1. Welcome and Apologies

The Chair welcomed everyone to the meeting and apologies were noted.

2. Minute of the Previous Meeting and Action Note

The minutes of the previous meeting were approved and the action note was discussed. Morna Rae, North Ayrshire Council, provided an update on the following areas:-

NHS Transformation - Partners have provided feedback to NHS colleagues on how to communicate NHS transformation to the public. The process is ongoing and continued partner support is welcomed.

Community Justice - Vicki Yuill is progressing arrangements with third sector on an ACEs input and will provide an update at a future meeting.

Local Outcomes Improvement Plan - The performance report has been circulated to members and feedback has been provided.

Community Learning and Development Strategic Plan - Partners have provided Audrey Sutton with feedback on the plan.

3. Fair for All Overview

Morna gave a presentation on Fair for All which provided context for the workshops which were scheduled to take place following the meeting. Information was provided on the strategy, pledges and approach to implementation.

4. Welfare Reform Working Group

Greig Robson, North Ayrshire Council, provided a report on the work which has been undertaken by the Welfare Reform Working Group and the key developments which have taken place including the Universal Credit full service roll-out and the emerging devolved Scottish Social Security Agency and system.

The perspectives of a variety of members of the working group were discussed and noted including:-

- the continued partnership working in North Ayrshire has helped with the introduction of the UK full service DWP;
- a notable increase in the average rent arrears for those receiving full service Universal Credit NAC Housing;

- concerns around claimants being provided with innaccurate advice by others leading to budgeting issues HSCP Money Matters; and
- delays in processing claims due to Universal Credit income information not being readily available from the DWP NAC Revenue and Benefits.

The Chair thanked Greig for his report.

5. Minutes for Information

The Chair highlighted that the minutes of the last round of Locality Partnership meetings and the Fair for All Advisory Panel meeting on 22 August 2018 were included in the agenda pack for information.

The Chairs of the Locality Partnerships highlighted the following points:-

North Coast

- The success of the recent participatory budgeting event and the range of groups who were involved.
- A bid received for Community Investment Fund (CIF) funding from Cycling Without Age.

Irvine

- A bid received for CIF funding for Digital Irvine Officer.
- A forthcoming event which will be used to plan a strategic approach to allocating funding from the CIF.

Kilwinning

• Work which has been undertaken to look at the existing priorities for the Partnership and to consider what new priority work may be appropriate.

Garnock Valley

- CIF funding which has been used to support the Garnock Valley Men's shed.
- Work undertaken by the three subgroups in relation to the Partnership's priorities.

Arran

- The Arran Ideas approach has been used to receive input from wider community groups.
- Preparations are underway for a participatory budgeting event.

The Chair and CP partners commended the progress being made by the Locality Partnerships.

6. AOCB and Next Meeting

Morna spoke about a recent workshop which considered the CPP response to the Local Governance Review consultation. The draft response will be considered by Strategic Management Team and then submitted to the CPP for approval. The Board agreed this approach.

The Chair closed the formal part of the CPP Board meeting.

The next meeting will be held on 28 March 2019 at 11am at Fullarton Connexions.

7. Workshops

Attendees spit into groups and participated in three workshops which focused on the Fair for All approach to food, Child Poverty, and North Ayrshire's Strategic Housing Investment Plan (SHIP).

John McKnight and Bruce McMaster led discussions on the Fair for All work in relation to to food which focused on local initiatives, links with national developments and the partnership working approach.

Andrew Noble, Regina McDevitt, and Lauren Cameron gave an input on the Child Poverty Action Plan and partners discussed how they feed into the approach.

Yvonne Baulk and Greg Hamill spoke about the North Ayrshire approach to providing high quality sustainable housing.

Purpose: To provide an update to the Board on key developments in Locality Planning

1. Introduction

The purpose of this report is to provide an update to the Board on key developments in relation to Locality Planning.

2. Developments

Agreed Awards from Community Investment Fund

The Locality Partnerships have been working with communities on ways to deliver on local priorities, including using the Community Investment Fund (CIF) to support local initiatives. The most recent CIF applications to be approved by Cabinet are a Travel Needs Analysis from the Garnock Valley Locality Partnership and Clearer Minds from the North Coast Locality Partnership.

The "Moving Around Workgroup" was convened by the Locality Partnership to discuss and develop ideas to improve the lives of residents of the Garnock Valley through increased mobility an accessibility to facilities, amenities and employment opportunities. The principal aim of the Travel Needs Analysis is to investigate what can be done to improve access to employment, education, social and leisure activities and health services. £25 000 will procure an organisation to undertake the analysis and guide future actions be partners.

Clearer Minds was developed by Largs Academy Mental Health Ambassadors, made up of 5th and 6th year pupils, supported by the school guidance team. The proposal will deliver a unique, practical programme to improve pupil mental health. The group will work with HeadStrong to support pupils to improve resilience, build coping strategies, speak out, and value each other. The overall aim is to promote positive mental health in a series of assemblies, workshops, 1-1 support and staff and parent training over a period of 18 months. The funding request was £30 200.

Sharing With Other Areas

The Improvement Service hosted a webinar on the 22nd of February 2019 focused on how to align Community Planning and Spatial Planning. In the webinar, Neale McIlvanney, Strategic Planning Manager, & Morna Rae, Community Team Leader, from North Ayrshire Council introduced the process NAC have applied to ensure that Local Development Plan (LDP) policies are aligned with their Community Planning Local Outcome Improvement Plan (LOIP) priorities. There was good participation from across Scotland and a wide range of follow-up questions. There was also positive feedback on social media.

Arran Pilot

NAC Cabinet agreed on 12th February that an integrated CPP Locality Partnership and HSCP Locality Planning Forum be established on Arran. This will be piloted from 1st April 2019 for 12 months and will be the first such arrangement in Scotland. The arrangement has been devised taking into account the legislative requirements upon the CPP and HSCP, practicalities concerning meeting arrangements and issues specific to Arran. It will mean HSCP Locality Planning Forum members joining the Arran LP with the Lead GP becoming a joint Vice Chair.

The impact of this change will be monitored and any learning will be shared with other Locality Partnership areas.

Storymaps

Damien Griffith has produced story maps for the Locality Partnerships. These have been demonstrated to CP groups and the Locality Officers have been briefed on their use. The Locality Partnerships will have an opportunity to discuss these at their June meetings and consider how they might best use them.

Locality Partnership survey

An online survey of Locality Partnership members took place in January. The survey was sent to 114 respondents out of which there have been 35 responses, representing a response rate of 31%. The survey results were encouraging. 94% of respondents felt they understand the role of Locality Partnerships in North Ayrshire. 62.9% of respondents felt that the LPs are helping to address local issues and inequalities. Only 1 respondent felt that inequalities are definitely not an issue in their locality.

Key Areas of Locality Planning Work for 2019

The Locality Partnership Working Group considered a presentation by Morna Rae at their meeting in February 2019 and agreed the following key areas for 2019:

- Delivering on priorities whilst focusing on inequalities
- Supporting and developing officer on LPs
- Use of the CIF
- Strengthening link to SMT and Board
- Implementation of Arran pilot and learning from it
- Evolving local priorities Kilwinning charrette

- Making locality links at a strategic level Council Plan, Child Poverty Action Plan
- Co-opting members
- Digital participation
- New approach to the conference
- Improving agendas and meeting papers Community Representative Updates, decision trackers

North Ayrshire Community Planning Partnership

Introduction

A strong and effective Community Planning Partnership is essential if we are to achieve the outcomes set out in the Local Outcomes Improvement Plan (LOIP).

As a Community Planning Partnership we are very ambitious for our communities and how we, collectively, can make a difference. We know that we have good working relationships across partners but this plan is designed to help us develop further and make best use of our collective assets.

CPP Learning and Development Plan 2019

Community Planning Presentation for Partner Organisations

While many CPP partners do include Community Planning in their induction for new staff the approach to this is not consistent. Updated presentation materials will be produced and circulated around CP partners. These will have scope for adaptation to incorporate how that specific CPP partner fits within the CPP and how their work relates to the Local Outcomes Improvement Plan (LOIP). Partners will be asked to include the CP induction materials as part of their own corporate induction.

Shadowing Programme

A Shadowing Programme has been devised to support partnership staff at all levels to undertake shadowing in another organisation. Shadowing opportunities across the CPP will continue to be identified and opened up to other CP partners. Feedback on the shadow programme will be collated.

Community Planning Training course

The Community Planning training courses are delivered by the CPP Team and have received positive feedback from the wide range of partnership staff who have participated. These face to face courses are evaluated and updated during the course of the year.

Development Days on Specific Topics

Periodic Development Days are held by the CPP for targeted groups of staff to address specific issues. These allow the development of better working relationships across CP partners as well as delivering improvements in the work of the CPP. These will be scheduled during 2019.

Community Consultation and Engagement Training

The CPP Community Engagement Centre of Excellence will be launched in 2019. The vision for this is that all CPP partners employ a cohesive and ambitious approach to consultation and engagement through use of an online hub, joint training menu and cohort of engagement champions. Briefings and training will be provided to CPP officers to support this.

Community Planning Induction Pack

An updated induction pack will be provided on the CPP website. A link to this will be provided to any new group members along with the terms of reference. This will assist representatives to understand the context of the work they are involved in. They will also be offered a meeting with a member of the CPP Team to deal with any queries they may have. This induction material will complement the induction presentation issued for incorporation by CPP partners.

Sharing Across CPP Partners

The CPP Team will continue to identify useful information about national or local developments, and the work of partners and share this across the CPP. This will be targeted and communicated accordingly, put on meeting agendas, promoted on the CPP website or emailed directly to relevant partners. This awareness raising supports a consistent approach across the CPP, increased understanding of roles of partner organisations and opportunities for joint working. We will also continue to share partner learning and development opportunities that are opened up more widely, conferences and briefing events.

CPP Terms of Reference

A Community Planning Terms of Reference document outlines the governance structures for the partnership and the roles and responsibilities of members of the CPP. This will continue to be updated as appropriate. There will be awareness raising of the Terms of Reference undertaken across CPP structures.

Monitoring and Future Plans

Morna Rae, Community Planning Team Leader, North Ayrshire Council will act as lead officer and will provide six monthly updates to the Strategic Management Team and CPP Board.

Over the lifetime of this plan additional activity can be incorporated as appropriate.

Subject: Community Justice Ayrshire Update

Purpose: To provide an update on the work of Community Justice Ayrshire

1. Introduction

1.1 The Community Planning Board has been kept up to date with progress in implementing the transition to the new local model of community justice in Ayrshire during the shadow year and first year of operation, which has included updates on progress towards the commitments in the Community Justice Outcomes Improvement Plan, 'Beginnings, Belonging, Belief'.

2. Current Position

- 2.1 We are currently finalising the end of year update for the Community Justice Outcomes Improvement Plan (2018-21). An update on progress and achievements made during 2018-19 will be made available to the CPP Board at its meeting on 23rd May 2019.
- 2.2 To date the commitments made within the CJOIP have been progressed via four thematic groups: 'Throughcare and Community Integration', 'Whole Systems Approach for Women', 'Health and Justice', and Children and Families Affected by Justice'. Local priorities in North Ayrshire are being progressed via the Safer North Ayrshire Partnership.
- 2.3 We are currently undertaking a review of the thematic groups to ensure that the terms of reference and partner representation are correct.

3 Transitions Funding

- 3.1 Grant funding of £50,000 per annum is allocated to each local authority for the coordination of community justice activities. This resource is pooled across the three Ayrshire authorities to increase capacity and enhance partnership working. The bulk of this funding pays for the Community Justice Ayrshire support team.
- 3.2 During 2018-19, some transitions carried forward from the previous financial year was utilised to pay for the final year of delivery of the **Turning Point Scotland Prisoner Support Pathways** service which operates within HMP Kilmarnock. This service coordinates throughcare support for short term prisoners who are being liberated to Ayrshire addresses, linking in with existing community services in order to increase the likelihood of a person successfully re-settling into the community and desisting from offending behaviour.
- 3.3 Turning Point Scotland will cease to deliver this service on 31 March 2018, and no alternative funding source has been identified. We have worked with Serco and other partners to develop a new model for the delivery of throughcare from HMP Kilmarnock. This centres around a weekly 'Community Links' drop in

session within the prison. The new model has been running concurrently with the existing model since the January 2019 to ensure that there is minimal disruption and disadvantage to those being liberated.

- 3.4 We have also written to the Cabinet Secretary for Justice to highlight the inequity in access to Throughcare Support Officers within HMP Kilmarnock, and the disadvantage this causes to those being liberated from HMP Kilmarnock. We have received a response from the Cabinet Secretary which does not provide a satisfactory reason for the inequity in access to this service. Our next step will be considered by the Community Justice Ayrshire Board on 20 March 2019
- 3.5 The **Service User Involvement Initiative**, headed up by researchers from the University of Strathclyde via funding from Community Justice Ayrshire has now reached the end of the project phase. Service user groups are now embedded within the three Ayrshire authorities, and in North Ayrshire this group is called the 'Making a Difference' (MAD) group. This group has recently been nominated for the Scottish Association of Social Work (SASW) award for Team of the Year with the ceremony on 19th March.
- 3.6 The project bring social workers, current and former service users and other community justice agencies together to influence the development and delivery of community justice services: a significant shift in service governance. Notably, service user involvement in all aspects of these services are formalised for the first time.
- 3.7 The final project deliverables have now been produced in draft form and will be considered by the Community Justice Ayrshire Board on 20 March 2019. There has been widespread interest in the project from outwith Scotland. In particular, Her Majesty's Prison and Probation Service have expressed interest in learning about the process through which this work has been undertaken to inform their emerging Standards of Excellence for Service User Engagement. As such, we are working with the University of Strathclyde on most effective way to launch the research findings and project materials.
- 3.8 Confirmation of funding (£50,000 per local authority) to support the ongoing work of community justice until the end of March 2020 has been received from Scottish Government. It is anticipated that this funding will continue to support the employment of the Community Justice Ayrshire staff team.

4. Adverse Childhood Experiences (ACEs) and Trauma

- 4.1 A follow up to the first Pan-Ayrshire conference on ACEs and trauma will take place on 25 March 2019. The event is entitled 'ACEs: Adversity is Not Destiny'.
- 4.2 The morning session will provide an opportunity to celebrate some of the work being done across Ayrshire, with the afternoon session focussing on what ACEs have to do with justice. We are delighted to welcome local, national and international speakers to the event. The agenda for the event and speaker biographies can be found below.





- 4.3 Over 65 multi-agency screenings of the 'Resilience' Documentary took place in 2018, led by colleagues from Public Health and Police Scotland (Ayrshire Division). It is estimated that over 4,500 people across Ayrshire have attended a screening and panel discussion.
- 4.4 Following a motion to Council for North Ayrshire Council to become 'trauma informed', the Director of the Health &Social Care Partnership convened a meeting to discuss a proportionate response to achieve this. Colleagues from Human Resources, Learning & Development, Community Planning, Community Justice and the H&SCP are now considering a plan to take this forward.

5. Validated and Supported Self-Evaluation of Community Justice

- 5.1 Community Justice Ayrshire are one of three pilot areas chosen to undertake a validated and supported self-evaluation in association with the Care Inspectorate.
- 5.2 A series of focus groups and one to one discussions were convened to allow the partnership to gather evidence to support our position statement in relation to the quality indicators chosen by the Care Inspectorate. Our position statement and supporting evidence was submitted to the Care Inspectorate on 22nd February 2019.
- 5.3 Validation activities are due to take place week commencing 11th March with the validation letter being published on the Care Inspectorate website on 11th April. More details on the approach taken and timescales can be found below:



6. Recommendation

6.1 The Community Planning Partnership are asked to note the content of the above report and to expect a further update on the work of Community Justice Ayrshire, which will include the results of the validated self-evaluation exercise on 23rd May 2019.
