COMMUNITY COUNCIL MEETING held MONDAY 13th May 2019, 7.00pm in VILLAGE HALL

MINUTES: 8th April Minutes approved by (KH) and seconded by (DP)

TREASURER'S REPORT: Treasurer (DP) reported that the accounts had not changed in the last month. The current balance is £ 272.94. The Community Council Insurance had been paid by NAC and is in force.

POLICE SCOTLAND: PC Thomas Arthur reported that from8th April 2019 to the 13th May 2019 there had been (96) incidents reported which resulted in (13) crime reports consisting of (3) Assaults; (7) Theft; (1) Drugs; (2) RTA. Of the offences recorded, (5) were detected.

The Community Council has concerns that of the seven thefts recorded five of them were of Wheely Bins which this Council will not replace free of charge unless they have a 'Crime Report number'. This gives a false reflection of the true state of crime in the community. The requirement of a crime Report is not consistent over all the Local Authorities in Scotland.

CORRESPONDENCE / REPORTS:

Peel Ports: Hunterston Parc Master Plan Consultation May-June 2019.this has been circulated and is noted. (KH) requested that the Community Council remind Peel Ports formally that any future developments at Hunterston will require Environmental Impact Assessments with regard to the remediation of the existing Coal and Iron ore stockpile yard site. Further information on this proposal was still awaited from Peel Ports prior to the start of the Consultation. WKCC had already complained to Peel Ports regarding their proposal to not have consultation exhibitions in West Kilbride, Largs and Skelmorlie.

NAC Exec: A New Regional Transport Strategy for Strathclyde – Notice of Forthcoming Briefing and Opportunity to Comment. No update as yet from NAC.

Local Place Plans: (JL). Was unable to attend the Conference but WKCC had submitted comments which were included we would be kept up to date with the final report of the meeting. At stage 2 of the Planning Bill currently going through parliament, regarding Place Plans support on the face of it that Communities may prepare Place Plans and with the views of the local elected councillors submit the plan to the Planning Authority, who must keep a register of local place plans.

NAC Executive: Pan Ayrshire Community Council Conference 11th May. (KH) and (JL) attended, the main topic was the Scottish Government / UK Government funding of the Ayrshire Growth Deal which amounts to £251.1million over 10 to 15 years, looking to attract up to 7,000 jobs. the funding has been allocated as follows: £80m for aerospace and space; £69.5m for Engineering and manufacture; £34mfor Tourism; £42.5m for energy 14m for digital infrastructure; £8.5m for Skills development; £3m for Community Wealth building. There were also presentations by SCDC on Community Power and the Local Place Plan.

WKCC will request that the users clean up the site or remove the framework. (DM) would respond to the complainer that this should be taken up with the users of the site.

UPDATES and ONGOING:

Scottish Government: Site to South of 128-130 Meadowfoot Road. No further information available at present. The Appeal is still with the reporter and no judgement has been issued.

NAC - Future of Public Buildings in West Kilbride: Public Consultation was held in the Primary School on Thursday the 11th April at 6.30pm till 8.30pm. (KH) and (DP) attended. There was a significant turnout of over 100 residents. The results will be appraised and developed over the summer and will lead to a further consultation in the autumn.

Trans Serv: A78 extension of 30mph limits to Chapelton and new 40mph limit to southern boundary of Waterside Hotel. This is ongoing. Cllr Brahim is also requesting a response from ScotTrans.

LDP2: With Scottish Government Reporter: Request received by WKCC regarding further information re Lawhill Site to be submitted by the 24th April. This was submitted by the due date.

Gladman Associates: An EIA application has been submitted to NAC Planning today 13th May, however, no details are available at present on NAC website.

Meadowfoot Tenants Association: No report.

WK Business Group: Siting of Off-road long-term parking in village centre and town centre refurbishment continuing. The current response from NAC was as previously stated, there would be no off-road parking in West Kilbride instigated by NAC in the foreseeable future. They are meeting with Cllr Brahim and Dr Audrey Sutton on Wednesday 15th to discuss Town Centre Improvement funding.

War Memorial Garden: (JL) reported that the work had now been done and is a great improvement.

COUNCILLORS' REPORTS: By e-mail Cllr Brahim reported the following:

Cllr Brahim is still trying to get more information on progress regarding reduction of speed limit on the A78 Seamill.

WKBG and I are meeting with Audrey Sutton on Wednesday in our ongoing quest to retain previously allocated funding to improve the town centre shopfronts (with Dalry and Stevenston getting £500k each, I will ask for WK to be allocated some of what I believe would be another £400k). Kay of course can elaborate if you she so wishes. I have conveyed concerns regarding the future of the library to Audrey Sutton. As you will be aware, the consultation period ends on Wednesday the 15th and options will be developed and appraised over summer. The way NAC are looking at it is what services are required and which buildings are best placed to deliver those services from, rather than from the perspective of what buildings they would like to keep.

On Wednesday the 15th, before my meeting with Kay et al and Full Council, I'll attend the briefing re Hunterston PARC.

(JL) informed the C.C. that the full Council was to have a presentation from the Office of Nuclear Regulation on the 3rd June regarding the Core Brick cracking in the reactors of Hunterston B.
