#### WHAT IS COMMUNITY PLANNING?

Community Planning is a process which helps public agencies to work together and with the community to plan and deliver better services which make a real difference to people's lives. Community Planning was introduced by the Local Government Scotland Act 2003. The Community Empowerment (Scotland) Act 2015 lists the public authorities who must take part in Community Planning and it places duties on them.

#### **CPP SENIOR OFFICERS GROUP**

The remit of the CPP Senior Officers Group is:

- > To support the achievement of 'North Ayrshire A Better Life'.
- > To receive instruction from the CPP Board.
- > To task the Strategic Partnerships and scrutinise their performance.
- > To scrutinise the implementation of the Local Outcomes Improvement Plan (LOIP).
- > To support the development and monitor the implementation of partnership strategies and action plans within the context of the LOIP.
- To solve problems and resolve issues raised by the Strategic Partnerships and Locality Partnerships.
- > To scrutinise the use of resources and implement joint resourcing approaches
- > To champion partnership working and lead by example.
- > To ensure effective community engagement is at the heart of community planning.
- > To support the implementation of the Locality Approach.
- > To promote measures to build community capacity.
- > To shift focus and resources to preventative and early intervention approaches.
- > To focus the work of the CPP on addressing inequalities.
- > To inform the work of the CPP Board.

The Chair of the CPP Senior Officers Group Team will rotate on an annual basis.

## **THEMATIC GROUPS**

The Thematic Groups outlines in the CPP Structure take responsibility for leading on the related LOIP priority.

### **MEMBERS PROTOCOL**

All CPP group members are expected to:

- Give priority to community planning meetings to ensure attendance;
- Submit apologies in advance if unable to attend;
- Have a nominated substitute who may attend on occasion. All substitutes should be appropriately briefed in advance of the meeting;
- Acknowledge that group membership will be reviewed once 3 consecutive meetings are missed by the group member or nominated substitute;
- Prepare for meetings by reading the appropriate documentation and carrying out any necessary consultation;
- Contribute honestly and openly at all meetings;
- Act as a conduit of information to and from partner organisations;
- Take responsibility for progressing actions after meetings;
- Identify opportunities to share resources, service planning and development, and service delivery;
- Act as ambassadors of community planning within partner organisations;
- Seek to identify and share good practice examples of community planning;
- Promote community engagement and equal opportunities within community planning.

#### **COMMUNITY ENGAGEMENT**

A key aim of Community Planning is to engage with individuals, local communities and organisations to identify their needs and priorities and to ensure these influence the planning and delivery of public services. Effective community engagement is therefore at the heart of community planning in North Ayrshire. This includes:

- Consultation (asking and listening)
- Co-operation (working together)
- Participation (taking part and getting involved)

#### **CENTRE OF EXCELLENCE FOR ENGAGEMENT**

The Engagement Hub is hosted on the CPP website. It includes the North Ayrshire engagement pledge as well as signposting to all CPP and partner guidance documents, as well as a resource library and performance framework which are under development. Partners are encouraged to use this hub to share their consultations. Additionally, the 'Engagement Champion' programme will consist of a bank of Consultation Institute qualified staff in each department that can act as engagement advocates, providing support and guidance on consultation and engagement to colleagues.

#### The Community Engagement Network (CEN)

The Community Engagement Network's remit is:

- To support the Engagement Centre of Excellence.
- To share information on community planning partners consultation and engagement.
- To act as a sounding board for the development of partnership strategies and action plans.
- To share information and best practice in relation to community engagement.
- To promote the <u>national standards for community engagement</u>.
- To ensure effective community engagement is at the heart of community planning.

The CEN meets three times per year, with each session focusing on a key strategic topic relating to the strategic aims of the CPP.

#### **People's Panel**

<u>The North Ayrshire People's Panel</u> was established in 2000 and is used as a tool to gather information on the attitudes and perceptions of local people on topics such as the local area, employment and community safety and to track changes in these views over time. Community Planning Partners also have the opportunity to include questions.

The Panel is randomly selected from the electoral roll and consists of 2,000 members, including from the 15% most deprived areas within North Ayrshire. This allows us to compare findings between more disadvantaged areas and the rest of the authority, and use this as an indication of how far we have travelled in terms of reducing the gap.

#### LOCALITY PLANNING

There are six Locality Partnerships in North Ayrshire which cover all of the local authority area. These are show in the map below:



The Community Planning (CP) Locality Partnerships (LPs) meet quarterly with interim working groups/workshops as required. Their remit focuses on a partnership approach to tackling local issues and inequalities. They are the means by which we fulfil duties under the Community Empowerment Act (Scotland) 2015 to have locality arrangements. The overall aim of locality planning is to harness the power of Community Planning Partners and communities to work together towards shared, data led, priorities. Their membership comprises:

- Elected Members
- Community representatives
- Community Council Chairs
- Community Planning partners.

Following consultation, use of the Place Standard and consideration of local statistical profiles the LPs have agreed local priorities. The Health and Social Care Partnership (HSCP) Locality Planning Forums have also decided on local issues to be addressed. The HSCP uses the same geographies as the CP LPs, and links between the two structures are in place.
