Background

- Existing Strategic Plan 'Lets Deliver Care, Together', will cease on 31st March 2021.
- Strategic Planning Group last met in January 2020 to discuss the refresh of the new plan, outlining an ambitious approach to its development. They met again on the 10th August to inform this approach.
- As a result of the Pandemic, there are now significant barriers to our ability to effectively develop a refreshed Strategic Commissioning Plan by March 2021.
- To address this concern, it is proposed to develop a '1 year bridging plan' with a 2030 vision

Guidance

- Guidance was sought from Civil Servants in the Scottish Government on our proposed approach
- Scottish Government colleagues agreed the approach is sensible. (we would join the timelines of the other IJBs across Scotland)
- A meeting was organised on 3rd August with integration authorities who were early adopters.
- Most agreed with the NA approach, and suggested they would follow a similar path.
- Legal advice has also been sought from NAC Chief Legal Officer.
