- the fact that around 80% of buildings were now open for a priority purpose, such as after school care;
- ongoing meetings with voluntary and third sector organisations to assist them in accessing available funding;
- the provision of Scottish Government funding to support vulnerable people in terms of areas such as food and fuel poverty, mental health and wellbeing, support for warm winter clothing and free school meals:
- support for festive food, Christmas lights and other (mainly virtual) festive events;
- work to support digital participation, including the provision of further devices and connectivity for use within the community;
- appointments to support Community Wealth Building work;
- Asset Transfer activity;
- recovery and renewal work to consider new ways of working in future, the use of buildings and opportunities to look at transport and travel;
- work on Cumbrae in terms of social and economic renewal as well as the longer-term future of the Cumbrae water sports centre;
- the recruitment of an Islands Officer; and
- a recent Joint Cabinet meeting, which had heard from young people on their experience during Covid

#### The Group discussed:

- the amount of work being undertaken across all six Localities; and
- the need for effective arrangements to be in place to support the timeous roll-out of the Covid vaccine

#### 5. Child Poverty/Cost of the School Day

The Partnership received a verbal update by the Lead Officer on the work of a Short-Life Working Group on Reducing the Cost of the School Day which had been established by the Council's Cabinet to identify and roll out best practice in this area.

The Group discussed the important role of breakfast clubs and free lunches and the need to avoid stigma for young people in receipt of support.

#### 6. CIF Update – Sing Your Song Group

Submitted a year 1 grant monitoring report in respect of the West Kilbride Community Initiative which was in receipt of funding support for the 'Sing Your Song Group'.

The Locality Co-ordinator reported on the work which had been undertaken by the group to date and a request to carry forward approximately £1,500 of year 1 funding to mid-January.

On a roll call vote, the Partnership unanimously agreed (a) to allow the group to carry forward remaining year 1 funding as requested; and (b) to approve the release of the second tranche of funding to the group.

#### 7. Millport Town Hall

The Partnership received a verbal update by Community Representative Lesley Stringer on progress in terms of the Millport Town Hall project, including:

- the submission of a £1.5m Scottish Government Regeneration Fund bid for the project;
- expressions of interest submitted in respect of other funding sources, including Crown Estates;
- the intention to proceed with the asset transfer following the outcome of the Scottish Government funding bid;
- a request for the release of CIF funding meantime to allow the procurement of works to proceed;
- support and advice provided by the Council, including from its Legal Service: and
- ongoing work in terms of building warrants, surveys and energy conservation arrangements for the building

On behalf of the Group, Lesley Stringer extended her thanks to the Council, local Elected Members and the Partnership for their continued support.

The Group discussed:

- whether Scottish Land Fund support had been secured;
- the number of significant projects which would undertaken on Cumbrae over the next few years, including conservation area work and flood protection, and the need to ensure effective co-ordination in terms of construction traffic on and off the island.

The Senior Lead Officer suggested that the Group make contact with Arthur Cowley, the Council's Senior Manager (Roads) on the coordination of works on the island.

#### 8. Locality Officer Update

Submitted update report by the Locality Co-ordinator on activities undertaken in the period September – December 2020.

The Locality Co-ordinator highlighted elements of the report, including:

- ongoing operation of Community Hubs, supported by voluntary groups;
- the willingness of some community groups to provide ongoing support in terms of 'food with dignity' projects, including a community larder/pantry initiative in West Kilbride and the provision of precooked meals on Cumbrae and in Largs (also covering Fairlie and Skelmorlie);
- the recruitment of a Community Worker, including plans for interviews to take place in December or early in the new year;
- arrangements in terms of the distribution of the mental health pocket guide for children and young people;
- the availability of wellbeing and literacy support and arrangements to publicise this;
- recent youth and street work undertaken in Largs with support from the Campus Police officer;

The Group discussed:

- the possible duplication of community meal provision on Cumbrae and the need for co-ordination on this;
- the use of the DA Hall for food preparation;
- the feasibility of youth/street work around Anderson Park in Largs being extended to include Douglas Park; and
- whether the Community Development Worker post would be an internal or external appointment

Community Representative Lesley Stringer undertook to follow up on the issue of community meal provision on Cumbrae.

#### 9. HSCP Update

The Partnership received a verbal update from Louise McDaid, the Locality Forum representative on the work of the Health and Social Care (HSCP) Locality Forum, including information on:

 a meeting of the Forum held in October 2020, which had discussed the increase in mental health issues in light of the pandemic and the positive role of Community Hubs;

the feasibility of continuing community hub work in the longer term, something which would be discussed by the Integration Joint Board; the ongoing review of Locality Forum arrangements and the potential for combining the work of the Forum and Partnership in line with the model now in place on Arran; production of a new Joint Strategic Commissioning Plan by the Integration Joint Board by March 2021, to be informed by a robust needs assessment; and the issue of gambling, its impact of individuals and communities particularly during the pandemic, and work to engage with Gambling Anonymous The Partnership discussed: the benefits of combining Locality Forum and Locality Partnership work and whether this should be the subject of consideration at the Localities Conference: • the impact of Covid on mental health and whether sufficient resources were available to support what was likely to be rising demand for services in this area: and the demographics of those affected by gambling issues The Group agreed (a) to recommend that combining the work of Locality Rhona Arthur Forums and Partnerships be the subject of discussion at the Localities Conference; and (b) otherwise, to note the content of the update. 10. **Grants/PB Update** The Partnership received a verbal update by the Lead Officer on: Scottish Government funding used to support local groups and the availability of funding for initiatives such as festive food; and the promotion, via social media, of participatory budgeting and the intention to use online voting to agree the distribution of funding; Noted. 11. **Any Other Competent Business** 11.1 **Largs Common Good Fund** Submitted a funding application from Barrfields User Group (trading as Barrfields Theatre Group). ## **Foreword**

I took up my role as Local Police Commander for Ayrshire Division in March 2020 and I would like to acknowledge the impact the pandemic has had on the communities across North Ayrshire, and on individual's personal and work lives. This has also been a challenging time for police officers and other key workers, particularly those in the NHS; their contribution and continued commitment along with the unsung heroes in our communities has been inspiring. It is more relevant now than ever to highlight that Police Scotland's purpose is to improve the safety and wellbeing of people, places and communities; we continue to work closely with partners to ensure that we collectively address the needs of the most vulnerable in our community.

Police Scotland is led by Chief Constable Iain Livingstone QPM, supported by his Executive Team. They have a close and constructive working relationship with the Scottish Police Authority who have a key role in providing scrutiny in support of maintaining and improving our service delivery. From a local policing perspective there are 13 Divisions across Scotland and I am very proud to lead and support colleagues across Ayrshire.

With that responsibility, I am pleased to present this revised Local Police Plan 2021/23 for North Ayrshire. The Plan is now aligned to Police Scotland's corporate planning cycle and continues to be reflective of Community Planning Partners priorities. Through our Divisional Strategic Assessment process we have identified the areas of focus that are at the heart of this Local Police Plan. As we adapt to a new normality, Ayrshire Division will remain vigilant and agile so that we can respond and address issues that have the most impact on our communities.

Notably, from March 2020 until March 2021 there has been an overall downward trend in recorded crime; largely due to the impact of COVID and the subsequent restrictions placed upon society. This has included a reduction in reported Domestic Abuse and Sexual Crime. I want to be absolutely clear that Police Scotland and our partners have been, and will continue to be, available to respond to any survivor's report of abuse (recent or non-recent).

The Community Planning Partnership (CPP) in North Ayrshire has strong foundations and this Plan supports the Partnership's 'Fair for All Strategy' to reduce inequalities in North Ayrshire. For the first time Community Wellbeing has been identified as a priority in our Plan. This takes cognisance of the varied and meaningful partnership activity we undertake to address often complex issues that impact on individuals in times of crisis or require a coordinated approach to ensure they get the support that they need.

Through the CPP structure we aim to further develop joint local approaches to prevent crime and disorder; and to collectively provide support to those most vulnerable and at greatest risk of harm in our communities.

In the next two years there is going to be significant positive changes that will improve the outcomes for young people. The completion of the Independent Care Review and the publication of 'The Promise' puts an onus on Police Scotland as a Corporate Parent to play an active role in ensuring that care experienced young people realise their full potential in North Ayrshire; and we will work with partners to achieve this. The UN Convention on the Rights of the Child will be incorporated into Scots Law and will require all public authorities to consider our policies and practices to ensure they protect children's rights. In addition, the Age of Criminal Responsibility (Scotland) Act 2019 will come into effect and require the police and criminal justice partners to support young people in a different and more positive way.

The implementation of 'The Promise' and new legislation will make a significant contribution to embedding trauma informed practice into everyday ways of working. In North Ayrshire, we will be working with the Local Authority, Health and Social Care Partnership, the NHS and other key partners to identify training opportunities and best practice so that we can collaboratively respond to the needs of individuals in ways that prevent further harm and supports recovery. I also recognise the impact of trauma in the workplace; my focus will also be on supporting the health and wellbeing of police officers and police staff in North Ayrshire.

As the pandemic has shown; collaborative working is key to delivering the best outcomes for our communities. On behalf of my colleagues in Ayrshire Division, I look forward to building on the already strong working relationships in North Ayrshire, and I remain committed to providing a visible and responsive local police service that contributes to improving the wellbeing of our communities.

## Introduction

North Ayrshire has a population of approximately 136,000. It is located in the South-West region of Scotland covering 341 square miles and is bordered by the local authority areas of East Ayrshire, South Ayrshire, Inverclyde and Renfrewshire.

Irvine is the largest town with an approximated population of 40,000.

The area also contains the towns of Ardrossan, Beith, Dalry, Kilbirnie, Kilwinning, Largs, Saltcoats, Skelmorlie, Stevenston, West Kilbride, as well as the Isles of Arran and Cumbrae.

This presents a diverse mixture of urban, rural and island areas that provide officers in the Command Area with a unique set of policing challenges.

Building on existing partnerships, we aim to deliver a professional and effective service that engenders trust and confidence in Police Scotland and contributes to an improved quality of life for the people of North Ayrshire.

## **Legal Basis and Corporate Framework**

The Community Empowerment (Scotland) Act 2015 places a statutory purpose for all partners to be focussed on outcomes. It is explicit about how public bodies work together with the local community to plan and provide services that improve local outcomes with a view to reducing inequalities.

The Police, Fire and Reform (Scotland) Act 2012 requires the Local Police Commander to submit a Local Police Plan to the Local Authority for its approval.

Whilst this Plan is a local one and is focused on North Ayrshire, the activity we undertake will also contribute to the <u>Scottish</u> <u>Government's National Performance Framework</u>, in particular the following National Outcomes that seek to ensure people:

- live in communities that are inclusive, empowered, resilient and safe
- respect, protect and fulfil human rights and live free from discrimination
- grow up loved, safe and respected so that they realise their full potential

The Plan also aligns with Police Scotland's / SPA's Strategic Policing Plan and Annual Police Plan; these key documents provide us with the following five Outcomes that are within the Performance Framework for Policing and are adopted locally:

- Public Safety and Wellbeing
- Needs of Local Communities
- Confidence in Policing

- Positive Working Environment
- Sustainable and Adaptable Service

Police Scotland's Annual Police Plan provides detail on wider Policing priorities that are addressed with national and regional resources and supported by local resources when required. Serious Organised Crime (SOC) is one of the national Police Scotland priorities; however Serious Crime is an identified local priority and we will take appropriate steps locally to address these issues that impact on our communities, e.g. focusing on drugs supply.

Protecting communities by reducing and mitigating the risk and impact of Terrorism remains a priority for Police Scotland. Experience has shown that Scotland is not immune from such acts and Police Scotland must be ready to counter terrorism in all its forms. This national priority will also be addressed locally; albeit it is not specifically referred to as a local priority.

## **Local Policing Delivery**

The Community Planning Partnership (CPP) has embraced the locality partnership model to coordinate and deliver a wide range of services. This has been supported by all partners and as this had matured, relationships have grown stronger and collaborative working with partners and communities has thrived. The six localities in North Ayrshire are:

- Irvine
- Kilwinning
- Three Towns (Stevenston, Saltcoats and Ardrossan)

- Arran
- North Coast, Cumbraes and West Kilbride
- Garnock Valley

In North Ayrshire we have dedicated policing resources for each of the locality areas; these officers build links with the communities and partners to deliver a service that addresses local concerns. The Campus Officers are also integral to delivery of policing services in the area of their designated schools.

In addition, North Ayrshire has response policing hubs in Irvine, Saltcoats, Kilbirnie and Largs. These resources are responsible for responding to 999 and high priority calls. This structure allows us to assess the threats, risks and harm of each call and ensure the appropriate response is provided to meet the needs of the public. There is also dedicated Criminal Investigation Department resources.


There are also a range of specialist resources in Ayrshire that are deployed to support local resources as and when required, these include Road Policing, Domestic Abuse Investigation Unit and Rape Investigation unit. The Division also has a Violence Reduction Unit and Pro-active Crime Team that are regularly deployed in North Ayrshire to respond to intelligence led investigations and enquiries.

The benefit of being a national organisation also provides North Ayrshire with access to specialist resources that will deploy to the area to support local resources. These are varied and the following list is not meant to be exhaustive: Marine Unit, Air Support, Negotiators, Mounted and Dog Branch.

## **Local Objectives and Activity**

#### **Priority - Serious Crime**

Objective 1: Provide a victim-centred approach is taken to investigating serious violence.

- Understand the impact of violence on communities and effectively manage the policing response through best use of management information and analysis
- Maximise intelligence gathering to target those involved in violent crime and use of weapons
- Monitor violence used against police officers, police staff and other emergency workers through Divisional Your Safety Matters Sub-Group

Objective 2: Conduct intelligence-led and focussed activity on individuals and groups involved in the supply of illegal drugs.

- Maximise intelligence gathering opportunities to target those involved in the supply of drugs
- Divisional Pro-active Crime Team will coordinate enforcement activity with support of North Ayrshire resources

**Objective 3:** Work with partners to protect people considered vulnerable and prevent all forms of abuse, neglect and exploitation including rape and child sexual abuse / exploitation.

- Ensure survivors of child sexual abuse / exploitation are supported to have the confidence to report incidents and crimes
- All reports of child sexual abuse and rape (recent / non-recent) are investigated thoroughly and professionally
- Provide an effective, supportive and victim-centred approach to rape with provision of services in Ayrshire, in collaboration with partners
- Support national / local campaigns to raise awareness of child sexual abuse / exploitation and rape

In addition, Locality Policing supervisors and officers will attend Locality Partnership and other public meetings to provide updates on police performance and engage to better understand local issues and concerns.



### Reporting Period – Jan-Mar 21

Community Worker/Project Officer for the LP priorities post has been re-advertised.

We are continuing to support the Millport Town Hall group through securing the Regeneration Capital Grants Fund £1.5m and through early access to previously approved Community Investment Fund monies of £70,000.

West Kilbride Community Association have now fitted solar panels to the roof of the community centre to make it more sustainable/climate friendly.

Douglas Park Group are now a registered SCIO. They have decided to halt the stage 2 paperwork for CAT aiming to pick it back up later in the year. The group are still looking at various funding opportunities. The group plan to continue to facilitate various community engagement opportunities. They are also continuing to do work around the park (clearing leaves, planting etc) and have involved local groups.

The North Coast & Cumbrae Community Hub is still in operation, with support from the voluntary groups delivering a service to the community. Things haven't been as busy but the hub and all groups are still available in the event of any future lockdowns, and, where needed, to support people who are having to self-isolate due to symptoms or contact from Trace and protect.

Team aiming to engage in more streetwork opportunities within Largs, hoping to build on the successful programme that was completed before Christmas.

NC Youth Forum expanding membership, 8 young people attend the group and are in the process of delegating office bearers. The group have applied for funding to facilitate a fun day in line with North Coast priorities.

Supporting Cumbrae Community Development Company, as they prepare to prioritise the 6 public toilet blocks and develop their CAT plan.

Supported public engagement re Cumbrae Watersports Centre. Awaiting feedback from community members on their thoughts and next steps.



General



Reporting Period – Jan-Mar 21

#### Update

Work continues on establishing local need with the Community Planning Partnership's statistical team. This has included an indepth study of data and consideration of a place-based approach with an external partner. The Chair of the sub-group continues discussions with partners.

Money matters have worked closely with the community hub during lockdown. This is something that we can explore to see if it's feasible to continue.

Supporting Organic growers of Fairlie in the early stages of a Community Garden project in Douglas Park (Tennis Courts), this will include raised beds for group members, intergenerational work and community growing.

Staff continuing to deliver online sessions and have delivered a workshop on wellbeing, as well as partnering with RBS to host a scam awareness session.

Participatory Budget applications have been received and short-listing took place at the end of February. Number of applicants: Arts and Culture – 9; Youth – 17; Locality – 18.

Food with Dignity Projects:

West Kilbride – Pantry/Larder will be hosted within West Kilbride Community Centre. Resources have been procured for the pantry (freezer, shelves, insulated bags etc). The group will be part of the North Ayrshire fairer food initiative and are working in the background sorting out donations, membership of local co-op progs, funding etc. The group have been in contact other North Ayrshire pantries which has helped their process.

Cumbrae – Millport Support group working with Newton Bar to prepare hot lunches and these are being delivered to over 100 people across the Island.

Largs/surrounding areas – The North Coast Community Cookhouse (NCCC) is up and running. This is a partnership between Largs Resilience team and Largs Church of Nazarene. The church cooks hot meals every Friday, and the resilience volunteers delivers them. The group managed to deliver Christmas meals to vulnerable people in the area.

#### **Update**

Due to COVID a lot of the work has been put on hold.

Good partnerships built up over the time that the community hub has been running will help inform how we can take this priority forward when its possible to do so. This will include working with service access team, Locality Link Workers etc.



Social isolation older people

Staff have obtained funding from Connecting Scotland to provide laptops and tablets along with Mifi for households and families including pregnant women, to support learning and tackle social isolation.

The community choir in West Kilbride, funded through CIF 'Sing Your Song', has been running online (to an extent) during lockdown. They have now completed year 1 of the project, have submitted monitoring report and are looking to get their year 2 funding released.

Virtual Community Centres continue to provide updates and relevant information that would be of use to the North Coast Community, including learning opportunities, capacity building and befriending, as well as online digital support.

2 of the team targeted people who were digitally excluded by producing bookmarks that went into all books through the library click and collect system, offering support for wellbeing, literacies etc. This has also progressed to a lamppost campaign.

Stress and anxiety – younger people Before COVID Louise had made contact with Parent Council to see if we can look at future funding. Haven't received a reply yet. This will be chased up once things return to some sort of normality.

Skelmorlie & West Kilbride Youth groups will continue to have a session on mental health in each of their terms. Group is still running digitally. Numbers attending aren't very high but it's an important group for those who are attending.

North Coast youth groups have applied for PB funding to attend team building and confidence building workshops

Staff have been liasing with Oyster group aiming to facilitate accredited learning opportunities to young people within the North Coast.

#### **Finance & Corporate Support:**

No Financial Statements are available to review as this organisation was only set-up in March 2020. The bank statement provided does not show any income from previous sales of these packs and the only expenditure shown is for wages.

#### Legal:

In accordance with Section 15(4) of the Local Government etc. (Scotland) Act 1994, the Council in administering the Common Good Fund shall have regard to the interests of the inhabitants of the area to which the Common Good relates.

This Grant Application cannot be justified in terms of Section 15 (4), as it is limited to recipients of a particular age ("reception and year 1 at Primary School") and to the two primary schools located within Largs.

#### **Economy & Communities:**

The CPR Group is based in Tain but is a nationwide organisation. They are seeking funding to support the purchase of "Little Lifesaver Packs" for distribution to primary schools. The packs aim to help parents save their child and other adults in a choking and cardiac emergency.

The criteria of the Common Good Fund states that applications must benefit all or a significant group of the inhabitants of the area to which the Common Good relates. This application is aimed at school entry children only and it may be viewed as not supporting all or a significant number of inhabitants.

- TACT Staff have been organising and facilitating monthly 'networking' Forums for all 3<sup>rd</sup> Sector groups and organisations that wish to attend. - Eglinton Community Garden Collaboration we are continuing to work with a range of

  and Drug Partnership to deliver a successful Community Garden for local people to
  get involved and learn to grow their own produce. The Collective have recently been
  successful in securing their first funding, to continue their work, from the Green Health

- Organisational Support continuing to work with groups and organisations delivering relevant Training including Governance, Basic Bookkeeping and Volunteer Management. We are also assisting with Charity Registrations, PVG Support, Funding Support and Support with compiling Constitutions.
- Community Wealth Building, North Ayrshire is the first Community Wealth Building Council in Scotland – this is fantastic news and something very positive for North Ayrshire. As the Third Sector Interface, TACT sits at the Community Wealth Commission. This commission supports the implementation of the CWB Strategy and will encourage involvement from local businesses, government agencies and local organisations on CWB initiatives.

- SLACK The Ayrshire Community Trust and Arran CVS as the Third Sector Interface are currently trialling an engagement platform known as SLACK. This will have a wide range of information and resources for 3<sup>rd</sup> Sector Organisations to access. - We are continuing to contact and engage with 3<sup>rd</sup> Sector groups and organisations to complete our COVID Health Check Questionnaire. This Health Check enables us to ascertain support that is required including Funding, Governance Support, OSCR Guidance, Volunteering Support, Health and Well-being information and any other areas.
- Staff continuing to update and source a range of Volunteering Opportunities that are currently available. We are still receiving a high number of Volunteer Registrations and don't have enough placements for those interested. - TACT are working closely with the British Red Cross, through the national vaccination centres, to provide suitable volunteers who are able to help.
- TACT and Arran CVS staff will offer at least 100 individuals from different groups and organisations the opportunity to attend Mental Health Improvement Training to support the ongoing needs of service users and staff throughout this pandemic and importantly there on after.
- TACT and Arran CVS as the local Interface were asked to consult with local 3<sup>rd</sup> Sector Organisations by the Scottish Government on proposed changes to Charity Law. The consultation event was held on 21<sup>st</sup> January 2021. Results from the consultation have been returned to the Scottish Government. The consultation was closed on 19<sup>th</sup> February 2021.
- TACT Capacity Building Officers have been in touch with Nicola Gooch, NAC Community Benefits Officer to introduce ourselves and explain our role within Community Benefits and to discuss how we can work together. The Capacity Building Officers have also been in contact with local contractors and put them in touch with local third sector organisations.
- Staff are working with our Locality Partners in the Participatory Budgeting process.
