- Families moving to the island has slowed down but still happening.
- Children enjoying being back, continue to have outdoor full school assemblies whilst the weather is good;
- Working closely with the music school;
- Enhanced cleaning and different entrances for pupils.

- Looking ahead, halls have been provisionally booked for shows and also bookings for residentials have been made;

T Tracey highlighted that he was fortunate to meet with the Cabinet Secretary for Islands today. The focus of discussions was on sustainability was made and that we had a critical housing issue needing support resolving as well as the impact of the ferry. Tomorrow the Ferry Committee, Arran Recovery Group and the Council are meeting with Minister for Transport to reinforce the ferry side of things.

8 Update from Argyle College

J Worthington provided the Locality Partnership with an overview of the work of the AC.

J Worthington highlighted that Argyle College is part of the University of the Highlands and Islands and the Arran Centre is based in Lamlash. The College offers further and higher education on the island.

September is the College's busiest month with inductions, the College has 25 full time students with 11 studying at degree level. In addition to this, 22 school pupils are also studying, this is a higher level of engagement than before.

The College is also providing part time courses, which currently accounts for 10 students as well as NQ qualifications, leisure classes and business training.

Intake numbers are very positive this year as it has been the biggest intake in 21 years.

As part of the pandemic the College made the immediate transition to online learning, as of September 21 the College will operate on a hybrid model which will be staffed and by appointment only. This has allowed inductions and face to face support to take place.

The College will collaboratively with Skills Development Scotland, North Ayrshire Council, Argyll and Bute Council and Highlands and Islands Enterprise to identify the key areas of growth and future job creation both regionally and nationally.

Discussions have also took place with DYW Ayrshire around collab projects with the College, Arran High and DYW Ayrshire. This would be in regard to operating a number of skills academies.

The College are also provided, workforce training to SME's and support employers to recruit Modern Apprentices. One Modern Apprentice is in post with several more post being discussed.

The Chair commented that in Shiskine there has been an influx of professionals due to digital working. She also commented that there is a need more skilled trades people on the island.

The Chair thanked J Worthington for the update.

9 Islands Plan Engagement

S Baird provided the Locality Partnership with an overview of the sense checking of the island plan engagement exercise that is currently underway:

The island plan engagement exercise commenced in mid-August 2021 to sense check the findings of specific consultations, survey and feedback gathered during 2019 and 2020 to inform inclusive place-based plans for Arran and Cumbrae.

A key area of focus is working in partnership with island communities, businesses, and wider stakeholders to develop and facilitate the delivery 10-year island plans that maximise the potential of Arran and Cumbrae.

SKS Scotland are working on behalf of the Council to undertake a short, focussed exercise to check that the issues and actions identified through earlier island engagement are still relevant as we enter covid recovery period.

S Baird highlighted that the Team are acutely aware of the interdependences and the need to avoid overlap and duplication of plans at island level. Therefore, a short one-page diagram on how of these plans fit together will be provided in due course.

To ensure the engagement exercise is a success, a steering group with appropriate terms of reference meet on a weekly basis to take matters forward. This steering group is made up of island representatives, Community Planning Partners and officers from the Connected Communities and Corporate Communications Team.

There will then be an opportunity each year for input each year as part of the plans annual review.	
	S Baird highlighted that in terms of island relating funding, the Island community fund application window closed on 16 July. The fund was oversubscribed with 180 applications. 41% of applications came from third sector and the remaining 59% from businesses. Final consideration is being made and applicants will be advised in due course.

Purpose: To provide the Arran Locality Partnership with an update on the development of the draft 10-year Arran Island Plan and seek endorsement from the Partnership of the production process undertaken to date and seek support for the proposed next steps.

1. Introduction

- 1.1 The Islands (Scotland) Act 2018 introduces measures to underpin the objective of ensuring that there is a sustained focus across Government and the public sector to meet the needs of island communities now and in the future. The Act also gives effect to a range of policy changes to improve outcomes for our island communities. This includes placing a duty on Scottish Ministers to publish a National Islands Plan and a duty to have regard to island communities in exercising their functions in essence, this means island 'proofing' what and how we do things. The Act recognises that island communities often face different issues and challenges compared to the mainland. The National Islands Plan published in December 2019 provides a framework and 13 strategic objectives for action to meaningfully improve outcomes for island communities.
- Aligned to the National Islands Plan, the Council is participating in an ambitious three-year Islands Recovery and Renewal Pilot in partnership with the SG and HIE to support an inclusive and green economic recovery and renewal of North Ayrshire's Island communities in line with their unique needs. The pilot project is aligned to the delivery of the National Islands Plan and Community Wealth Building principles. A key area of focus within the pilot is working in partnership with island communities, businesses, and wider stakeholders to develop and facilitate the delivery of 10-year socio-economic Island Plans to maximise the potential of North Ayrshire's islands.
- 1.3 In recent years, the Arran community have contributed to a variety of consultations and engagement exercises including locality planning, National Islands Plan consultation and others. These have produced a host of issues, aspirations, commitments, and actions. As we recover from the Covid-19 pandemic, it is timely to step back and sense check how relevant the issues and ideas that islanders have previously voiced are,

and to refresh the priorities for each island post-pandemic. To build on this previous engagement and inform the development of Island Plans, a comprehensive and in depth engagement process has taken place with communities on both Arran and Cumbrae over August and September 2021 to identify if previous priorities are still relevant and what changed or new priorities and actions are required to support island recovery and renewal.

1.4 To support the development of the Arran Island Plan, the Council commissioned and published research from the Fraser of Allander Institute on the disproportionate economic impact of Covid-19 on the Arran economy in September 20201 and provides an outline socio-economic baseline for Arran that can be updated and monitored moving forward to inform an evidence-based approach to policy development.

2. Engagement Activity

- 2.1 Starting in August 2021, SKS Scotland CIC were commissioned by the Council to undertake a proactive engagement exercise with island businesses, communities, young islanders, Elected Members, local stakeholders, Locality Partnerships and wider partners for the Isles of Arran and Cumbrae. The purpose of this exercise was to sense check the findings of specific consultation and feedback gathered during 2019 and 2020 to ensure that the issues and actions identified through earlier island community engagement and planning are still relevant as we enter a Covid-19 recovery period and, where required, develop new actions. From late August until mid-September the following activities took place:
 - Desk-based analysis and summary of previous island engagement and consultation;
 - Launch of short-life engagement website;
 - Open short-term survey to allow people to have their say (with paper copies made available at key island locations);
 - Contact with community organisations, business networks and other stakeholders to arrange discussions;
 - Two public online community conversations for Arran and Cumbrae;
 - Two final public online discussions one for each island where islanders came together to discuss the short, medium and longer-term priorities that will inform Arran and Cumbrae's 10-year Island Plans.
- 2.2 The engagement is supported by a small Short Life Working Group with representation from each island (membership includes Arran Locality Partnership, Cumbrae Community Council, Arran Recovery Group and various Council services). The role of the group during the engagement process included: clarifying expectations of the engagement process and outputs; providing relevant knowledge, contacts and share any local sensitivities to be aware of; monitoring and agreeing any amendments to the approved work programme; approving content for all project related communications and sharing communications with relevant networks.

The engagement process for Arran received a wide range of responses and perspectives as demonstrated in Table 1.

- 31 organisations invited to contribute
- 471 unique website visitors (across both islands)
- 9 individuals directly contacted SKS to input (across both islands)
- 2.3 The key themes that engagement participants raised for Arran are outlined below in Table 2.

- 2.4 Following the conclusion of the above activity on 30 September 2021 work has been underway to draft the 10-year Arran Island Plan. There is now a particular focus on the development of the accompanying 2022/23 annual action plan.
- 2.5 A key intention of the Islands Recovery and Renewal Pilot is for the Island Plans to be developed in partnership with local communities and therefore draft 'Island Plans for comment' (including sample 2022/23 annual action plans) will be made publicly available from **noon on Monday 29th November** for final comments, invite ownership of actions and partner contribution, and provide example case studies to ensure a robust and inclusive 2022/23 annual action plan is prepared.



- Case studies of community, Council and partner activity will be covered in this section
- Implementation including governance
- Appendix 1 –2022/23 Annual Action Plan (under development)
- 3.2 A key area of focus for the Island Recovery and Renewal Pilot is to contribute to closer and more coordinated working between the island communities, partners and national and local government and agencies to ensure stronger island-focused partnership working and will work collaboratively to unlock the knowledge, resources and support necessary to bring the Arran Local Island Plan to life. What will be key to the implementation stage will be the governance model that will have responsibility either collectively or individually for the delivery of the actions.
- 3.3 Whilst it is essential that governance of the Island Plan aligns to the Arran Locality Partnership structure, there is also a need for thematic expertise and wider islander input. A draft governance model for consideration and further exploration is included within the Plan, with an appointment process to be established to ensure appropriate and inclusive representation. The 'delivery group' approach has also been taken by Scottish Government for the delivery of the National Islands Plan.

 - New actions suggested from engagement process that are feasible and deliverable
