NAC Roads: -Access Steps to Maimhor: - Cllr Ferguson will continue discussion with the residents and NAC Roads Dept. to ascertain if there is any other way that the repair of the steps can be undertaken, and report back to the Community Council. No change from previous month.

NAC: Village Library- The Village Library has increased its opening hours from Monday the 18th October to almost a pre-Covid level access is still restricted on a minimum distance format and delivery of returned books. Computer usage requires booking.

Remembrance Sunday: The event took place on Sunday the 14th November, WKCC would like to thank Streetscene for their work in preparing the war memorial, this being the 100th anniversary of the British legion and the Lady Haigh poppy appeal, the Primary School for the first time laid a wreath and would do so from now on.

NAC: North Coast Community Chit Chat, ---(**DF**) This will take place in Skelmorlie Community Centre 7.00pm till 9.00pm on the18th November. (**GC**) has registered. (**DF**) This has been cancelled due to lack of interest and will be re-instated in January, it is the intention to have more local meetings in the new year.

Scottish Government—NPF4—The draft NPF4 document has been issued for consultation. WKCCC will respond in due course.

NAC Local Place Plans Workshop; - (JL) Information received 11/10/21 and forwarded to members. We would register interest in being part of the ongoing scenario. Currently little information available for how these would be developed in Local Authorities and what status they would have. —There has been no change from last month.

NAC --LDP3, -- The issue of a draft LDP3 for consultation has been delayed until second quarter 2022.

XLCC; It is expected that a Planning application will be submitted early next year.

Hunterston non-nuclear Generation, Battery Storage and Synchronised Compensators. FlexibleGridPower2 Ltd: Power Generation Submission to Scottish Government at Hunterston Estate. (JL) initial indications are that the application to Scottish Government has been approved and that a detailed planning application will be submitted to NAC in the near future.

West Kilbride Website: (KH) Website further training is required to ensure the website is kept up to date. This will be carried out this week The site will be launched with an invitation to send information the community wishes to have posted.

ACTION: (KH) will report on a monthly basis on progress.

Glen Paths: (NA) This is ongoing with NAC Streetscene. Friends of Kirktonhall Glen will meet on the 27th of November and it is hoped by then to have an update from Streetscene. (NA) The hedge to be cut runs the length of the bank running along to east of the grass football

pitch from the tennis court to the ramp down to the ford with its recently replaced footbridge. Thus, opening up and restoring the all-weather path that runs along the base of this hedge."

. Streetscene have been asked as to who is responsible for maintaining the hedge.
