## **Woodland Creation**

We also asked for feedback on the type of woodland that people wanted to see at the north of the site which Green Action Trust will consider in their proposals. We were delighted that several people expressed an interest in being involved in the planting and managing of that woodland and we look forward to working with those individuals. Species of trees that you would particularly like to see planted in the new woodland included fruit trees, cherry blossoms, oak, bushes like bramble, raspberry, gooseberry, blackcurrant etc., beech, birch, apple, scots pine, joseph rock trees, rowan, hazel, chestnut, aspen crab apple, bird cherry, and fir. As a result of the demand for an orchard and community garden we have identified a potential location for this at the south of the site.

## Accessibility

Some questions were raised about accessibility within the park. The park will be designed to the standards of universal access. This means it will be designed for all abilities - there will be full provision for wheelchairs and buggies and special provision for those with sight impairments etc.

## **Next Steps**

Now that we have a final design we will begin the process of delivery in a phased way and in line with drawing down funding support from a range of project partners. We will finalise the detailed plans over the next few months so that we are in position to get planning permission delivered quickly when we are ready to build out phases of the park plan.
