2. Brief description of your organisation

Beith Playpark Action Group are a registered charity (SCO31704) formed in 2001, so we have been in existence for 21 years, and our charitable objectives are "to promote the benefit of young people of Beith and surrounding area by associating with the local authorities, voluntary organisations and inhabitants in a common effort to provide play facilities in the interest of social welfare for recreation and leisure time occupation with the object of improving the conditions of life of the said young people".

The Group have previously delivered over £250,000 of investment in play and outdoor leisure provision on Orr's Park, and in 2005, the were presented with The Queen's Award for Voluntary Service, acknowledging the many hours of voluntary work put in by the members.



3. Title and summary of proposal

The proposal is to replace the old skate park ramps with a new concrete state of the art skate park on the existing site and provide a new zip wire and outdoor gym within Orr's Trust Park. We have recently extended BPAG's lease of the park and we have a strong track record in delivering high quality play facilities for local youngsters.

The project is proposed for Orr's Trust Park in Beith. This park is central to the town and a key focus point for leisure and recreation in the community with a pitch, running circle and grass space, as well as the Group's existing skate ramps, MUGA and play park. The current provision of play and skate ramps provided and maintained by the Group is shown on the map below in yellow.



The following images show the current skate provision in the park which is outdated and dangerous. The Group acknowledge that the materials used for these ramps and features, and the surface on



the park at present are not in line with today's wheeled sports facilities and recognise the demand for improved provision in Beith.



Who is our target audience?

Our target audience is young people in Beith and their families

- 26.4% of households have one or more children
- 26.5% of households do not own a car
- 27.5% of households are listed as council or social housing
- 5.8% of the population (16-74) are listed as unemployed

We are also keen to help alleviate social deprivation by offering access free of charge to new innovative play facilities. The SIMDs for Beith are shown below

Who it will benefit and how? It will benefit ALL local families and young people who live in Beith.

Given huge increases in household energy, food and fuel costs it is even more important now to be able to help all families access high quality play facilities which are locally based so people can walk to them without having to draw on the already overstretched family budgets. The benefits of participating in outdoor activities and play are well known.

Additionally, other residents in the Garnock Valley will also be able to access these facilities free of charge. No other public park in the Garnock Valley currently has outdoor gym equipment. The improved skatepark will further enhance the provision for wheeled sports in the Garnock Valley.

People are healthy and active.

By its very nature, the proposed facilities for Beith promotes active lifestyles, in particular for those who may experience greater barriers to participation. In developing active lifestyles, and increasing



the levels of physical activity, participants have a direct positive impact on their physical and mental health. The provision of new facilities will help meet this outcome.

By encouraging both improved physical health and increased opportunities to develop social skills and interact with peers, the facilities proposed will improve the quality of life for its users. By increasing and improving the range of skate boarding and wheeled sports facilities, the Group will continue to expand and develop opportunities for more people to become more active and healthier. BPAG plan to offer Come and Try skate boarding events where more established skaters help young ones to learn the basic skills.

Restrictions due to Covid-19 may continue for some time, or maybe imposed again in the future. A facility such as a skatepark will provide a much-needed opportunity for residents of all ages to use during allowed daily activity.

What partners we are working with

BPAG have a positive partnership with NAC Facilities/Streetscene. Ian Hollis (NAC Facilities Maintenance Office/Streetscene) is supportive of the planned development and a meeting is due to take place at the park to discuss the proposed changes.

Beith Trust have the lease for the running track and football pitch at the park. Jane Lamont, CEO, is aware of the proposals and is supportive of improving the facilities at the park. There are plans to create a park users' group to ensure all with an interest in the park meet and work together, BPAG would welcome this.







Below are some concepts of what a new skate park might look like.

Outcomes

The outcomes we hope to achieve is to improve wheeled sports and play facilities free of charge at local level in Beith. We are hoping our skate will have "different" features to the skatepark at Dalry and therefore compliment the overall Garnock Valley wide skate boarding experience. We hope young people from Dalry, Kilbirnie and Beith will be encouraged to mix together and use different facilities. Dalry and Kilbirnie residents can access Beith by public transport and there is a recognised cycle route.

Our secondary outcomes relate to the benefits these will provide for local residents and young people.

Our new facilities link to NAC LOIP/ Fair for All which recognises that high levels of inequality, particularly poverty exist in North Ayrshire. The Local Outcomes Improvement Plan (LOIP) 2017-2022, has an increased focus on child poverty. By providing play and wheeled sports facilities that are free of charge to use, our project addresses the Council's priority areas of a healthier North Ayrshire, a thriving North Ayrshire and meeting the needs of children and young people.

Our outcomes link to the following national policies and strategies;

"Take Life On"

This Scottish Government Health and Wellbeing campaign promotes healthy, active lifestyles through various online, media and event marketing. The focus is on encouraging people to find activities near them, understand the health implications of inactivity and obesity, and to ultimately reduce the resultant strain on the NHS in Scotland. With targeted marketing and promotion of facilities in North Ayrshire, the Group can increase the interest and excitement around the project to attract more people into sports and exercise, with a particular focus on young people, and those who perhaps are financially disadvantaged, therefore unable to access paid activities and facilities.



Scottish Government's Legacy Plan

This plan sets out the key legacy aims and ambitions and highlights a wide range of initiatives, which will be taken forward with key partners over the next 10 years. The plan focuses on an Active Scotland, Connected Scotland, Flourishing Scotland, and a Sustainable Scotland.

Improving the nation's health is the overarching theme of the plan and the Active Scotland component of the plan includes two key initiatives. Both are aimed at increasing the availability and accessibility of physical activity and sport to individuals and communities that will in turn contribute to improving the health and fitness of people in Scotland.

These initiatives are the Active Nation and the development of Community Sport Hubs. Active Nation aimed to create a popular and high-profile movement to motivate people of all ages across Scotland to become more active. Community Sports Hubs focused on the bringing together of communities of interest to share best practice and shared values across a range of sports.

The development of improved wheeled sports provision in Beith aligns with this strategy, creating a potential wheeled sports hub for young people to socialise, participate in exercise and be diverted from any temptation of antisocial behaviour or activities detrimental to their health or development within the community.

Active Scotland Outcomes

The Active Scotland Outcomes Framework describes Scotland's ambitions for sport and physical activity. Active Scotland Outcomes contribute to the delivery of National Outcomes and ultimately to the Scottish Government's overarching purpose of creating a more successful country, with opportunities for all to flourish. The framework has been developed collectively with partners through the National Strategic Group for Sport and Physical Activity (NSG), chaired by the Cabinet Secretary for Health, Wellbeing and Sport. Conclusively, the following outcomes are proposed – and evidently supported by the proposal to develop a new wheeled sports facility in Beith.

- We encourage and enable the inactive to be more active.
- We encourage and enable the active to stay active throughout life.
- We develop physical confidence and competence from the earliest age.
- We improve our active infrastructure people and places.
- We support wellbeing and resilience in communities through physical activity and sport.
- We improve opportunities to participate, progress and achieve in sport.

Physical Activity Implementation Plan – A More Active Scotland

This 10-year plan adapts key elements of the Toronto Charter for Physical Activity (which makes the case for increased action in tackling physical inactivity) to Scotland, and links it directly to the Scottish Government's legacy ambitions for the Commonwealth Games. Underpinning delivery of the overall commitments of the plan will be a series of detailed action plans which will define how the plan's commitments will be met.

In addition, the Scottish Government and its partners continue to spread the word about the importance of physical activity, informing people about how and where to get involved through the following websites:

By providing improved wheeled sports facilities in Beith the Group will contribute towards achieving the outcomes of the National Physical Activity Implementation Plan.

In terms of addressing Equality issues our project subscribes to the following;

Promoting accessibility

Our project will promote accessibility and all sections of the community will be able to use the new facilities in Orr Park with relative ease.

Valuing cultural diversity

People have different needs, beliefs, values and abilities and these differences need to be respected and promoted. This will be achieved by providing facilities suitable for everyone.

Promoting participation

We have a close understanding of the needs of the community but need to prove this through our consultation exercises (Feasibility Study). In this way we have involved local people in the design of the play areas and in selecting the type of equipment to meet their needs. Our project is all about promoting participation in local park development. Residents local to the park had the opportunity to feedback their views through the feasibility study which was widely circulated. BPAG have received a letter of support from Beith Orr Park Neighbourhood Watch group.

Promoting equality of opportunity

We believe that we should create a level playing field for everyone and this will be reflected in the final designs for our project. We will take account of representations from older people and disabled so these will be accommodated in the final designs. The design of the park should be fully accessible to meet the Equality Act regulations and we have been invited to liaise with the Garnock Valley Disability Forum regarding the design and layout of the skatepark.

Promoting inclusive communities



We want to help build strong communities, in which:

- people feel they belong
- their lives are appreciated and valued
- people have similar life opportunities, and
- strong, positive relationships develop between people of different backgrounds.

Our project aims to achieve all of these things.

Reducing disadvantage and exclusion

We feel as a community we have been disadvantaged by the very nature of location, lots of house building but not much in community facilities. We hope to redress this imbalance through our project and promote inclusion of the most disadvantaged and excluded.

Fit with Moving Around

By creating locally based facilities there should be readily accessible to everyone who lives in Beith in line with the Scottish Government's Place Based programme on reaching facilities within a 20 - minute walk of where people live.

Fit with Work and Local Community

Through our Feasibility Study we have demonstrated community support and evidence of need for the proposed new facilities.

Fit with Facilities and Amenities

This is probably the best fit in that we are providing new and innovative wheeled sports and play equipment as addition to local amenity provision.

Survey Promotion & Reach


The survey link was promoted through a number of local social media channels, groups, and key contacts. In addition, the project and survey were highlighted in the local newspaper.

For those unable to access the online survey, contact details were provided to request a hard copy by voicemail or email. The survey ran for 6 weeks with a total of **250** responses. This probably represented more than **1,000** individuals as some were replying on behalf of whole families.


We have 13 letters of support included in the appendices of the attached Feasibility Study



Respondents were asked if they supported the development of a new concrete skate park on the existing site in Beith, as shown below there was 96% in support of the project.



The group are also investigating funding options to improve play provision in the park. As part of this they are considering installing a zip wire. Is this something you would like to see provided? 89% supported this.



In order to maintain involvement of local people we intend to create a local skate park user group to assist with finalising the designs for the final layouts. Therefore local young people will have the opportunity to take ownership and pride in their local project.



We have a strong track record of delivering other play projects in excess of £250,000. The project's finances will be managed in exactly the same way and also reflect open procurement in line with the Council's tendering and procurement regulations.

It may be necessary to break the project into 2 phases depending on the timing and availability of other matched funding streams. If this was necessary, we would have phase 1 as the new skate park and phase 2 as the zip wire/play equipment.

Our whole committee are volunteers and this will be expanded on perhaps with the creation of a new wheeled Sports User Group made up from local residents and young people. In terms of employment there may be opportunities to provide part time coaching/instruction as outlined in our Feasibility Study, experienced skateboarders could be asked to facilitate 'come and try' sessions.

Notwithstanding the proposed free access, respondents were asked if they would be supportive of a membership scheme, to provide people with access to coaching, classes, and instruction. As shown below, there was a moderate majority supportive of this:

8. Monitoring and evaluation process

Please include detail on the monitoring and evaluation processes planned or in place.

The primary aim of this project is to improve the health and wellbeing of young people locally. This I be achieved by providing engaging and appropriate facilities locally for children in and around Beith, preventing them having to travel further afield to take part in wheeled sports, and promoting wheeled sports as a low cost and enjoyable option for healthy outdoor activity.

Whilst the monitoring of this project's success will be primarily anecdotal, the group will build on the findings of the initial survey, and undertake regular post project delivery engagement work to understand how it has impacted the community, namely:

- Communication with the local community policing team and community council to identify reductions on antisocial behaviour both in the park's vicinity, and in the wider Beith area.
- Spot counts conducted by the group regularly on a variety of days to assess the number of users of the facility, and compare to the user numbers of the existing ramps (which anecdotally were minimal).
- A follow up survey will be conducted 3 months, and 12 months after the project is complete, this survey will repeat a number of questions in order to compare against the initial baseline figures:
 - \circ How often do you or your children use the existing skate ramps in Beith?
 - Do you travel elsewhere to use wheeled sports facilities?
 - How do you rate the quality of the existing skating / wheeled sports provision the local area?
- Communication with schools and local youth organisations to discuss and understand the benefits resulting from the park, and the ongoing opportunities for partnership working based around the facility.
- The group will also gather testimonials from parents, carers and young people to sense check the views and opinions of the facility, and to understand anecdotally, how it has positively impacted the community.

Bypass Art - Bypass Art was formed in 2017, shortly after the construction of the new Dalry Bypass was announced and their ultimate aim is to site a piece of public art (of Bessie Dunlop, Witch o' Dalry) on the Hillend Roundabout near Dalry. They feel this is an opportunity to highlight Dalry, to remember what happened to Bessie and so many innocent others and an opportunity to combine art and culture, creating an attractive gateway into Dalry. They are currently working with John Hodgart, Beith Drama Group, local residents and Grey Hill Productions to record an audio book of John Hodgart's play 'Bessie Dunlop, Witch o' Dalry', with an expected completion date of 31st October.

Lochshore Park Development - The active travel route from Kilbirnie to the site is now complete. The 5km route is under construction and will be completed by the end of December and the play area at the hub should be delivered within the next few months, as well as new woodland planting. The Lochshore Park Hub construction is now complete. A formal launch will be held on the 4th of October, followed by a Family Fun Day on the 8th of October from 10.30am-4pm. This day will see a variety of activities including nature and heritage walks, crafts and bug hunts, inflatables and some adventure sports taster sessions and a scavenger hunt. They say they would love to see you all there on the day.

Our Community Space – This programme was created in response to the rise in reports of social isolation and an increase in suffering from poor mental health. "Our Community Space" offers a safe space for local people within their own communities, where people can engage in conversation, meet new people and access services to improve their personal situations. "Our Community Space" is staffed by a partnership from NAC Community Development Team, Community Link Workers, Turning Point and NAHSCP. Supporting agencies and partners can also attend sessions to provide information and support. The drop in runs on a Thursday afternoon in Dalry, Kilbirnie and Beith on a rotating cycle from 1pm – 4pm.

Garnock Valley Once Loved Uniform Centre – Members of the Youth Forum, who developed the Uniform Centre, attended NAC summer programme and holiday meals to make contact with local families. They are currently planning an open day in October to help raise awareness and provide uniform items free for local families. Garnock Valley Carves - This year's 4th annual Chainsaw Carving Event was held in the Manse Field off Glebe Road on Saturday 10th September. It was another busy, sunny day and this year there were 12 international carvers taking part along with many local stalls. It was a great family day out.

Garnock Valley Summer Programme - Four events were offered over the summer period across the Garnock Valley, including events at: Lochshore, Bridgend Community Centre, Dalry Public Park and Beith Astro. Each event offered free refreshments, inflatables, sport activities, arts and crafts, retro gaming, uniform swap shop and activities offered by partner agencies. Activities offered through partnership work included: junior wildlife rangers, canoeing and kayaking, BBQ, meet with emergency services (Scottish Fire and Rescue) and use of venues and facilities. The summer programme has created opportunities to develop partnerships in the future, to offer a more varied programme of activities to help engage with the wider community. Partners during the programme included: Dalry Community Sports Club, Eglinton Park Ranger Services, Garnock Valley Canoe Club, Lochshore Management Group, Beith Community Development Trust and Scottish Fire and Rescue. Approx. 700 people attended the events and feedback received was extremely positive.

Holiday Meals Programme - This programme was delivered across three venues in the Garnock Valley and was well attended. It offered a wide range of fun activities for all participants to get involved with. Each day offered both sports and leisure activities as well as arts and crafts sessions. Every young person who attended received a free lunch and healthy snacks throughout every session. In Dalry, Dalry Thistle allowed the staff and young people to utilise the park for outdoor activities, this was an added bonus given the weather and the young people wanted to play outside. The programme also encouraged and developed partnership work with sessions being delivered by NA Active Schools, Impact Arts, KA Leisure, Scottish Sports Futures and saw the Beith programme delivered by Beith Community Development Trust at Beith Astro.



Moving around

Highlights

Sustainable Transport Survey - The Moving Around working group has been working with Planning Aid Scotland, as part of the Sustaining Choices Programme. As part of this project, they have been conducting community engagement with the local community. This has been to understand their experiences and challenges whilst using sustainable methods of transport in the Garnock Valley. Sustainable transport includes walking, wheeling (mobility aids) and using public transport. They have used a combination of methods to gather the communities' opinions and priorities. Community members, groups and 20 ganisations have been invited to take part

(Public transport, traffic and parking)

through online sessions, face to face sessions and completion of a Microsoft form. To date they have received in excess of 330 responses. This data is currently being analysed and the captured information will be used to form an evidence base and action plan which looks at these identified issues and will work towards making changes. A feedback session is planned for mid-November.

Once Loved Bikes - Recently, NAC funded a group of men from Men's Shed Dalry, to undertake the Velotech Bronze Bike Maintenance Course. As part of the ongoing commitment to the course, participants are required to consolidate their learning, by putting their newly acquired skills into practice. They do this by fixing up bikes which are donated and issuing them, free of charge, to those in need in the local community, thus recycling once-loved bikes. In turn, recipients benefit from a cheap and sustainable method of transport, which enhances their health and wellbeing, opening up a host of work, travel and leisure opportunities.

Health Walks in the Garnock Valley - As part of Ayrshire Walking Festival (3rd to 11th September), two walks were held for new participants around Kilbirnie and Speirs Old School Grounds. Participants commented: "opened my eyes to parts of Ayrshire I hadn't been to.; "interesting to see the history of the town"; "more events like this would be good"; "well worth having". Health Walks continue across Garnock Valley every Wednesday, all welcome.

Garnock Valley 2023 – Consultants have now been appointed to deliver on this community engagement project, which will create a cultural and heritage vision for the Garnock Valley.
