Organisation name	CHAP – Community Housing Advocacy Project		
Brief details of organisation	CHAP provides free and independent information and advice on housing, welfare rights and debt issues to residents of North Ayrshire. Various services are delivered, offering a balance of reactive and proactive assistance. All of the services delivered by the organisation have in common the purpose of ensuring that individuals are not disadvantaged through a lack of awareness or information regarding their rights. The ethos of all services provided supports and promotes social inclusion and social justice for all. CHAP supports those individuals most in need to receive much needed information and support to address issues and problems that affect their everyday lives. The service empowers individuals to have their views and opinions heard by the decision makers and overcome the barriers of literacy and communication difficulties. CHAP has been delivering services in the local community for over 20 years and is therefore well established and well connected with partner organisations. In our last financial year (ending Nov 21), we assisted 715 clients with a variety of housing, debt and welfare rights issues.

Brief overview of proposal	Following the success of our newly established community hub within Kilwinning Sports Club, which has seen referrals from the Kilwinning area increase dramatically in the first few months of the project, with clients being supported with multiple complex issues within a trusted environment in their local area; CHAP, Ardrossan Community Development Trust, and Ardrossan Community Sports Hub want to work in partnership to replicate the success of this within Ardrossan to take the service out into familiar and established locations within the heart of the community. Our project in Kilwinning has proven that people are more likely to engage in places where they can access services more discretely, as there is still a stigma in society around reaching out for help, especially concerning money and debt issues. In the first 6 months of the Kilwinning project, we have achieved over £70,000 of financial gains for individuals and their families. During the current financial crisis, putting money in people's pockets has never been more needed than it is now. As such, we are requesting money from the Community Investment Fund to resource a full-time Advice Worker post, which will allow a dedicated adviser to work solely within a community hub in Ardrossan. The worker would be based within the Ardrossan Community Sports Hub for 3 days a week offering a drop in service as well as pre booked		

	 appointments (with the other 2 days being office based for case work, training etc) CHAP advice services will compliment all the community work that the team at the Sports Hub are carrying out to encourage people to think about their overall health and wellbeing. We will also work with ACDT who are a referring partner of ('children In Need', to ensure that we are driving forward North Ayrshire Council's priority to reduce the levels of Child Poverty in the area. The worker will be initially based within the Ardrossan Community Sports Hub, with the intention of looking at other possible hub locations within the area as the project progresses and additional funding is secured. According to the latest Child Poverty statistics, North Ayrshire has the second highest rate in Scotland, and within North Ayrshire, Ardrossan Central has 31.1% of children living in poverty and is the most vulnerable compared to similar communities in Scotland. Ardrossan Northeast has 24.4% of children living in poverty. Due to the current cost-of-living crisis, which is predicted to get worse towards the end of 2022, and into 2023, the need for the services that CHAP provides is ever-increasing, and it is vital that we are able to place our dedicated, knowledgeable advisers at the heart of communities. This proposal meets the locality partnership priorities in several ways. The project will promote the local economy by maximising people's income, which in turns means they have more money in their pocket to spend, therefore boosting the local economy. The work we do and the support we provide to our clients improves their overall wellbeing. Our clients report that the help they receive from CHAP aids in improving their confidence, their finances, overall quality of life, as well as reducing their stress. By establishing a foothold within the community in Ardrossan, this will encourage more people to engage with our service. This h

Brief details of organisation	Co-Produced 3 Towns Safer Shores are 3 community groups who came together in early 2022 with a collective approach to Community Safety, to benefit the 3 towns giving comprehensive CCTV coverage of the shoreline from the Barony Church, Ardrossan to the Beach Park, Stevenston essentially making the 3 Towns shores safer. The 3 groups involved in this are Raise Your Voice with Ardeer(RYVwA), Saltcoats Active Lifestyle Team(SALT) and Ardrossan Community Development Trust(ACDT). Raise Your Voice with Ardeer are a local Charity encapsulating Stevenston and Kilwinning and have been running for 5 years now. Our Charity are currently in the process of delivering the new fully funded Beach Hub / Community Cafe and toilets down Stevenston Beach. SALT became a constituted voluntary community group on 3rd August 2021. We are in the process of completing the regeneration of the play park at Winton Circus, Stevenston. ACDT were incorporated in July 2019 with the assistance of the Our Place programme, which was coming to an end. The Trust were established to succeed the Our Place programme and continue with community development within Ardrossan, including the completion of the proposed Playpark for the Town. A new engaging and informative website was launched in 2020 and provides detailed information on projects being developed within Ardrossan and can be found at www.ardrossantrust.org

Amount requested	£150,000.00
Brief overview of proposal	The 3 Towns Beaches are a popular destination for both locals and visitors. They are an extremely valuable asset to the communities of Ardrossan Saltcoats and Stevenston and need to be protected. At present there is no CCTV or limited CCTV along the 3 towns shorelines. Having CCTV along the Beach area from Ardrossan to Stevenston would help keep recent community investments such as the Playpark in Saltcoats, Beach Hub in Stevenston and the soon to be Beach Hub, Café and Playpark in Ardrossan safer. The installation of CCTV would not only help protect local residents, visitors and all community investment projects, but assets such as the sand dunes and local nature reserves. Having CCTV would also be a good deterrent for stopping damage to the hight restriction barriers currently installed, new play park in Saltcoats and Ardrossan soon to be development. Due to the location of the areas, there is little to no street lighting so CCTV would be a very

	New strong partnerships have been developed with Raise Your Voice with Ardeer, The Saltcoats Active Lifestyle Team, and Ardrossan Community Development Trust to work together to help protect their investments for everyone to experience and enjoy.
	This community resource is even more needed to protect the investments placed on the shorelines between Ardrossan and Stevenston. The investments already placed on the shorelines and the planned investments that are in progress have raised the Civic Pride in the 3 towns. These investments are not just to promote tourism, but for the community. There is comprehensive evidence that the benefits of having CCTV on our shoreline will bring to the 3 towns.
	As a first collaborative approach, inclusive of the 3 towns it will bring communities closer together. This will act as one of the catalysts to get the community involved within the various group based in the 3 town.
	We will be working closely with North Ayrshire Council who will monitor the CCTV 24 hours a day this will reduce anti-social behaviour (young people and adults) therefore enhancing the safety of locals and visitors. This will increase investment within the 3 towns shores, protect the investments already there and encourage others to invest. As part of this we would encourage other groups and organisations to get involved

	Ardrossan Community Sports Hub SCIO was created in 2019 to promote a healthier Ardrossan where people are more active more often and where physical activity and sport helps bring about positive benefits for individuals and our community, including a sense of wellbeing, resilience and civic pride.		
Brief details of organisation	We have 133 members and beyond this our gym membership numbers stand at 340. Our 8 member Board are well connected with trusted community organisations such as Ardrossan Castle Heritage Society, Ardrossan Community Development Trust, Winton Rovers CIC, and local Primary and Secondary Parent Councils. To develop our activities we've consulted extensively with local people and groups using social media with over 1400 Facebook followers.		
Locality	Three Towns		
Amount requested	£100,000		
Brief overview of proposal	Ardrossan Winton Rovers are committed to developing further as a community club. Community use of the facilities at Winton Park, however, is constrained as the grass pitch is unable to take more intensive use. 15 teams currently operate under the umbrella of Ardrossan Winton Rovers Youth Academy (AWRYA), with more in the pipeline. A recent survey of Winton Youth Academy teams established that 324 players, 32 coaches and 44 volunteers were involved within these teams but that they face significant difficulties in securing local facilities to train and plan games - with Academy Managers reporting lower participation levels when travelling to train or play home games. Significant expenditure (c £50-70k pa) is made by the AWRYA teams outside of Ardrossan in facility bookings and ancillary spend whilst teams travel for home games and training – representing leakage from the local community. A mapping exercise of existing 3g provision in North Ayrshire shows that there is obvious under provision of facilities within Ardrossan and the Three Towns when mapped against those available in other North Ayrshire towns such as Kilwinning, Irvine, and Kilbirnie. There are no Astroturf facilities within the Three Towns that are suitable to accommodate full size 11 aside league games .		
	Ardrossan Community Sports Hub continue to develop their successful operation of a 7500sqft community gym in Ardrossan, having brought a redundant building back to life in May 21 - with more than 340 members taking advantage of affordable, low cost gym membership and 5 staff employed to operate the facility, creating valuable employment opportunities for local residents.		
	These 3 organisations are now working in partnership to develop proposals to create a 3G facility at Winton Park. Ardrossan has a population of 10500 which, given the platform provided by the Youth Academy supplemented by wider community use, could easily sustain a thriving 3G facility if a suitable funding		

package can be assembled. A recent community survey undertaken by ACSH demonstrated that a very significant proportion of the community as a whole are supportive of the project, with 80% expressing a positive view.

Ardrossan contains significant pockets of deprivation with low income and poverty being a barrier to participation in sport, a factor which inform our approach. In health terms 20 of the Three Towns' 44 data zones (45.4%) are in the top 15% most health deprived in Scotland which is the highest rate for any local authority. Compounding this picture of significant socio-economic challenges for Ardrossan is a marked absence of local provision for sport and fitness with KA Leisure Trust operating no facilities within Ardrossan.

The development of a new community asset would help give the AWRYA teams an identity and an affinity to the club and town – with a local survey establishing likely positive impacts on participation on sports and physical activity generally (92%), on pride in the area (90%) and on the health and wellbeing of people in the community (92%).

The project partnership would involve:

- Ardrossan Winton Rovers retaining ownership of Winton Park but lease the facility to Ardrossan Community Sports Hub for 25 years. Winton Park will remain the home ground of AWR who will have first priority access to the facility for home matches and training.
- Ardrossan Community Sports Hub would be the lead partner in seeking capital funding to install the new 3G surface and procure and manage the works contract. Post installation ACSH would be responsible for overall facility management, financial management and marketing and promotion of the facility.
- Ardrossan Winton Rovers Youth Academy teams would populate the facility for training and home games, providing sufficient income to make the facility financially sustainable and play a key role in managing and promoting wider community use.

The project will contribute directly to the priorities identified by:

North Ayrshire Community Planning Partnership - Local Outcomes Improvement Plan

Under the Healthier North Ayrshire Priority, the ambition is for all people who live in North Ayrshire to be able to have a safe, healthy and active life – this includes building on the strengths of local communities; and promoting good physical and mental health and wellbeing.

Under the Safer North Ayrshire Priority, the ambition is for North Ayrshire to be a safer place to live, residents feel safer and communities are empowered - which includes supporting communities by an asset based approach.

The Three Towns Locality Partnership The Winton 3G project contributes directly towards 3 of their 4 current priorities:

- Regenerating community facilities
- Increasing civic pride and community engagement
- Improving community wellbeing

	Our project partnership will look to deliver the following activities and outcomes within the local community
	 Promote excellent physical and mental health through participation in football, sport and physical activity. Enable more children and young people to engage in and enjoy positive sporting and diversionary activity. Increase the number of players, coaches and clubs playing football and progressing through recognized national pathways. Design and deliver specific programmes for a range of different groups within the community and link with related clubs and promote the new facility as a venue for local social and leisure events Create employment and volunteering opportunities, developing skills for life, learning and work. Improve access to sport and physical activities facilities and environments. Increase the level of community engagement with the Winton Park facility and establish a reputation for quality and good practice. Promote a strong, resilient, sustainable, and supportive community which has pride in its achievements.
	In April 2022 we obtained a set of indicative capital costs in the region of £615,000 for the installation of a 3G pitch and associated floodlighting and changing facilities at Winton Park.
	Our review of potential funding sources identified the Scottish Football Association Grassroots Pitches Fund as a key source which may contribute up to 50% of the cost, with initial consultations with the SFA confirming this and an expression of interest due to be submitted in Autumn 2022. A series of other smaller funding opportunities were also identified including Garfield Weston Foundation; Suez Landfill Primary Fund; Barcapel Foundation; Scottish Football Partnership; Peoples Postcode Trust; and Viridor Scottish Landfill Communities Fund.
	We would like to request £100,000 funding support towards our capital funding package from the North Ayrshire Community Investment Fund managed by the Three Towns Locality Partnership.
Timescales	Our timescales for the project envisages a capital funding package being secured by December 2023, with the works contracted procured by March 24 and the installation of the new 3G facility taking place during the close season between May and August 24.

Received £20,000 from Community project fund, had publicity in The Times and Scotsman newspaper. A feasibility study is now underway to be concluded Oct/Nov 22.
