Chair's Update

Councillor's Reports

Councillor Reid

- Produces a weekly blog detailing work carried out. Anyone can receive a copy or view it via social media.
- Dealt with 122 constituent issues since Ward 2 election.
- Happy to deal with any issues raised across the Ward.
- Doesn't hold surgeries, but willing to undertake home visits as and when the need arises.

Police Report

- Sgt. Clark presented the Police Report, which can be found at Appendix B.
- Youth disorder has been an issue across the Garnock Valley in recent years.
There has been a 75% reduction in youth disorder in Dalry in the last year.
- There remains a lack of reports on drug using / dealing.
- It was agreed that the Community Council's social media page would highlight CrimeStoppers as an anonymous way of providing information to the police.

Health and Social Care Partnership (HSCP)

Update provided by

Michelle Sutherland, Senior Manager Primary Care Development, since September 2021

Dr Iain Jamieson, Clinical Director, who has been in post for one week.

Michelle Sutherland is tasked with prioritising the work covered by the Caring for Ayrshire programme.

The programme considers factors such as deprivation, capacity and physical condition of the buildings and population change. The new model is based on multi disciplinary teams (MDTs) which involve multiple disciplines being available within a practice.

Dalry reportedly has Nurses, Pharmacy, Mental Health (post currently vacant), Community Link Worker and Physiotherapy services.

Dr Jamieson asked the Practice Manager at Dalry Health Centre if they considered there was an accommodation problem in Dalry. The response was no, there was not an accommodation problem, the issue was recruiting GPs. The opinion of the Practice Manager was that 2 additional GPs were needed in Dalry.

Questions asked:

- Trying to contact the practice by phone can be very difficult. The Chair commented that they made 133 calls to the Health Centre in one day.

Q: Is there anything being done to improve the situation?

A: Practices record a high level of calls, although it is not known how many of these are repeat calls because people cannot get through.

GP practices are contracted businesses. They are being encouraged to invest in modern digital systems.

- **Q:** In light of the previous comment about the number of GPs and that the HSCP had stated previously that Dalry had capacity issues, does Dalry have capacity issues?

A: In terms of the MDT teams currently operating in Dalry, there are no accommodation issues.

A recent retirement, has impacted on the number of GPs serving the practice – which the practice manager considers to be 2 GPs short.

Across North Ayrshire, there are currently 9 GP positions being advertised. The GP running the practice feels that “they are coping with demand, although they could cope better”.

- **Q:** In 2013, Dalry and Beith were highlighted as being urgent priorities for replacement, the two highest priorities in North Ayrshire. In 2017, the HSCP reprioritised Dalry and Beith as there was “no real issues”. Since that time continuous requests, latterly through Dalry Community Council for the evidence justifying the reprioritisation have been ignored. Similarly a recent request for the analysis on which the Caring for Ayrshire report was based, placing Dalry as the last practice to be addressed, has been ignored. Previous comment about the number of GPs and that the HSCP had stated previously that Dalry had capacity issues, does Dalry have capacity issues?

Can we see the analysis on which the prioritisation is based?

A: I (Michelle Sutherland) thought that the director had sent a copy of the analysis. I will send an email to the Director tomorrow requesting that it be sent. Who else would you like it sent to?

Councillor Reid and Helen McNaughton of Beith and District Community Council requested a copy.

- **Q:** Is physiotherapy treatment available in Dalry, or do we still need to travel to Kilbirnie?

A: Physiotherapy has been available in Dalry for a while.

- **Q:** If Dalry were to have an increase in population, due to the development of a housing estate, would there be accommodation in the practice for an additional GP?

A: The Practice Manager considers there is room for the GPs which they are currently trying to recruit.

“What we are seeing now is surgeries who are kind of on their knees in terms of physical space”.

- **Q:** People with high level mental health issues have possibly not received the treatment they need due to pressure on the services. Dalry did not have any provision. Will there be more funding for mental health services?

A: The Scottish Government are increasing funding for mental health activity. Lockdown has created a tsunami of people with mental health issues, so we are going to have to be creative in the way we deal with that.

A Mental Health Practitioner is due to start in Dalry / Beith in July.

- **Q:** Are they considering a central facility for the Garnock Valley?

A: The proposal is for a central health and social care facility, Where we can, we will have GP surgeries in individual towns.

Removal of Lifeline Bus Services (X34 and X36)

- **Helen McNaughton, Chair of Beith and District Community Council gave an update on the meeting held in Beith.**

Invitations were sent to Stagecoach, SPT, Ward 2 Councillors and MSPs.

Over 300 members of the community, including some from Dalry, and four Ward 2 Councillors attended the meeting. None of the other invitees attended.

On the night an announcement submitted by our MSP said that there would be a stay of execution until the 1st October, with Stagecoach looking at providing a “basic service” from 17th July. No details of the basic service were provided.

This was refuted the next day on the Stagecoach website. It is unclear what the position is.

The Scottish Government have recently announced that legislation will come into force to allow local authorities to provide public transport either directly or through contracts.

The buses are vital to the Garnock Valley, and we need to fight to keep the service. Several people shared their personal experiences, outlining how these services were a vital lifeline for workers, carers, those in education, health, wellbeing, social inclusion, and those who benefit from free public transport, which does not extend to rail services.

The question was raised as to how we will attract and retain people in the Garnock Valley if there is no viable transport system.

People were encouraged to write to Stagecoach, the Scottish Government, Strathclyde Passenger Transport (SPT) and our elected representatives to highlight the personal impact that the withdrawal of the services would have.

There was widely held opinion that Stagecoach were making decisions solely on a financial basis, with no consideration of the impact on the community.

The usage of the services, which Stagecoach claim are too low to be viable were questioned. People using the services suggested that they were often busy. There were also reports of journeys on these services not being recorded by Stagecoach, where a ticket is not purchased on the service e.g. return tickets, season tickets and where the ticket was bought for a journey initiating on another service.

- **Discussion at this meeting:**

Stagecoach appear to want the withdrawal of the services, citing that they are not financially viable.

It was suggested that SPT could be asked to re-evaluate the services which they subsidise in recognition that the pandemic has brought about changes in service usage. There may now be different priorities for subsidies.

All agreed about the severe impact that the withdrawal of the services would have on the community. It was suggested that North Ayrshire Council need to be made aware of just how devastating this would be for the Garnock Valley.

Any solution should hopefully be one in which the Garnock Valley are not dependent on the whim of a single private company for critical services.

It was suggested that the Garnock Valley could jointly request a meeting with Stagecoach and SPT.

North Ayrshire Council will be writing to the Cabinet Secretary for Transport and SPT to condemn Stagecoach's proposals.

At the Moving Around workgroup, part of the Locality Planning Partnership, the possibility of South Ayrshire Community Transport potentially being willing to operate in the Garnock Valley was raised. Given the recent change in regulations, allowing Local Authorities greater regulatory control over bus services, this may be a feasible solution.

The NAC Locality Officer stated that if there were a group of people who were willing to establish community transport in the Garnock Valley, then there was “certainly money available to do it”.

The consensus at the meeting was that Dalry Community Council should write to the all parties, supporting what Beith District have put across, while emphasising the significant impact which this will have on Dalry. Our MSP should be asked to obtain the details of the “basic service” to be introduced on 17th July by Stagecoach.

Once Beith & District CC have had a debrief on their meeting etc., they will arrange a joint meeting of the GV Community Councils to consider how to take the issue forward.

Dalry Community Council should consider holding a special meeting to obtain the views of the residents of Dalry on this issue, gather more detail of the specific impacts which it will have.

Once this has been done, the three Garnock Valley Community Council’s should work together on a resolution for the entire Valley.

Site To North East Of Big Barkip Farm, widening of existing vehicular access at junction of public road and forest track .

Approved subject to conditions regarding visibility splays, road finishing materials and positioning of gate at access point.

Site To North Of New Acre, Highfield, erection of detached dwelling house.

Approved subject to conditions:

Final details of the build (external finishing, zero carbon technologies, boundary treatments etc.) to be submitted to NAC Planning for their written approval before construction commences.

Site To East Of 1 Kirkland Crescent for the erection of 3 single storey terraced houses to include associated garden ground, parking and boundary treatments - **approved subject to conditions.**

Details of boundary enclosures to be agreed in writing to NAC Planning before the commencement of build.

Ref No 22/00390/TN - Site to South of 1 Roche Way, Dalry. Installation of 5G telecommunications apparatus comprising the erection of a 15m high street pole, the siting of ancillary cabinets and associated works - **refused.**

Applications for developments such as this qualify as 'General Permitted Development' but do need confirmation from planning that 'Prior Approval' isn't required.

In this instance NAC planning decided that prior approval was necessary so that siting and design impacts could be considered.

They concluded that:

The siting of a 15m high telecommunications pole would be inappropriate at this prominent site in the centre of Dalry.

It would cause an adverse townscape and visual impact near a conservation area.

Visual impact would be harmful to the character, amenity and appearance of the established residential area around the site

7. Correspondence

A letter (email) was received from Alastair Adamson relating to works being carried out at East Kirkland, where the roads were not left in an acceptable condition after the works were completed.

8. A.O.C.B

- A drop-in consultation by Systra on non-vehicular use of roads is being held in Rosearden on 28th June 2022 at 6:00p.m.
- Hamish Harkness highlighted a number of issues, which had been raised, and which were not considered to have been resolved:
 - Actions required for the de-trunking of the A737 prior to NAC taking ownership of the road
 - Drainage issues which were supposed to be repaired, have not been repaired.
 - Public Park flooding and associated sewage problems.

The drainage issue does not appear to be resolved, and is impacting on St Palladius Terrace.

The concern is over the raw sewage alongside the Rye Water.

Times and dates of incidents have been recorded, and will be made available.
 - The cycle route between Dalry and Kilbirnie. There are no updates issued through the Community Council.
 - Community benefit from renewable energy.

The hosts, Dalry community, should receive onshore windfarm development updates.
