Church of Scotland Small Grants Fund

Church of Scotland churches and groups of churches can apply for funding to support local communities through the upcoming winter cost-of-living crisis.

Energy Saving Trust – Energy Redress Scheme

Energy Redress Scheme Opens for Main and Small Grants

Funding to support energy consumers in vulnerable situations across Great Britain.

Energy Saving Trust has launched the next phase of its Energy Redress Scheme, offering £22 million across four streams.

The Main Grants and Small Projects streams are open to registered charities in England, Scotland and Wales that are registered with the Energy Redress Scheme and have passed the due diligence process.

Examples of the kind of activities that can be funded through the Energy Redress Scheme include:

- Engaging vulnerable customers with energy issues and referring them for support.
- Delivering energy advice that does not duplicate existing advice services.
- Installation of energy saving or renewable energy measures that cannot be funded elsewhere and/or are innovative or are being used in innovative ways.
- In-home safety advice and measures related to energy systems.
- Training and education on energy that is targeted at supporting vulnerable customers.

Grants are offered as follows:

- Small Project Fund grants of between £20,000 and £49,999.
- Main Project Fund grants of between £50,000 and £2 million.

Grants can be used for capital or revenue funding and can provide up to 100% of the project cost. Projects lasting up to two years can be funded.

Energy Saving Trust - Carbon Emissions Reduction and Innovation FundFunding to empower householders to engage positively with the transition to net zero and for the development of innovative products and services related to energy.

Energy Saving Trust has launched the next round of its Carbon Reduction Fund and Innovation Fund to benefit domestic energy consumers in Great Britain.

Applications are accepted from registered charities, Community Interest Companies, Community Benefit Societies and Cooperative Societies in England, Scotland and Wales that are registered with the Energy Redress Scheme and have passed the due diligence process.

The Carbon Emissions Reduction funding is for projects that:

- Can demonstrate measurable and lasting reductions in the carbon intensity of energy end use and accelerate the transition to net zero carbon dioxide emissions.
- Have a realistic prospect of delivering broadly replicable benefits to existing and/or future energy consumers.

The Innovation funding is for projects that:

- Support development of innovative energy products or services to benefit households.
- Help to reduce the environmental impact of energy use (or have minimal negative impact where the scheme is delivering significant social benefit).
- Are efficiently managed and provide value for money.

Both funds offer grants of £50,000 to £1 million for projects lasting up to two years.

 - Single parent households
 - Women and girls
- **Panel B's** Fund offer grants of between £5,000 and £25,000 to charities and community groups with a turnover of less than £200,000. The funding has a specific focus on supporting:
 - Young people
 - o Black, Asian and Minority Ethnic (BAME) communities
 - Single parent households
 - People with disabilities
 - Asylum seekers and those with NRPF

There are no restrictions on how the funding can be used as long as the grants focus on financial hardship and are in response to the current cost of living crisis.

Organisations can propose what they would like to do with the funding.

Only Panel A funding can be used to make cash grant to individuals, provided there is a robust system in place.

OVO Energy Fund

The OVO Energy Fund is a fund that helps people who've fallen behind with their energy payments to OVO. To qualify, individuals need to be in receipt of one of the following: Income Support, Job Seekers Allowance, Pension Credit, Employment and Support Allowance, or Universal Credit (but only if not working). In addition to qualify the energy debt on the energy account needs to be at least £150 and the annual household income is £16,190 or less.

Stop Hunger is a worldwide Sodexo initiative active in more than 40 countries. Through the initiative, the Sodexo Foundation donate time, skills and money to *tackle hunger*, support good nutrition and promote life skills in local communities.

In the UK and Ireland the Stop Hunger Foundation is a grant giving organisation and its vision is to work with very best charities that exist to tackle hunger and malnutrition; promote healthy lifestyles; and develop life skills such as cooking.

Previous grant awards have ranged between £1,500 and £120,000, however first time applicants can only apply for a maximum of £10,000. Organisations that have previously received funding include Fare Share who redistributes surplus food destined for landfill to local charities and community groups across the UK and Focus Ireland who support homeless people in Dublin by providing hot nutritious meals.

The National Lottery Community Fund Cost of Living Support Scotland Fund Voluntary and community organisations across Scotland can apply for funding to support vulnerable individuals, families, and those disproportionately affected by the cost of living crisis.

The National Lottery Community Fund is offering grants of between £10,001 and £75,000 for voluntary and community organisations across Scotland to support individuals, families, and communities currently experiencing hardship due to the cost of living crisis.

The Cost of Living Support Scotland Fund aims to prevent and reduce the impact of financial security by enabling groups to deliver new or improve existing projects and activities that:

- Support individuals, families, and/or communities currently experiencing hardship because of cost-of-living increases.
- Increase access to services and support for people facing financial hardship.

Groups must demonstrate that their proposed activities are:

- People-led: Meaningfully involving the people the organisation is working within the development, design, and delivery of activities.
- Strength-based: Making the most of, and building on, the skills and experiences of people and assets within communities.
- Connected: Having a good understanding of what others are doing locally, developing good working relationships, and complementing and adding value to other relevant activities in the area.
- Preference will be given to smaller groups who are working with those most vulnerable and disproportionately affected by the cost-of-living crisis.

Funding can be used for costs associated with project delivery, such as staff salaries, training, volunteer expenses, equipment, premise, and overhead costs.

Applications can be submitted at any time between early October 2022 and early 2023.

The Scottish Government - Scottish Veterans Fund

Not-for-profit organisations across Scotland can apply for funding for projects that provide new or innovative approaches to improving the lives of veterans and their families, *including projects that address the cost-of-living crisis.*

The Scottish Government is offering grants of up to £50,000 per year (up to three years) to support innovative projects that help veterans overcome any disadvantage

experienced because of service, achieve a successful transition to civilian life and make Scotland the most attractive place to be for those leaving the services.

Through the Scottish Veterans Fund, a total of £500,000 is available during the 2023/24 funding round for projects and activities that achieve one or more of the following aims:

- Supporting access for veterans and their families to health and social care; housing; employment, skills, and education; financial advice; or any other services provided by the public or third sector; as well as those going through the justice system.
- Supporting veterans and their families in their meaningful inclusion in civilian life, including promoting positive health and well-being and aiding social integration, with an emphasis on inclusion amongst civilian/non-military communities.
- Supporting the successful transition to civilian life following service for the service person and their family.
- Raising awareness of veterans and their families amongst the general public, emphasising their positive contribution to society and local communities.

Priority will be given to projects that include support to early service leavers or address some of the issues that this cohort may be particularly likely to face in the transition back to civilian life, as well as projects which offer support to veterans suffering from the impact of the current cost crisis, for example through financial advice or support into employment. Projects that support the wider family needs of veterans' spouses, partners, and families will also be considered.

The deadline for applications to the Fund is midnight on 19 November 2022 (11:59).

Through the Bank of Scotland's Reach Programme, funding will support vulnerable people and provide the opportunity to make positive, sustainable changes to their lives.

Funding will support activities that address the following themes:

- Disadvantage addressing primary disadvantages such as homelessness, abuse, mental health or poverty, or secondary disadvantages such as debt issues, learning disabilities, illiteracy, lack of employability skills or health issues.
- Social exclusion addressing exclusionary challenges for minorities, people with disabilities, LGBT people, drug users, institutional care leavers, the elderly or the young.

Charities registered in Scotland with an annual income of less than £1 million can apply.

Bank of Scotland Foundation

Co-op Community Fridge Fund

Funding to support community initiatives which minimise food waste across the UK.

A partnership between Hubbub and the Co-operative, the Community Fridge programme has reopened for autumn 2022 applications.

The fund is open to UK not-for-profit groups with their own bank account, providing they:

- Are setting up a **new** Community Fridge which has not yet opened.
- Establish the Community Fridge within six months and have intentions to sustain the project for at least three years.

Priorities include:

- Supporting applications in regions with a sparsity of Community Fridges (a map can be found on the Hubbub Foundation website).
- Supporting groups in areas with high levels of multiple deprivation.
- Ensuring a fair and inclusive application process with equal opportunities for everyone, regardless of background, culture or race.

Each successful applicant will receive £3,000 to cover the initial costs of setting up the fridge, and a further £1,000 one year after opening.

Community Fridges | Hubbub Foundation

Hubbub - Community Fridge Food Hub Fund

Funding for Community Fridges to increase their social and environmental impact.

As part of its partnership with the Co-op, Starbucks Foundation and Rothschild Foundation, Hubbub will be launching a new Community Fridge Food Hub Fund to expand community-based food activity provision.

Constituted non-profit organisations in the UK can apply for the funding providing they:

- Are operating a Community Fridge which is currently open to the public.
- Are registered members of the Community Fridge Network.

50 grants of £6,000 will be available to cover activities which fall into at least one of the following categories:

- Skills providing access to training and knowledge-building activities.
- Affordable food supporting collaborative purchasing and/or local food retail.
- Community Connection providing opportunities for communities to come together around food.
- Growing increasing the amount of food grown locally.
