Largs Town Charitable Trust Criteria - In terms of the trust deed there are 3 purposes for which assistance may be given:

Purpose A - the prevention or relief of poverty;

Purpose B - the provision of recreational facilities or the organisation of recreational activities with the object of improving the conditions of life for the persons for whom the facilities or activities are primarily intended; and

Purpose C - the relief of those in need by reason of age, ill health, disability, financial hardship or other disadvantage.

Connected Communities, Finance and Legal Services have been consulted and their comments are as follows:

Finance: Quotes have been provided for the sashes, banners & napkins and the Kandy Bar cake, confirming the total requested, no other quotes have been provided. No current bank statement has been provided, to confirm the organisation have the funds to meet their commitment of £1,414.43.

Legal: The funds in the Kilwinning Town Fund are primarily held for Purpose A, with a small amount held for Purpose C. This application perhaps best fits Purpose B, as the main intention is to organise recreational activities with the object of improving the conditions of life for the persons for whom the activities are primarily intended, in this case the over 60s. However, the activities may also meet Purpose C by providing relief to those in need by reason of age. In particular, the activities are intended to provide opportunities for the over 60s, many of whom live alone, to socialise and help reduce isolation.

The application can therefore be granted as it meets one or more of the Trust Purposes. As some funds are held for Purpose C it may be best to consider the application under that Purpose as it does appear to meet the criteria for this. Alternatively, the grant could also be made under Purpose B, if there is a surplus of funds held for Purposes A and C due to insufficient eligible applications meeting those purposes to exhaust the annual total amount available.

In addition, the Trustees should also be satisfied that granting the application will be a beneficial use of the trust funds. In particular, they should be satisfied that the grant will provide a benefit to the whole community. In this connection, the Trustees may wish to consider the proposed use of the grant funds, which are primarily to provide a memento of the occasion, and the information on membership, which is open to all over 60s regardless of financial need.

Connected Communities: St Winnin's Over 60's group is seeking funding towards their 30-year anniversary event. The application meets the criteria of Trust Purpose B, which will improve the recreational activities for the elderly community of Kilwinning and improve their condition of life through reducing isolation and loneliness and improving their health and wellbeing.

Subject: Youth Forums and Citizenship and Partnership work

Purpose: This report is to inform the Kilwinning Locality Partnership about Youth Forum, Youth Citizenship/Partnership activity, planned and actual for the Kilwinning Area.

Background

The Kilwinning Youth Forum strive to benefit the lives of young people in the Kilwinning area. We aim to achieve this by involving young people in Kilwinning in the decision-making process and giving them a voice.

The Youth Forum has seen an increase in its numbers, with 11 young people registered and actively attending.

The group has recently held its AGM and now have a fully functioning committee consisting of a Chair, Vice Chair, Secretary, Treasurer, Minute Taker and 6 Committee Members.

The group recently applied for and were successfully shortlisted to the voting stage for this years Youth PB. They have applied for the full £1000 to carry out a project in partnership with Eglinton Country Park. The Project is an idea the young people imagined themselves to try and destigmatise poor mental health within the park. Instead, they wish to inject positivity by creating wooden plaques of different shapes and sizes, which fit in with the aesthetics of the natural surroundings and place them around popular walk paths, on benches etc. These plaques will be highlighting positive affirmations, jokes, positive words.

The young people are supporting the Christmas light switch on again this year. 3 young people are dressing up as elves and helping in Santa's Grotto, while the rest of the group will be offering free facepainting to families.

Kilwinning Youth Forum took part in National Youth Work Week this month. They teamed up with our communications department to share with social media what being part of a youth forum looks like, how it has he helped them and share what they are able to achieve as an active platform for youth voice and participation.

The group have strategised in future projects and events and would like to deliver a wide range of opportunities and support. Examples include, care packages for residents in hospital and assisted living, organise and deliver a community litter pick, particularly in Eglinton Country Park and surroundings areas and organise some community Fun days.

The future of the new committee is looking positive and the group are eager to support as many community lead projects as possible. Watch this space.

The Locality Network meeting took place on 17 November. We had a presentation on 'The Promise' and an update from Bridge Church on their Heat Hub. The workshop will be looking at what winter warmers/heat hubs we are aware of in the locality and possible projects that could be done with the resources we have.

Continuing to support Kilwinning Community Council.

The draft Kilwinning Place Framework is being prepared by the appointed consultant (Austin:Smith-Lord) and is due to be issued to the Council by 18 November 2022. The Place Framework will comprise a Main Report and Action Plan. The Action Plan will contain short, medium and long-term projects that have been identified during the process.

The Kilwinning Place Framework is supported by capital funding from the Place Based Investment Programme (£90,000 comprising of £20,000 from 21/22 and £70,000 from 22/23). This fund will provide a community grant that will be spent in accordance with the recommendations from the Action Plans on a range of projects and initiatives in the town. The Place Frameworks Project Team will carry out an exercise to determine which groups to contact in relation to the grant once the Action Plan is finalised.

Kilwinning Bowling Club now have all funds in place for their ladies/junior locker/changing area. This will now be a building rather than portacabin. Work is due to start on the build at the end of 2022 early 2023.

The new Primary 7 transition group at St Matthews Academy started on Tuesday 1 November. There are almost 70 young people registered. This year's group consists of St John's, St Anthony's, St Luke's and St Winning's. The group will be part of the Find your Feet Programme before Christmas break and work towards the Hi5 Award.

The Kilwinning Primary 7 Transition Group started on Monday 7 November. There are over 80 young people registered. This year's group consists of Corsehill, Abbey, Pennyburn, Blacklands and Whitehurst Primary Schools. They will also do the Find your feet Programme before the Christmas break and work toward the Hi5 award.

Arranging support for Cranberry Moss Larder and Café during heat hub hours. Community Leadership Collective Calendar is still active and has been refreshed for 2022. The team are looking at revamping the training menu and are also looking into retrieving a pattern for Canny Cookers, to then deliver sessions on how to make them within the Heat Hubs.

This originally started off as 1:1 support and is now open to the public to come in with any device issues. Anyone looking for advanced support will be directed to the Community Leadership Collective for training/learning. This has been slow on the uptake however, there have been three new participants in the last week.

Update

Me & My Mental Health Weekly Support Group for the residents of Kilwinning. The group is about exploring mental health and wellbeing in a safe, relaxed place. Looking at coping strategies for anxiety, overthinking and stress.

Stroll With It Kilwinning resumed week beginning 5 September and has now finished for the winter. It will restart around March 2023. They have also been doing a bit of partnership work with Ice-cream Architecture. We Teamed up with walkers to explore the new "know the place" App which is available. The App highlights walking routes available in North Ayrshire, particularly Kilwinning, as well as the new information point sculptures situated in the town.

Detached Youth Work restarted week beginning 5 September in partnership with Police Scotland. The number of engagements has dropped from what they were previously, however this is to be expected due to it being the winter months. One night per month Pryde is being utilised to hold a session, again numbers haven't been great at this.

Community Wellbeing

ASN Groups continue to run well with numbers growing and referrals continuing to come in.

System changers - The six-month Programme has finished and they are now meeting independently as a group to explore how the dynamic of the group will form for future practice. The focus at meetings just now is Mental Health. Have we made any changes to make our lives easier or to make someone else's easier.

Community Chit Chats will take place from January 23.

Kilwinning Elderly Forum have decided that they would like to continue as an elderly group as opposed to a forum. A committee has now been elected and support is being given to the former chair and current treasurer to change hands of accounts. A visit from Citizen's advice has been organised to inform the group of the benefits and grants available to support through the cost-of-living crisis and soaring energy bills. The fraud team from No are also visiting to inform the group on how to protect themselves against scams and cold callers etc.

The Kilwinning Youth Forum have formed their new committee and are being supported by staff. They have been successful in reaching the voting stage in youth might for their Eglinton Country Park Mental Wellbeing

Project. They are also supporting this year's Christmas Lights by supporting Santa's Grotto and providing free facepainting.

Friends of North Ayrshire Group continues to run and is going well. The group carry out one hour literacy support out of the 2-hour time slot and the rest will be spent doing activities such as; cooking, music lessons, photography, walks, picnics, IT skills etc.

Winter Warmers are being set up across the community. Venues include Cranberry Moss, Woodwynd Community Centre, Bridge Church and PRYDE. Support has been provided by North Ayrshire Council for these. If you would like further info on the days/times, please let me know and I can provide this.

Mental Health and Wellbeing Community Mapping- a list of sources of support and signposting opportunities has been collected and condensed into a live document for each locality in North Ayrshire

Your Resilience- this is mental health and wellbeing and employability blended programme. Working in partnership with Ayrshire College Hive Department to put young people through the eight week workshop of Your Resilience by Mental Health UK.

Take Time Families – Corsehill Primary: The programme addresses Mental Health within families addressing targeted parent/carers and young people to achieve a joined understanding of resilience and emotions in the home.

The Ayrshire Community Trust continues to support the Community and Voluntary Sector with a range of services. Below is a list of support / activities since the last Locality Meeting:

- Virtual Reality Taster Sessions TACT Digital have been delivering taster sessions to a wide range of organisations and groups including: Autism Support Ayrshire, YES (Your Entire Self), CAMEO Group (LinkUp Saltcoats), SENSE Scotland.
