Community Representatives who noted their interest in the role of Vice Chair were asked 'Outline your current/previous experience you have within your community that will help you take on the role of Vice Chair of the Three Towns Locality Partnership?'

Noted below is the response from each of the Community Representatives who noted their interest:

1 - Julia Gray

I held the position of Chairperson at the Ardrossan Whitlees Community Association from 2014 until 2020, previous to this I was a volunteer and still on the committee today. We are going from strength to strength with the centre and providing events, warm hubs, and our larder for the community. With the world changing so often we communicate with the public on what they need help with or how they think the centre can best support the community. I am also a Director of the Ardrossan Development Trust, I work closely with the community with both of these organisations.

I help support local groups and Community Centres who may need help and advice on funding available them and how best to maximise their group/centre.

I am fair, honest, and confident and feel this has helped build my relationships with the community and partners. If there is anything I am unsure of, I am not shy to ask for help and guidance.

2 - Scott Mould

I've played an active role in Ardrossan since 2005 and involved with several community groups, recently playing an integral role as Trustee and 'Director of Gym' raising funds and setting up Ardrossan Community Sports Hub (ACSH), a new charitable gym which opened in the grounds of Seafield School. With 400+ members it serves as a major community asset being the only deliverer of sports within Ardrossan. I am also Chair of the Ardrossan Community Development Trust (ACDT) and have been since incorporation which followed a community engagement exercise - ACDT is now a registered charity with a mission to develop Ardrossan making it a better place to live, work, volunteer, and visit and reinstating civic pride in this amazing Town. ACDT have raised over £1.1 million to develop South Beach via CAT and will introduce a hub, café, crazy golf, toilets, free deckchairs, disability wheelers and retail beach huts as well as extend the existing playpark with inclusive play items. Having a wealth of knowledge in community engagement and partnership working I also hold the position of Head of Social & Economic Development with Cunninghame Housing Association and have wider aspirations to encourage better partnership delivery and working for the Three Towns.

3 - Ian Winton

I was elected to Stevenston Community Council as a Councillor in 2018. I also held the posts of Secretary and Treasurer until I was elected Chair in 2019, and I have continued in this post until present.

During my tenure the following improvement were made to the Town Centre. The three flower beds in New Street were partially dug out to dispose of what had been allowed to grow wild over a number of years. New soil was added and topped with pea gravel. Various flowers and shrubs were then added enhancing this area. The library beds front, and back were similarly treated raising the ambience of the whole area from the dismal depressing sight to one of relaxing pleasure for the public in an area of poverty and high unemployment.

The circular area at the cross and the Champion Shell car park were also weeded, dug over and brightly coloured flowers planted creating a space where people sit down and relax.



2. Brief description of your organisation

Ardrossan Scout Group has been in existence for over 100 years.

It is a registered charity. It is an autonomous organisation holding its own property and equipment. It is subject to the policies of the Scout Association, including Equal Opportunities Policy and Health and Safety Policy.

The aim of Scouting is to actively engage young people in their personal development, empowering them to make a positive contribution to society. We also offer personal development opportunities to young and older adults through volunteering as leaders, assistants and trustees.



The objectives are for young people and adults to work together, based on the values of scouting and :-

- Enjoy what they are doing and have fun
- Take part in activities indoors and outdoors
- Learn by doing
- Share in spiritual reflection
- Take responsibility and make choices
- Undertake new and challenging activities
- Make and live by their promise

They take part in activities such as nature studies, creative arts, cooking ,games, camping, first aid, outdoor activities and survival skills, all of which give them skills for life and include personal development such as teamwork, leadership, communication, and time management.

The Scout Group comprises 4 age group sections:-

- Beavers 6-8 years
- Cubs 8-10 years
- Scouts 10.5 -14 years
- Three Towns Explorers Unit 14 to 18 years

Currently we have 70 young people and support a voluntary adult leadership of 13 and 11 committee members.

As well as the various sections of the Scout Group using our premises at Kilmeny Terrace, Ardrossan, our premises are also open to community groups to let. Currently the following groups are using the premises to meet in and to store equipment:-

- Table Tennis Club
- Akaido Club
- Mother and Toddler Group
- Drum4UrLife Group
- Canoe Club
- Woodland Wake Up
- Attainment Training
- RamH College

This amounts to approximately another 60 users.

ARDROSSAN SCOUT HUT REFURBISHMENT

The Scout Hut was built in 1967. We have to refurbish it to bring it up to modern day building standards, make it fit for purpose and more importantly sustainable with reduced running costs and maintenance. The fabric of the building is now failing and beyond designed lifespan. The most pressing requirements are:-

Remove the roof, including removal of asbestos, and replace with an insulated alternative

Remove all ceiling panels

Install an effective and efficient heating system

Reconfigure the internal layout to make a more flexible and usable space.

The roof is in poor condition, has been extensively patched and is progressively leaking. It has reached the end of its lifespan and to make the building sustainable for the future requires to be replaced.

The replacement of the roof would then allow us to upgrade the heating system, which is currently in the form of electric heaters suspended from the ceilings. These are inefficient and costly to run.

An energy efficiency assessment has been completed by Business Energy Scotland, which includes financial savings and reduction in carbon emissions which would result from replacing the roof.

We already have planning permission and have engaged an architect and a quantity surveyor. The plans have been drawn up in such a way that the refurbishment can be done on a phased basis, as and when funding allows.



As well as the current users, the target audience is new users. We recognise that the Scout Hut has not been fully utilised in the past and we want to open it up further to community use and make it a local community centre, particularly as there is no community centre in this part of Ardrossan.

Community groups and Scout groups will benefit from it, along with individual users who may wish to let the premises. They will benefit from a modern facility, which is comfortable and warm. We believe that we can offer affordable lets for a range of groups. It can also be open to individual lets for events. We believe there is a demand for a modern, well appointed and affordable community facility in this area.

We have been liaising closely with Ardrossan Community Development Trust, who have plans in place for development of the South Beach area of Ardrossan to regenerate it and to bring more community use into that area and we consider that our plans would complement theirs. We have also been liaising with Ardrossan Community Sports Hub regarding possible joint activities and with North Ayrshire Council's community development officers.

Increasing Civic Pride and Community Engagement - Will fit with the plans to regenerate this area of Ardrossan. Will give the community a facility that can be widely used and open to all.

Improving Community Wellbeing - Will allow more community activities to be held in this area of Ardrossan.



5. What engagement has taken place in relation to the project?

A consultation was undertaken some years ago with members of the Scout Group, their parents, other users of the premises, community associations and children from local schools. They were asked about the current provision of facilities, their views of Scouting and what changes needed to be made going forward. In relation to the building itself, the most common concern was that, although well loved, it was not fit for purpose and should be upgraded. They considered that there was a need to upgrade the facilities to create a safe and comfortable environment in which to work and learn.

It also took account of a piece of research compiled by Community Education in 2014 involving 103 teenagers, which examined gaps in community provision in the area. Scouting was seen by them as closely linked to the outdoors and associated with adventure. 94% of the teenagers said they would like to take part in an adventurous activity. 79% said they would like to do some sort of outdoor activity.

The number of people engaged with across the more recent forms of consultation amounts to over 100.

A face to face consultation was held at our Christmas Fayre in November 2022, which was open to any member of the public. The results showed that 100% agreed that the Scout Hut was in need of refurbishment. 75% thought that their community group would use it. Of the remainder, some were not a member of a community group. Some were involved in groups in their local church. Members of St Peter's Church and of Park Church in Ardrossan have indicated that their lets are at capacity, so we believe that there would be an overspill demand to use our premises. 80% said that they as an individual would be interested in using it for a family event.

A number of adults who were former members of the Scout Group commented that the Scout Hut had not changed since their day.

A consultation was also held recently with user groups. Comments included:-

- "How cold it is."
- "Heating is not great, Sessions would be more relaxed and enjoyable with improved heating".



- "Improve the heating."
- "Toilets are a bit iffy".
- "The fabric of the building is rather tired. Any improvements would be welcome".
- "Disabled access portable ramps are ok, but better access would be a bonus, both internally and externally. Improved access would allow us to widen the attraction of our drum circles".

Things that user groups like about the building include the location and the size of the rooms. As well as having two large halls, meeting rooms, a kitchen and ample storage space, the Scout Hut is on a main bus route, close to two railway stations and has ample parking making it ideal for community use.

A further consultation was held online in February 2023. The responses came from Scout Group members, Adult Not for Profit Community Groups, Small Businesses, Other Groups and Local Residents with the majority of responses, 55% coming from those who classified themselves as local residents and the remainder split across the other categories. 85% responded that they would be interested in using the scout community hub if it was value for money and comfortably refurbished. Over 40% indicated that there would be up to 30 participants using the premises. Almost 40% indicated they would wish to use the entire facility. In terms of features which would be necessary for them as a group or individual, the top feature required by 78% of respondents was "warm and comfortable". This fits in with our priority in the phasing of the works, which is to replace the roof and insulate it in order to minimise heat loss.

FINANCES

Our aims and objectives are to advance the emotional and physical wellbeing of the inhabitants of Saltcoats through the provision and regeneration of such facilities which enable this

We have recently successfully completed the upgrade and regeneration of the local playpark and secured the total funding package of over £100,000. This has led to a safe space for the provision and development of play for the children and young people of the town.

Our recent survey analysis has concluded that the installation of CCTV would create a greater sense of community safety and lead to increase use of the park.

The project will be delivered in partnership with NAC and the SALT group. Once the camera is in place NAC will add this to their existing network and monitor the area.

Connected Communities, Finance, and Legal Services have been consulted and their comments are as follows:

Finance:

Only one quote has been provided, Finance would recommend three to ensure value for money is achieved. The accounts show that funds are held for maintenance which has an adequate balance to fund the cost of this refurbishment.

Legal:

It is my opinion that this application could be justified from a legal perspective that the grant application meets the criteria in terms of s15(4) of the Local Government (Scotland) Act 1994.

Usage of churches over the years has evolved to become more multipurpose rather than solely serving the congregation/parishioners, and the groups that currently use the hall cover a wide demographic of varying age groups. The church is open 7 days a week from morning until evening and is generally open to the public.

If it is decided to grant the application, the benefit to the community, as a whole, should be clearly minuted in case the auditor requires this information in future. The trustees ultimately have discretion as to whether Common good funds should be awarded to the applicant, however from a legal perspective I think the awarding of funds could be justified in terms of the Act.

Connected Communities:

The funding requested is to refurbish the disabled toilet which is located within St Peter in Chains Church Hall.

The Church Hall is accessible to the whole community and provides a safe, accessible and affordable venue to help improve the quality of life and social cohesion within the community. It is used by a wide range of community groups as well as for private funerals, weddings, christening teas, birthday and Christmas parties and Burns Suppers. The Hall staff, volunteers and beneficiaries are embedded within the local community and, consequently, well placed to bring positive change and be highly responsive to local needs.

Connected Communities are satisfied that this project meets the criteria of the Common Good Fund.

Subject: Memorial benches, plaques, memorial trees and other options for bereaved families

Purpose: To note the proposed options in terms of memorials and to provide feedback on this.

Background

North Ayrshire Council has a longstanding history of providing memorial benches and plaques to offer bereaved families the opportunity to remember their loved ones in a lasting and meaningful way. Over time, the large accumulation of benches and plaques, challenges with suitable locations, maintenance, and sensitivities of removing tributes, led to the temporary suspension of the service and the investigation of alternative approaches.

North Ayrshire Council recognises and acknowledges the desire of many members of the public to remember loved ones with a memorial in the surroundings with which they were familiar. These requests are agreed and accommodated wherever possible, but any decision must recognise the needs of the wider public. The Council will therefore ensure that the memorial process is managed and implemented for the mutual benefit of all. This can also be to the benefit of the community if the memorial enhances or makes the location more attractive by helping to maintain the character of the area. The principles will ensure that requests for memorials are responded to in a consistent, efficient and sympathetic manner.

The objectives of a memorial offer are to ensure that:

- Unique remembrance spaces for local people are provided to celebrate and mark the lives of loved ones;
- The memorial offer and service is clear and easily understood;
- The response to contrasting needs is balanced and appropriate;
- Quality provision is offered at an affordable price without constraints by space or deterioration in inclement weather;
- The use of public spaces is not compromised and ensure the quality of attractiveness is maintained for the use of all residents and visitors:
- Any memorial is appropriate for the location in which it is placed;
- All memorials are cost-neutral and low maintenance for the Council;

 Costs of supply and installation are affordable and are covered by the applicant of the memorial.

The following responsibilities and requirements are proposed for the Memorials Policy. Following agreement, the Policy will be reviewed every five years:

- The location and types of memorials for individuals will be agreed with applicants.
- Priority will be given to applicants that are resident In North Ayrshire or have a direct connection with the area. Other applications will be considered on a case by case basis;
- Memorials should have some community benefit either as street furniture or by enhancing the appearance of the local area;
- The cost of supply and installation of any memorial will be covered by the applicant and paid for prior to installation;
- The responsibility for the maintenance of any memorial is clearly defined and communicated prior to installation;
- The Council will accept no responsibility if a memorial is damaged, vandalised or stolen;
- In the event of damage by accident, vandalism or it becomes unsafe and beyond economical repair, the Council reserves the right to remove and not replace the memorial;
- Once installed the memorial can only be repositioned with the agreement of the Council;
- Any plaques or wording must be a suitable size, colour and type face and agreed with the Council in advance;
- Once installed the memorial will become the property of the Council and any routine maintenance costs will be covered by the Council.
- Any plaques will remain the property of the applicant and must be maintained in good condition;
- No additional structures or mementoes e.g. fencing, wreaths, flowers, can be placed on or at the memorial at any time.

Note: Unauthorised memorials may be removed by the Council taking account of the sensitivities around this.

Options

Memorial Benches and Plaques

The existing memorial option of procuring a memorial bench and/or attaching plaques to benches is nearing saturation point in some areas and it is proving difficult to support the wishes of individuals in specific locations.

To provide this service in the future, consideration must also be given to the length of time a memorial stays in place and to consider potentially bringing assets back into circulation after a period of time.

Alternatively, the option to purchase a bench with a prefabricated memorial could remain. However, the asset would be placed in a location identified by the Council and agreed with the applicant, such as parks and open spaces rather than the already congested coastal areas.

North Ayrshire Council will be responsible for all installation work. If the bench is to be placed on grass it will usually be fitted to a concrete base. Memorial plaques will require to be made of brass, stainless steel or aluminium and will be a maximum agreed size. Any inscription on plaques will require approval by the Council prior to fitting. The engraved plaque will be fitted to the bench by the Council.

It is proposed that this would be cost neutral to the Council with actual costs paid by those requesting the bench and/or plaque. It should be acknowledged that the costs of a memorial bench could be significant as the bench will be placed in a public space and will need to be durable, hard wearing and be of a higher specification than a typical bench used in someone's garden.

Living Memorial Tree

Dedicating a tree provides a living, growing memorial to a loved one and a poignant way of remembering them.

The Woodland Trust offer this facility across the UK and can range from individual trees to whole areas of woodland and it is proposed that North Ayrshire consider a similar initiative.

This would not only provide a remembrance to a loved one but also contribute to the global climate challenge. This would also complement the Councils tree planting strategy and areas of woodland/open space could be set aside for memorial trees.

Metallic memorial trees

Metallic memorial trees positioned in high amenity areas would offer a unique opportunity to remember family members and loved ones.

Metallic memorial trees are able to provide up to 640 memorial leafs in one location, creating a focal point for visitors and a single point of focus for families. The assets could become an attraction to visitors, require little to no maintenance, have a reduced impact on resources and would be cost-neutral.

Officers have identified an opportunity to promote this as a memorial offering. Once installed, the tree then has anodised gold-effect aluminium 'leaves', engraved with a loved ones' details, affixed securely to its branches over time. Leaves would be attached by Streetscene maintenance operatives. Similar trees have been installed successfully in other locations including across the UK and internationally.

The tree is manufactured from laser cut steel, stands at 3.2m in height, and has 640 spaces for memorial leaves. The tree is fixed to the ground with a two-part concrete foundation. The materials and manufacturing process are designed to withstand all weather conditions including exposed locations. Having purchased a memorial leaf, people can arrange the engraving of names, dates of birth and death with the possibility of a personalised message on the reverse and return it to be attached to the memorial tree. The tree memorial acts as a striking piece of public art, large enough that most leaves remain out of reach but still providing legibility of the messages engraved.

As with any public realm asset, the risks from anti-social behaviour must be considered. If this is an offering that is considered, then potential locations for this will be discussed further as appropriate. The tree is exceptionally robust, and the leaves themselves are securely fixed to the tree with pop rivets.

It is estimated that the cost of implementing this initiative could be cost neutral over a 5-7 year period.

Memorial Rocks

Memorial rocks and stones offer a simple natural way to remember loved ones. Rocks can be placed on a beach or thrown into the sea, potentially being washed up for others to find. They can be placed in a park or open space where loved ones enjoyed or potentially into areas specifically created to house the memorials.

Sponsoring flower bed

Sponsoring a memorial flower bed and remembering loved ones by planting some of their favourite flowers offers an appropriate memorial. Flower beds would be available in coastal locations as well as parks and open spaces.

Digital Remembrance

Not all bereaved family and friends are local and may not be able to easily visit physical memorials.

A digital page of remembrance would offer people from all over the world the chance to log in and view memorials at any time.

Key Points for Locality Partnership

It is proposed that the North Ayrshire Council memorial offer provides a range of affordable options to be eaved families and friends to assist them to celebrate a life and remember a loved one. Choice and affordability will be key with responsibilities made clear from the outset.

It is proposed that North Ayrshire Council will limit prices to the actual cost of each memorial selected. Therefore, the Council will not generate any surplus from its memorial offer.

Action Required by Locality Partnership

It is proposed that the Locality Partnership consider and provides feedback on the range of memorial options for implementation including:

- Benches and Plaques
- Living Memorial Tree
- Metallic Memorial Trees
- Floral Beds
- Memorial rocks
- Digital remembrance
- Bespoke requests on a case by case basis

Sustainable food projects in Three towns.

- All larders are running well, everyone in the three towns working together to support each other. Community cafes are all open.
- Money Matters has a worker regularly based in the Argyle Community Centre on a Wednesday running alongside the Community Larder to offer support for welfare rights and income maximisation to assist households who need it.
- Ardrossan Community Development Trust
- The Trust has just received charitable status.
- The trust employees 2 full time members of staff.
- ACDT continue to proceed with plans for their project at Ardrossan South Beach that will see a fully accessible playpark, maze, crazy golf and a community hub with a café and servicing point for the crazy golf and already in place wheeler/deckchair project.
- The tendering phase for the Playpark phase is complete and a contractor selected, the contract is not yet signed as the Trust

seek to cover a funding shortfall caused by the cost-of-living crisis which has meant an increase in material and labour. The Café and Servicing phase of the project is currently out to tender. The trust also needs to complete the CAT process before signing any contracts.

- The public notice period is complete and at present it is now with NAC and the Trust's legal representatives. The Trust require the lease to be in place before the end of the fiscal year, with time to sign contracts, this seems to be possible with the Trust recognising that NAC are doing everything within their power to achieve this timeline.
- ACDT look forward to having a community group manage the café and use the profit for further community activities and are at present agreeing terms for this.
- They intend to work with Streetscene to provide a modern apprenticeship, who will assist with maintenance of the green space and surrounding area.
- ACDT hope to have all the projects fully operational early August 2023.
- The Development Trust are also very active with other community organisations in assisting them to develop and be the best that they can be, we have been working closely with the Scouts and Men's shed in providing information and guidance that will assist both groups with having suitable premises in which to operate in.
- The Trust plan to gather all of the community groups in the town together on a regular basis and will use this as a steering group for future community planning.
- The Trust are working in partnership with NAC Active Travel Hub to put electric charging points in place at South Beach for bikes.
- The Trust also participate in the Ardrossan Connections project, they work along with other community groups with Sustrans to identify opportunities to design and implement high-quality public space and upgrades to the National Cycle Network through Ardrossan.

Ardrossan Community Sports Hub

- The Hub is a charity and employees 4 coaches on permanent contracts.
- The Sports Hub have been successful in regenerating the once defunct gym at the site on Seafield school turning it into a thriving community asset, in the last update it was stated there was 400 members, it is now closer to 500 members.

- The gym runs many classes and workshops to promote health and well-being in the community, including satellite fitness sessions throughout the area and nutrition, mental well-being workshops which have all been well attended. During the Summer they will provide community workshop and fitness events at the Highland Games, The Winton Rovers Fete, The Whitlees Centre Fete, Park Church Fete and events held by the Ardrossan Community Development Trust to promote health and wellbeing.
- The Sports Hub have received funding from the local authority and the national lottery to help support the project and to allow the Hub to put in place Health and Fitness coaches. The gym is unique in that members can book a coach for their visit and that coach will inspire by providing 1:1 advice and fitness planning to assist the individual in meeting their goals. There is always a coach on the gym floor to support the members.
- At present the gym is providing 50 free gym places to community members who will benefit with being more active.
- The Hub plan to be actively involved in the planning and design of the sporting facilities at the new school campus. The Hub hope to be involved in the management and day to day running of these facilities, they see this as vitally important to not only their continued growth but to their gym's existence. They will not survive with competing against the school campus facilities on their doorstep. With Community Wealth and community empowerment at the heart of policy the Hub see a future partnership with the local campus as a massive part of their future.
- The hub is now a Duke of Edinburgh award centre and have currently 20 children participating in the award.
- The Sports Hub continues to develop and work towards providing the fitness and well-being infra structure within the town for all its inhabitants and with that in mind they recognised the need for additional sporting facilities in particular an AstroTurf surface that will allow the towns 17 football teams to train and play within their own town. Currently teams must travel all over north Ayrshire to find facilities and sometimes there are no facilities. A Business plan is in place and application has been made via the CIF fund for initial funding for the project with additional funding being sought from the SFA and additional funders.
- The hub has been successful with a funding application to the CIF fund and have received £100,000 towards the Astro turf project, they recognise the support of the locality planning team

- and the importance of the initial funding that will encourage others to come on board. They are at present in advance discussion with Sport Scotland and the SFA.
- The Hub have Entered into an agreement with Ardrossan Winton Rovers FC who have made a great gesture in agreeing to lease Winton Park to the charity for 25 years allowing regeneration to take place and allowing it to be used as a centre for sport within the Town and a place where many other community activities can take place. They will work with Ardrossan Winton Rovers Youth Academy in the management and use of the facility.

Whitlees Community Association.

- Additional funding has successfully been secured from The Mental Health and Wellbeing Fund to secure additional centre staffing/resources.
- An application has been submitted to get the Association SCIO status through OSCR (we are awaiting feedback)
- We are currently reviewing the centre business plan
- The fuel insecurities provision (funding allocated by NAC) is proving very popular and necessary. Activities are free at the point of entry and free food will be provided for community members. Provision includes: Family Film Nights, Bingo evenings, cooking classes (where participants keep the food they cook
- Volunteers continue to work and gain experience in the centre and the café
- The Christmas period was very busy with the Pensioners Dinner, Toy Drive, Winter Wonderland Event all very successful.
- The Duke of Edinburgh Award Programme is going well with 8 young people undertaking the accredited award
- The centre in welcoming some actional new lets including CHAP and AA
- The Whitlees Community Centre has been selected black start and resilience response structure. Staff are about to embark on the associated training for this.
- The Association's AGM will be held on 27 March 23
