3. Memorials and Plaques

The Partnership received a verbal update from the Senior Manager (Commercial Services) on the proposed range of options in terms of memorials for bereaved families including benches and plaques, living or metallic memorial trees, memorial rocks, sponsoring flower beds and digital remembrance.

The Partnership discussed: -

- practical issues around other forms of remembrance, such as padlocks on bridges and other structures;
- the successful use of 'metallic memorial trees' elsewhere, including a two-dimension style for indoor use, as adopted by Ayrshire Hospice;
- concerns regarding ensuring memorials remain free from vandalism;
- issues around a 'saturation' of memorial benches in seafront areas and the need to identify and promote other suitable locations;
- options for different styles of memorial bench;
- updating the Council website with the options once approved;
- the potential to locate a 'metallic memorial tree' in each locality, subject to demand; and
- whether the 'living memorial trees' option would relate to specific, identifiable trees, or if the expectation was that it would relate to sponsoring tree planting more generally.

The Partnership (a) expressed support for the range of memorial options contained within the report; and (b) otherwise noted the report.

4. Mental Health and Wellbeing for Young People

The Partnership received a verbal update from the Youth Participation Officer on Mental Health and Wellbeing for Young People, which linked in with the Locality Partnership's priority of Improvement Mental Wellbeing.

The update included information on: -

- mapping of mental health and wellbeing services for ages 5-25;
- a participatory budget funding bid for the creation of a mural project;
- support work with families and young people within schools;
- a youth equality programme to support LGBT+ young people;
- the recent application for LGBT Silver Charter Mark;
- the creation of a mini BeeYou Ambassador Programme within primary schools;
- work on becoming a 'My Bank' pilot to promote financial literacy;
- joint work on the 'green agenda' and climate change
- the development of the summer road show and fun days to promote positive health and wellbeing; and
- the refresh of the Mental Health Toolkit within schools.

5. Youth and Education Overview

The Community Learning Development Worker (Kilwinning) provided an update on the activities of the Youth Forum highlighting the following: -

- the decrease in member numbers since Christmas;
- Youth Forum were successful in receiving PB funding last year for a project at Eglington Country Park; and
- Youth Forum poster will now be circulated via local schools.

Fiona Smyth, Head Teacher, Abbey Primary School provided a verbal update on primary cluster school activity including: -

- Negative press on the attainment picture but has now seen a 30% increase in attainment levels;
- There has been a NAC review team within the school with the focusing on leadership of change;
- The school was approached by the BBC learning Lab, with the children sharing their favourites places around Kilwinning, link to the film - <u>BBC Scotland - The L.A.B Scotland, Then and Now:</u> Kilwinning
- Monthly learning café for 70 families at the school;
- P1 P3 going to the cinema this week and P7 are going to Arran for their residential trip;
- Created a Zen Den within the school; and
- Very supportive Parent Council and are currently funding raising through case for kids.

Tim Swan, Head Teacher, Kilwinning Academy then provided a verbal update on activity including: -

- Lead up to the SQA exams at the school starting on 24 April until 31 May;
- Normal class teaching is still going ahead as well as supported study and Easter School;
- Aiming for Sports Scotland Gold Award;
- Going for the LGBT Charter again and trying to promote this as much as possible;
- Range of Digital Ambassadors in the school;
- Parent Council have applied for PB funding; and
- Face to face Parents Evenings.

6. Police Scotland – Wellbeing and Partnerships

The Partnership received a verbal update from Police Scotland on the key impact of wellbeing and partnership work being carried out by Police Scotland in Kilwinning.

The update highlighted areas including the following: -

- recent changes in personnel;
- referrals to the Community Wellbeing Unit;
- ongoing fraud prevention work in connection with financial harm
- the Scottish Police Authority 'Police Confidence' survey work;
- the provision of community safety packs for residents;
- ongoing shadowing work with the Council's Environmental Health officers:
- involvement in the Ukrainian and Syrian Refugee programme;
- a forthcoming Jobs Fair;
- work with the Council's Trading Standards service on issues around the sale of 'vaping' products; and
- tackling graffiti.

7. Scottish Fire and Rescue Service – Wellbeing and Partnerships

The Partnership received a presentation from Craig McFie, Scottish Fire and Rescue Service on the key impact of wellbeing and partnership work being carried out by Scottish Fire and Rescue in Kilwinning.

The update highlighted a number of areas, including: -

- changing the use of the training building at the back of Kilwinning fire station into a safe space;
- health partnerships looking to use the Community Room within Kilwinning fire station;
- reducing unwanted fire alarms signals;
- the change in how the Fire Service respond to fire alarms from 1 July 2023;
- the options appraisal process carried out in 2022;
- the 12-week public consultation in July to October 2021;
- 66% responses choose Option A which involves reduced attendance unless there are signs of fire;
- Scottish Fire and Rescue Service Board agreed this option in December 2021 to be implemented from 1 July 2023;
- The exemptions to this such as sleeping risk, hotels, hospitals, care homes etc where attendance will always be made;
- Call challenge from the control room;
- manual call points prone to malicious activation; and
- the benefits to businesses, Fire Service and Community as a whole.

Corra Foundation exists to make a difference to the lives of people and communities. It works with others to encourage positive change, opportunity, fairness and growth of aspirations which improve quality of life. Corra wants to see a society in which people create positive change and enjoy fulfilling lives.

Corra achieves this through grantmaking and its place-based programme of which Getting Alongside Communities is a key part.

In 2020 Corra launched a ten-year strategy. It is long term because making a different on the big challenges will take time. At its heart is the strong belief that when people find their voice, they unlock the power to make change happen.

About Getting Alongside Communities

Established in 2015, as part of Corra's People in Place programme, Getting Alongside Communities is currently working alongside eight communities across seven Scottish local authority areas, supporting local people to connect, collaborate on ideas, and take action to create positive change.

The community is at the heart of everything we do. Each community we work alongside has a dedicated Community Co-ordinator whose long-term relational approach - based on listening, bringing people together for conversations, and helping to identify shared priorities – has established deep knowledge, trust and connections with local people and partners.

The approach is designed to help facilitate and enable capacity building within the community; widening community participation, seeking out voices that are seldom heard; and ultimately resulting in locally-led actions being taken.

The ambition for each community is set by the people in that place. Corra's commitment is to help create the conditions and connections needed for bold change to happen.

Getting Alongside Communities: Blacklands

The proposal is for a partnership funding contribution towards the continued delivery of the Getting Alongside Communities programme in Blacklands for a three-year period between 2023 and 2026.

The work builds upon the community capacity that has been developed since Corra's partnership with North Ayrshire Council began in 2016, and will focus on increasing



the sustainability of community initiatives through the development of local capacity, infrastructure and connections with wider structures, including Locality Planning.

Since 2016 People in Place has invested £235k directly into the work alongside Blacklands. In addition, Corra's local knowledge and trusting relationships have connected local groups with other funding sources, including £46k to support pandemic response work.

During that time the programme has:

- Supported 13 community ideas into action
- Engaged over 538 people
- Benefitted from 587 hours of volunteering
- Partnered with Council colleagues to support community and strategic development
- Created opportunities for communites and colleagues to share learning, ideas and amplify community voices at a national level.

Some notable areas of activity include:

Increased Participation & Decision Making: connecting with existing groups, supporting new community activity and strategic developments - including participatory budgeting through - <u>Blacklands Community Kitty.</u>

System Changers: co-designed programme to explore systems and design thinking – and how this knowlegde can be applied to support positive change in Kilwinning. Community spaces: supporting community use of and investment in local facilities. Tackling poverty and stigma: including dignified food provision and clothing initiative.

Partners that the Community Co-ordinator regularly works with include:

North Ayrshire Council and HSCP, NHS Ayrshire, KA Leisure, Blacklands Community Association, Kilwinning Community Football Academy, Blacklands Primary School.

The Community Co-ordinator has developed strong relationships with community members and local partners and has been supporting and facilitating conversations and responses to alleviating poverty, ensuring equality of access and improving wellbeing.

Integral to this approach is enabling individuals, groups and organisations to identify and develop ideas – building confidence and capacity, which in turn results in empowerment and a stronger and more sustainable community.



In addition to directly working alongside Blacklands, Corra has supported the development and delivery of a System Changers project for Kilwinning and will continue to facilitate this work over the next two years.

The 'system changers' are a mix of public and third sector staff and community members. They have developed a deep understanding of systems change and are exploring ways to put this theory into practice in Kilwinning.

The group has identified metal health and wellbeing as a particular focus and are developing experiments to test how best to meet need and improve outcomes. An example of this is the coffee, cake and chat sessions, which libraries across North Ayrshire are currently looking to establish following the positive impact – including improved wellbeing and reduced in isolation - of pilot sessions in Kilwinning Library.

The overall budget will include an annual 'Ideas into Action' allocation of £7,500 to support community members and groups to test ideas and develop them. This provides experience of managing funds and evidencing impact, which builds confidence and the capacity to access larger sums of funding available through third sector funding programmes in the future.

Since 2016 Corra and North Ayrshire Council have been working in partnership alongside the community of Blacklands. This long-term work has supported strong connections to be built and established a firm foundation of increased confidence, capacity and community-led action. This partnership has been underpinned by a simple pledge designed to support, what was then, a new way of working alongside communities. Six years into the work, it feels timely and important to review and deepen that collaboration.

Collective investment from partners, with a shared interest in learning from and resourcing communities to tackle deep-rooted social challenges, has always been at



the heart of the People in Place programme. This approach is now vital, if we are to move beyond immediate financial pressures and achieve lasting change.

Communities are facing a critical moment of transition as they emerge from the pandemic and begin to grapple with the rising cost of living. We are seeing and hearing, in addition to difficult issues, new priorities emerging and an urgency to act.

This proposal sets out how partner funding from North Ayrshire Council can support a deeper collaboration with Corra and communities that can deliver new ways of working.

Through recent discussions we know that there are a shared ambitions - between communities, Corra and North Ayrshire Council - including in relation to the wellbeing economy, increasing community participation and how long-term funding models can support strategic partnerships and key community organisations.

To help achieve these ambitions, Corra will build our work around three key elements:

- **Priorities** we know that communities' priorities are changing and can offer a supportive space to explore, define and articulate them.
- **Plans** supporting communities to set out their priorities and actions to achieve them in a 'community-owned' plan.
- **Partnerships** connecting with partners who can help to produce the plan and/or help deliver on community priorities.

These 'three P's', and the evolution of approach they support, build on the strong foundations – of trust, relationships, skills and knowledge - that have been established to date and will continue to be instrumental in the work.

This approach will help North Ayrshire Council and communities deliver key outcomes including:

- An enhanced understanding of new and emerging community priorities.
- Communities taking action to achieve these priorities contributing to lasting change.
- Improved connections between local action and strategic priorities.
- Leading examples including in relation to the wellbeing economy and public service transformation - for other Local Authorities to follow.
- Enabling structures that support increased community capacity, local leadership, genuine sharing of decision-making and power.
- Financial and social returns on investment.



Corra has a strong understanding of the Locality Plan and governance structures for Kilwinning. We see our role within North Ayrshire as integral to supporting community members in Blacklands to be aware of the Locality Plan, engage in the structures and processes and help shape the evolution of the plan and priorities to recognise community need. This will involve supporting community members to develop confidence and capacity to deliver and lead on activity that directly contributes to the priorities identified.

Getting Alongside Communities will directly contribute to the following Localotu Partnership priorities:

- Supporting skills and work
- Alleviating Poverty and promoting equality of access to opportunities
- Improving Community Wellbeing
- Building strong communities

As community confidence and capacity to grow in terms of participating in locality planning structures and providing their ideas, there is also potential to make a more significant contribution to the priority of 'Improving our local environment' which has been a feature of some smaller scale local action to date.

Corra has worked alongside 538 different community members and partners within Blacklands over the past 6 years and has established trust and effective relationships. This has included children at Blacklands Primary and older people engaging in chair-based exercise and the highly valued tea and chat afterwards, which is often group members main chance for company each week. Corra also supports parents to be involved and lead the local parent and toddler's group. The community-led grant making work (Community Kitty) involved a range of community members including children and young people, who designed the process and identified criteria and worked very effectively together.

The investment will contribute to the overall budget for Blacklands and be managed by Corra's National Programme Manager.

Volunteering and potential employability will be increased through development of skills and confidence. As community members are supported to develop ideas, community participation and volunteering increases.

The intention is that some ideas and activity will result in the creation of governance structures and local organisations that will develop over time and result in paid employment. There has been 587 hours of volunteering provided so far and we expect that to increase at a faster rate as momentum builds.

The Community Co-ordinator is line managed by the National Programme Manager. Corra has a central HR department that supports all staff in the organisation.

From 2023–26 projected investment in Blacklands is £153k. A contribution of £36k (£12k p.a.) from North Ayrshire Council would be integral to the success of this approach – and leverage further investment of £117k that would not otherwise reach the area.

Corra's Board has confirmed investment in the People in Place programme for the next 3 years. Corra is also actively exploring investment from other partners. A funding commitment from North Ayrshire Council would be instrumental in securing additional new investment, a significant endorsement of the work to date, and underpin its continued success.



8. Monitoring and evaluation process

Monitoring and evaluation is underpinned by reflective logs, produced by Corra's Community Co-ordinator, which include a mix of qualitative and quantitative data and input from community members. This informs the analysis of our approach in Blacklands and across the programme. We use the qualitative data analysis to identify emerging themes, challenges and opportunities within and across communities.

The data collected through the reflective logs also informs the Annual Update that is produced alongside community members to describe the activity that has taken place, its impact and what has been learned. There are also several case studies within each Annual Update, the most recent of which is included as an example: Blacklands Annual Update 2022.

The Getting Alongside Communities team regularly meets with Corra's learning team to discuss the learning gathered and identify opportunities to evolve the approach.

Corra also supports community members to share their experiences and impact through community stories. An example of a Blackland's story is:

School Costs: A community pulls together - Corra

An annual event brings communities and partners - including council staff - together from across the People in Place programme to share learning, exchange ideas and plan ahead.

In addition, Corra facilitates a Community of Practice that brings colleagues from across different partner local authorities together to explore shared challenges, opportunities and exchange learning. An example of this includes collaboration between Fife and North Ayrshire Council colleagues that was instrumental in supporting dignified food provision in communities across North Ayrshire.





Subject: New Cemetery for Kilwinning

Purpose: To agree a name for the new cemetery in Kilwinning

1. Background

1.1 The existing Kilwinning Cemetery is nearing capacity for new lairs and as such a new cemetery has been built on the outskirts of Kilwinning on the B788, providing capacity for an initial further 8 years provision with additional capacity to be laid out as required.

2. Key Points for Locality Partnership

2.1 The new cemetery for Kilwinning is due to be completed in the next few weeks and requires a new name.

Historically, cemeteries have been named after the town they are situated within and when a new cemetery is opened it's usually called the Town's name followed by New Cemetery (ie, Kilwinning New Cemetery, Kilbirnie New Cemetery). However, this can cause future issues when a further new site is developed and the Town New Cemetery is no longer the "new" cemetery. Other sites have been named after the street name in which they are located.

Local members and Planning were consulted on a name for the new cemetery and two suggestions have been put forward, namely Old Glasgow Road Cemetery and Redston Cemetery.

The new cemetery is situated just out of Old Glasgow Road and the address would be classed under this. Appendix 1 shows the location of the existing cemetery and new cemetery.

A map dating from 1910 (Appendix 2) shows two houses or farms nearby to the new site with the name Redston and the new cemetery is situated on land which was within one of the old Redston farms. There is a Redstone Avenue in the Corsehill area of Kilwinning but this is spelled differently.





Update

Me & My Mental Health Weekly Support Group for the residents of Kilwinning continues to run and has had a core group attending weekly. They are currently exploring topics surrounding healthy relationships, stigma, identity and sleep by working in partnership with Peers4Hope delivering powwow sessions.

System Changers continues to have monthly meetings. No Events or projects in motion at present.

Stroll with it Kilwinning is back in full swing. 8 consistent participants are attending weekly, and group has reformed nicely.

Youth Work Diversionary has now finished. The programme was funded by cashback for kids. We have completed and submitted year 3 report which highlights what work was undertaken and the numbers engaged with. With some monies left from the cashback, we are looking to run 2 weeks in July (6 evenings)

Community Wellbeing

ASN Groups continue to run well with numbers growing and referrals continuing to come in.

Sadly, Kilwinning Elderly Forum has disbanded. Kimberly is still in contact with members who are still keen to engage with wider initiatives. Once the treasurer has recovered from ill health, Kimberly will support with the closing of account.

Kilwinning Youth has also disbanded. Kimberly and Heather (new CLD Worker for Kilwinning & NC) have now organised a engagement sessions within all primary schools in June, to ask young people what type of provision they would like to see in their community. Update to Follow.

Friends of North Ayrshire Group continues to run and is going well. The group carry out 1 hour literacy support out of the 2-hour time slot and the rest will be spend doing activities such as; Cooking, Music Lessons, Photography, walks, picnics, IT skills etc.

Take Time Families Kilwinning exciting opportunity for families to come together to learn about mental health and wellbeing. We were successful in getting £1000 PB funding. We are working with the families

to spend the money. We have been able to invite different partners in and hope to continue to do so. We have had Gruvi beats and St Andrews first aid

MH&WB Community Mapping- a list of sources of support and signposting opportunities has been collected and condensed into a live document for each locality in North Ayrshire.

Weekly Grief peer support drop-in's, every Friday from 12.30-2.30pm at Kilwinning Library. The groups commenced 25th November 2022. We've launched monthly bereavement awareness workshops to upskill community groups and individuals to better support bereaved people. We launched the Grief resource and information Hub at Kilwinning Library on 16th January.

Coffee, Cake and Chat sessions which is led by the Systems Changer group. – the idea is to provide a place/activity to go where if you are on your own or with a young family and looking to find company or make new friends. The sessions are held every 3rd Saturday of the month in Kilwinning Library and are increasing in popularity each month, the average number coming along is 26 people, a wide mix of age ranges and ethnicity. As a direct result from this other groups have increased in numbers, some of the attendees would be chatting about other groups they attended and made potential new attendees feel welcome and supported to come along and try something new.

The Library groups Knit and Natter and Lego Club and groups which are supported by Corra it terms of Co-ordinator in person support on a weekly basis. Chair Based Exercise and Nethermains Parent and Toddler Group have all benefited from increased participation. Parent and Toddler group in Nethermains Community Centre, this has now increased to an average of 30 children and 28 adults attending, giving space to play, learning experiences for very young children and peer support for adults. Some adults increasing in confidence are starting now to step forward to take a lead role in the group, this is a group that in the future will hopefully be community led.

The Systems Changers group have a common focus of Mental Health although individuals have their own goals and priorities too. As a group we are looking to recruit new members, specifically from those who work within health/mental health setting, this would be from statutory services and Third Sector. This initially will be a targeted approach where the SC

group will invite candidates to apply. This will be focused on the Kilwinning area.

A bereavement bookcase is situated in Kilwinning Library and Co-op Funeralcare, Kilwinning.

Kilwinning Locality team have recently completed Suicide prevention and mental health and trauma training. This will equip them to understand and better support individuals dealing with trauma in their community and groups settings.

Update.

Eglinton Growers: Continuing to support group with their monthly meetings being held within the library. Group were successful in latest PB funding round. The fund secured are to contribute towards yearly events. As such, the group successfully completed an Easter pop-up event with over 100 young people attending. The group held their AGM on Sunday 14th May, sadly quorate was not met. The AGM has been rescheduled for Wednesday 31st May.

Environment & Green open space

Kilwinning Community Council continue to have monthly meetings. PB application was successful. Correction on allocation of funds, this was applied for and granted to both Community Larders in Kilwinning.

Whitehirst Park Eco Project. Still supporting local resident to move forward. Recommended businesses have been contacted for support and donations but have been unsuccessful thus far. Kimberly has suggested another meet and greet be organised. More information to follow.

As part of the Kilwinning Place Framework, we have been working with the Heritage Society to understand what the group's priorities are moving forward. They advised that the heritage centre required updating as it was looking tired and required the introduction of up-to-date technology. A grant of £13,784.00 from the Place Based Investment Programme was issued to the rebrand and refresh the heritage centre.

Food with dignity projects are continuing to run well.

The Wee Shoap

Continues to run and have appointments available. Looking for volunteers to assist in the wee shoap, as well as in the Community Café. Community Café continues to run well and has been very well received by the community.

Cranberry Moss

Continues to run and have appointments available. Have had various providers in to assist the community including money matters. Training was offered via Home Energy Scotland to allow larder volunteers to be able to refer households for energy vouchers. Cranberry's Larder are now trained to be able to offer this. A bulk buy model was trialled in December with Cranberry's Larder taking on the ordering, receiving and sorting of the delivery from Sainsburys. This proved to be time onerous and due to supply chain issues with Sainsburys, they were unable to fulfil the order in a timely and effective manner to this will not be continuing.

Advertised for volunteers and got a fantastic response.

Community Café has opened back up. Some of the new volunteers will assist with this.

Poverty & Equalities

Sarah & Ewan are delivering the intervention group within Kilwinning Academy. Up to 6 young people attend for one period a week. This group allows us to work with young people that may be struggling within school. We have discussions around school, personal and social life. We are building positive relationships with young people within this group.

Kimberly attending Choose Kilwinning Meetings.

Choose Kilwinning have taking over events organisation from Promoting Kilwinning. The group have organised the Segdoune Royal Gala Day and will be organising the Christmas lights. These events will be little to no cost to make it affordable for families, including free activities delivered by Kilwinning locality team.

Kilwinning Youth Group.

We have planned out more activities. We have tried to put in a reward system for young people as behaviour hasn't been great. The activities we are doing the young people seem to enjoy. We are looking at putting more structure in place for the young people with more activities as we have noticed a change in behaviour as the nights go on.

We are continuing to build positive relationships with the young people who attend.

Subject: Roads, Structures and Street Lighting Maintenance Programme 2023/24

Purpose: To advise the Locality Partnership of the proposed Roads, Structures and

Street Lighting Maintenance Programme for 2023/24.

1. Introduction

- 1.1 North Ayrshire Council has a statutory obligation under the Roads (Scotland) Act 1984 to manage and maintain its public road network. The adopted road network within North Ayrshire has a total length of 1044km. The core roads assets are currently estimated at a value of approximately £1.7billion.
- 1.2 North Ayrshire Council is responsible for the maintenance of the adopted local road network including lighting and structures assets as well as its other non-adopted road assets. However, the Council has no responsibility for the maintenance of the Trunk Road Network which falls to Transport Scotland and their management contractor, Amey. The Trunk Road network includes the A78, the A737 from Kilwinning to the Renfrewshire Boundary and A738 from the Pennyburn Roundabout to the A737 Dalry Road Kilwinning.

2. Current Position

- 2.1 The Council's Roads Service has adopted an asset management approach to road maintenance to allocate available road maintenance funds to locations that will offer the most beneficial return on the investment.
- 2.2 The Roads Asset Management Plan (RAMP) and the roads assets maintenance strategy follows the recommendations contained within the 'Well Maintained Highway's Code of Practice, ensuring that the Council's statutory obligations as delegated Roads Authority are met.
- 2.3 In complying with the Code of Practice, an effective regime of inspection, assessment and condition recording is well established which assists in not only providing a road network for the future but one that promotes social inclusion and contributes to economic growth within the area. This approach also ensures the Council is providing value for money on any investment attributed to road maintenance.

3. Proposals

- 3.1 North Ayrshire Council's roads are the Council's largest community asset and play a vital role in supporting the local and wider economy by facilitating the movement of people, goods and services and connecting people with economic and social opportunities.
- 3.2 The proposed Roads, Structures and Street Lighting Maintenance Programme for 2023/24 has been developed in accordance with the strategy contained within the Roads Asset Management Plan (RAMP) to deliver the maximum return on investment and ensures the provision of an effective road network throughout North Ayrshire.
- 3.3 Road Condition is measured nationally through the Scottish Road Maintenance Condition Survey (SRMCS). The measure in place, the Road Condition Index (RCI), records the percentage of the Council's roads which should be considered for maintenance. North Ayrshire's RCI has been improving in recent years and is currently 33.9%.
- 3.4 The estimated carriageway maintenance backlog figure for North Ayrshire is currently £34.8 million. The 'steady state' figure for maintaining our roads at present condition is £4.3 million per year. The capital budget supported by revenue funding is £4.45 million for 2023/24. An additional £0.5m has been identified from the 'core infrastructure, property and vehicles renewal investment' capital budget allocation, taking the total investment in the road network to £4.95m for 2023/24. This level of investment outpaces the 'steady state' figure and should therefore contribute to an improvement in the road network condition over time.
- 3.5 Road lighting condition is measured through programmes of structural and electrical assessment and testing and is complemented through the ongoing review of age profile and material type life expectancy. The results are categorised and recorded in the lighting asset management database to inform a prioritised list of replacement schemes. Lighting is allocated and annual Capital budget of £1.000m to address a 'steady state' position of maintaining our lighting at present annualised depreciation rate.
- 3.6 Bridge and retaining wall condition is also evaluated through a robust inspection programme. General inspections are undertaken every 2 years, while an indepth 'principal inspection' is carried out every 6 years and the results of the inspections are used to inform work programmes. The results of the inspections are input into a Structures database which is then used to calculate an average Bridge Structure Condition Index (BSClav). The BSClav is currently 85.79 (2021/22 figure) which falls within the 'good' classification of 85 to 94 this figure is a slight fall on the previous year. The allocated capital budget of £935,000 is supported by a small amount of revenue funding giving a total of £1.07m.
- 3.7 Details of how condition assessments are carried out and how roads, structures and lighting locations are prioritised for inclusion in our maintenance programme are provided in Appendix 2. The assessment matrix used for

scoring and ranking footways for inclusion in our footway resurfacing programme is attached in Appendix 3. The assessment matrix used for scoring and ranking structures for inclusion in the Structures Maintenance Programme is attached in Appendix 4.

4. Conclusion

- 4.1 The Roads Maintenance Programme 2023/24, which was approved by North Ayrshire Council's Cabinet on 21 March 2023, is attached in Appendix 1a and 1b.
- 4.2 Details of how condition assessments are carried out and how roads, structures and lighting locations are prioritised for inclusion in our Maintenance Programme are provided at Appendix 2.
- 4.3 A copy of the assessment matrixes used for scoring and ranking carriageway and footways for inclusion in our resurfacing programmes is attached in Appendix 3.
- 4.4 The assessment matrix used for scoring and ranking structures for inclusion in structures maintenance programme is attached in Appendix 4.

5. Recommendation

- 5.1 That the Locality Planning Partnership are asked to note the approach taken to determining the Roads, Structures and Street Lighting Maintenance Programme.
- 5.2 That Locality Planning Partnership are asked to note the Roads, Structures and Street Lighting Programme for 2023/24, as shown at Appendix 1a and b.

Condition Assessment and Prioritisation Process

- 1.1 The Audit Scotland Follow-up report, Maintaining Scotlands Roads published in August 2016 stated that Councils should use their RAMPs to establish long term investment plans for maintaining the road network taking into acount whole-life costing and treatment options.
- 1.2 As part of the Roads Asset Management process, annual condition assessments are carried out on the public road network as part of the inspection regime. All locations are assessed using a risk based approach.
- 1.3 Condition assessments are carried out simultaneously with the Safety Inspections in accordance with the pre-determined timescales contained within our Safety Inspection Manual. All faults noted during these inspections are logged within our electronic Routine Maintenance System (RMS).
- 1.4 For carriageways, to take account of whole-life and different treatment options the carriageway maintenance programme is developed using road asset management principles. Lifecycle planning is at the core of this approach and takes into account, hierarchies, condition and local community priorities. Preventative treatments are used to prolong the life of carriageway surfaces before their condition deteriorates and requires extensive resurfacing.
- 1.5 The main factors considered are:-
 - Road Condition based on detailed visual inspection and the Scottish Road Maintenance Conditions Survey (SRMCS).
 - Road Hierarchy this takes account of the strategic importance of the road and is determined from our Local Transport Plan.
 - Assistance to Council and Community Priorities this takes account of other priorities such as economic development, access to shops, amenity housing or schools.
- 1.6 Carriageways and footways are both condition assessed and scored in accordance with the assessment table below. These condition scores, RCI data, road hierarchy information and priorities information as above are utilised through our electronic WDM Scheme Manager to target locations for improvement works in order to optimise investment.

Each location is also reviewed at least once a year depending on its location within the Roads Hierarchy as part of the routine inspection process.

- 1.7 There are various types of surfacing materials and processes available depending on the particular road type, location and level of existing deterioration. Options available for treatment include preventative measures such as surface dressing and resurfacing options such as screeding, resurfacing (inlay and overlay), depending on the severity of deterioration full reconstruction may be the most effective option.
- 1.8 The level of investment associated with the varying treatment types identified in the table below was established using the Society of Chief Officers of Transportation in Scotland's cost projection model, developed as part of the Roads Asset Management Planning project. The model assists with identifying the effect of various treatments on the on-going condition of the carriageway. This enables a more accurate design life for the treatments currently available to be developed and ensuring value for money on their use. Costs for works can vary from the figures below depending on restricted working arrangements, traffic management required and the extent of preparatory works necessary to enable resurfacing. There is also an additional uplift for island working of up to 50% for works on Arran and Cumbrae.

- 1.9 Street Lighting column replacement is prioritised through non-destructive strength testing to determine the level of deterioration associated with the columns. Following testing, columns are categorised within the Asset Management database for road lighting.
- 1.10 Testing is carried out in accordance with the Institute of Lighting Engineer's Technical Report No.22 Managing a Vital Asset: Lighting Supports as well as UK Lighting Board Code of Practice: Well-lit Highways.
- 1.11 Once results are input, the database then compares these results against the more general age profile to determine a final list of priority repairs. This produces recommendations in order of priority for both individual units and whole streets or areas.
- 1.12 Recommendations are generally categorised as Category A through K as follows:
 - A: Immediate replacement
 - B: Replace urgently or reinspect within 6 months
 - C1: Column Material failure, replace as soon as possible or reinspect within 1 year
 - C2: Bracket failure, sleeve where possible or replace unit within 1 year
 - D: Foundation failure, realign, reinstate and reinspect within 6 months
 - E: Material approaching failure, replace as part of planned maintenance programme or reinspect within 2 years
 - F: Material approaching failure, replace as part of planned maintenance programme or reinspect within 5 years

- G: Condition reasonable, but age expired and certified insured for 2 year periods until replaced
- H: Condition reasonable, but age expired and certified insured for 5 year periods until replaced
- I: Acceptable condition but age expired and insured for 5 years periods until replaced.
- J: Sound condition but age expired & visually poor (evidence of concrete cracking etc.)
- K: Sound condition and not age expired no current requirement for strength structural inspection, visual only at planned maintenance cycle.
- 1.13 Where non-urgent replacement recommendations (Category F through to J) are on an individual column basis, the data is further analysed to determine a percentage value for recommended replacement numbers against the balance of units in a street. If this figure exceeds 30% then the entire street will be considered for higher prioritisation which will address the design class standard of the street beyond individual replacement for safety reasons only.
- 1.14 The structures programme is identified based on the structures prioritisation matrix which ranks assets based on a number of factors including its condition, safety, and usage.

Joint cabinet

Members of Scottish Youth Parliament

Our 4 MSYPs attend local and national groups and meetings to represent the views of their peers.

Currently they are linking in with youth forums and youth voice structure and working on specific projects including:

- LGBT
- National Entitlement Card
- Climate Change
- Mental Health and Wellbeing
- Youth Voice in Schools

Recruitment for notes of interest for any young person aged 14+ who wish to stand as an MSYP for the 2024-2026 term are now opened until 31st July. Locally we have launched a local recruitment drive through social media, press, schools and communities. The voting for these elections will take place in November 2023.



P7 Youth Council

140 young people from all localities attended this interactive day to take part in four workshops ahead of transition into secondary school. These workshops included: developing a Mental Health Toolkit, Health and Wellbeing Curriculum, Transition to Secondary School and Financial Literacies and Life Skills

This also provided an opportunity to consult the Local Development Plan

Schools that attended this event were Beith Primary, Stanley Primary, Whiting Bay Primary, Brodick Primary, St John's Primary, St Anthony's Primary and Annick Primary.



Joint Youth Forum

This meeting took place in March bringing together all of our youth forums and youth voice groups engaging on the topics of the Local Development Plan and the Mental Health Toolkit. These 40 young people also had the opportunity to share good practice and take part in some teambuilding activities.



Climate Change Ambassadors

A group of 12 ambassadors continue to work on a range of activities, opportunities, signposting and events around climate change and sustainability.

The group meet fortnightly to look at local and national issues that young people can input on, and the young people feed into the NAC Climate Change Steering Group

Proposed plans for summer include:

- 3 Beach cleans (Three Towns, North Coast and Irvine).
- Community tree plant and time capsule event.
- Climate Change Community and school charter

The young people would like any input from the Locality Partnerships of anything they may want included in the time capsule.





Youth Work Modern Apprenticeship Programme



Our six Modern Apprentices continue to work towards their SVQ in Youth Work and provide support to our locality teams and locality youth groups.

Six MAs that have just completed their qualification in March have all moved onto positive destinations and have all have retained sessional youth work opportunities within the team.

Additional training out with their core training has included a pilot for suicide prevention training. Participating in the Fair Jobs Fayre, they have also been working on national consultations including Alcohol Marketing consultation with Alcohol Focus Scotland.

The MAs are additional accredited Mental Health Ambassadors gaining Mental Health First Aid (SCQF Level 6).

Recruitment is now open for our new cohort of Modern Apprentices who will be starting in August. Applications can be found on the My Job Scotland website.



Working with our New Scots

New Scots youth participation activities includes sporting, cultural, and social New Scots Girls Duke of Edinburgh who play badminton weekly at Kilwinning Academy. The girls are also achieving competence in mountain biking, football and orienteering. The expedition for DofE Bronze will take place in the summer.

New Scots girls attend Swans football in Kilwinning. The group were supported to attend a residential in Inverclyde in partnership with Active Schools. They had their first competitive football game against Greenwood Academy working with Ali Duncan from the school. This was a great success even though the girls lost they enjoyed the game and keen to play again.

In partnership with Active Schools New Scots young people had the opportunity to attend the Scottish Assault Course. This was a trip that included New Scots and Scottish young people.

A very successful quarter with increasing involvement from Ukrainian and unaccompanied New Scots. The work now involves young people from 8 nationalities. It received support from the Princes Trust to buy a football kit, boots, waterproof coats for outdoor activities and a range of trips and additional activities to take place from May 2023, including taking their Dynamic Youth Awards and 8 boys registering for SFA Level 1 Coaching Awards. This is expected to be an ongoing partnership. 27 boys are attended our Nova Scotias Football group. (Kilwinning) and 23 boys attended an Inverclyde residential in March 2023. 9 boys attended the fortnightly Nova Scotias Youth Club (Irvine), 19 young people & 1 parent attended our Mixed Sex Family Volleyball (Kilwinning) and 9 children attended our Children's









The Multiply Project

As part of the UK Shared Prosperity Fund (UKSPF) North Ayrshire Council have secured funding to deliver the Multiply Project.

This project aims to boosts people's ability to use maths in their daily life, at home and work targeting learners who are 19+ that have not previously attained a level 2 SCQF, level 5 or higher maths qualification.

Success measures will be:

- More adults achieving maths qualifications / participating in numeracy courses
- Improved labour market outcomes
- Increased adult numeracy across the population

Staff have just come into place within CLD and have already met with CLD teams, partners and relevant services to discuss way forward, pathways, referrals and opportunities.

National numeracy day took place on 17th May followed up with National Employability week where the team promoted the new project at a number of events including the Parent Hub launch, TACT Open Day, Saltcoats Job Fayre and a social media campaign.



Next month they are attending events a HMS Kilmarnock at an employability roadshow event in Arran on the 22nd June.



Cost of Living Priority Auction

During the Joint Cabinet over 100 young people participated in an interactive Priority Auction around cost of living. This heled us identify areas that young people feel are priority in relation to Cost of Living

Young people were given 10 themes around this to rank in order from most to least important through an interactive priority auction. Below is the overall ranking of the Priority auction:

Priority given by young people in relation to the Cost of Living:

- 1 Support with costs associated to school
- 2 Access to foodbanks and community larders
- 3 Access to holiday and weekend meal provision
- 4 Access to financial literacy education
- 5 Access to school and community swap shops / clothing banks
- 6 Transport Costs
- 7 Employability Support& Guidance
- 8 Costs associated in socialise with friends
- 9 Access to digital equipment & WiFi
- 10 Cost of clubs and activities out with school

Take Time Families

This programme offers support to families targeting parent/carers and young people to achieve a joined understanding of resilience and emotions in the home. Currently this is running in Kilwinning Library along side the Kilwinning locality team on a Wednesday with around 20 participants.

This was running as a pilot in Corsehill Primary school before being moved into a community based setting and plans in place to run this group after the summer in North Coast.



Delivery of Your Resilience Programme in School, College and Community Groups

Your Resilience supports young people's mental health resilience. The educational programme is focused on building resilience through life's transitions in 14–20-year-olds, equipping them with the tools and resources to manage their mental health now and in the future.

Currently delivering or planning to deliver with Scratch Group within the Three Towns locality but keen to look at any community groups that would be interested in the 6 week programme.

Mini Ambassadors Programme - Boynce Back Peer Sypport Programme

Creating a mental health and wellbeing programme, targeting primary school young people which the BeeYou Ambassadors deliver. Schools identified in the pilot were Castlepark Primary and Hayocks Primary. This is branded as the Bounce Back Award which can be ran with primary schools through a 6-week course.

We have completed this with 14 young people meeting weekly Hayocks Primary.

Currently this is running in Lawthorn Primary in with 3 Mental Health Ambassadors supporting the programme with 30 young people taking part. On completion the young people will become mini ambassadors and will deliver resilience workshop to parents/carers within the school community.

The next programme of this will start in St Lukes Primary on the 30th August.





LGBTQI+

The Equality Project is led by the young people's needs and wants, in a hope to speak truth to power and empower our young people to make positive change within their communities in a safe and nurturing environment. The group has around 20 members and concentrating on LGBTQI+. The group have been meeting in Irvine and Three Towns locality with the next one planned for North Coast and then Garnock Valley

The Equality project will be attending an overnight on the 2nd of June, to take part in Arran Pride walking in the parade and having their own stall and promotion of what mental health and wellbeing community mapping and support for our LGBTI+ young people. We have 28 young people attending this. These young people are from North Coast, Garnock Valley and Irvine and we are keen to get more young people to join.

The youth work team have been successful in obtaining their LGBTYS Silver Charter mark and to celebrate this the group are planning a community picnic, tree planting and time capsule. More information on the Charter can be found here: https://www.lgbtyouth.org.uk/the-lgbt-


