If insufficient groups are in a position to take over the toilets, Largs could be left with only one toilet at the seafront car park. NAC's decision to put the question of the future of Largs' toilets is of great concern. Maintenance and cleaning of the toilets are paid for from |

| | • Councillors referred to the enormous amount of housebuilding in Largs over the last few years, chances of getting more funding for housebuilding in this area is remote and there is still a demand |
| | for private houses with a lack of surplus land. |

| | Finance for the building of houses on the former St Mary's land includes some for refugees. There will possibly be 2 houses for refugees and the remainder allocated in line with NAC housing policy. Concern was raised about whether the local people would benefit from the sale of the land which should be at the current market value. The budget is causing grave concerns and savings have to be made, one of which could be the toilets. NAC are carrying out a detailed study of Council buildings. The larder, now known as Largs Food Hub, is awaiting a fridge delivery and there is now a committee Flood defence is on schedule |

Drugs

Matters Arising from Last Meeting

Drugs/controlled substances, clarity within police report of whether or not there is a drug problem in Largs.

North Ayrshire, and Largs is a safe place to live. Relative to other areas in North Ayrshire, Largs appears to have a lower number of drug related issues. Police Scotland are committed to intelligence led enforcement aimed at disrupting the supply of illegal drugs, as well as closely working with public health and partners to tackle harm caused by substance misuse. Police officers now routinely carry Naloxone sprays, engage with local alcohol and drug partnerships, sign post supportive pathways and campus officers promote wellbeing and risks associated with substance use.

Can future reports include what national and local campaigns are being focussed on.

The Joint Strategy for Policing 2023 outlines the national direction for Policing in Scotland, the strategic outcomes, and their impact on communities. (Available via Police Scotland Website)

The North Ayrshire Local Policing Plan extends on this at the local level with close engagement with the Community Planning Partnership (Also available Police Scotland website)

This Local Police Plan is also complementary to the Safer North Ayrshire Strategy and delivers against the following priorities:

- Reducing crime and anti-social behaviour
- People feel safe and vulnerable people are protected
- Improving road safety

For Largs at the local level, officers holistically engage relevant campaigns (Is That Me, Hate Crime etc.) and partnership pathways / approaches to match the individual circumstance in a manner that works towards the above priorities.

Extra patrols around town particularly over Christmas providing a visible presence. This was done.

Advice and support being given to shops and businesses during Christmas period Done on an ongoing basis through routine patrols and engagement with shops.

Do local businesses contact each other to alert any shoplifting etc. taking place in town? Is an app used?

From the shops spoken with, there does not appear to be a single organised communication channel similar to town-centre radios as used in Saltcoats and Irvine.
