Street Names

We were asked to provide at 2 or 3 names for the new housing development between Place Woodland and Newhouse Drive in the Fudstone. We had less than a week to respond so we posted on Facebook to ask for suggestions from the public. The names couldn't be similar to existing names and if named for a person, couldn't be for a living person. Two days later, we collated the eligible names and ran a poll to see how much support the public had for these suggestions. The top 5 were then sent to the GVLP for a final decision. They chose Woodland Avenue and Puddock Place, subject to approval by NAC.

7. Garnock Valley Locality Partnership

Place Framework

The public consultation phase has now been started. There is a website where people can respond and paper copies are also being sent to every household in the Garnock Valley. There will be a series of public meetings in November to discuss the results with the public before the final report is written up.

Vale Park

The latest development on the bridge is that Tata Steel are now questioning whether they own part of the bridge. Most likely, this is their way of trying to get out of having to pay half of the repair bill, which means that any solution will be delayed.

GVLP – Childcare / minders

There was a presentation at the Locality meeting to discuss childcare issues. Even though they work on their own, childminders are expected to go through the same paperwork and planning processes as full-scale nurseries. There was some discussion about what support NAC could offer but their team has also been reduced due to budget cuts.

8. AOCB

Garnock Street / Mill Road

A member of the public asked if a crossing could be installed at the roundabout between Main Street and the old police station car park at the top of Garnock Street. Unfortunately, the road crests right at the junction and without sufficient flat ground for the crossing and approaches, it is unlikely that Roads will be able to install one. Since there is no pavement on the Main Street side of Garnock Street, moving the crossing further down, as they did at Stoneyholm Road with the traffic lights at Tesco or at Bridge Street with the lights at Easties, would not be appropriate as there is no pathway to the Main Street.

Older People's Network

Gavin Ferguson has been continuing to support the Older People's Network in the Garnock Valley. There is a conference coming up soon and Gavin has asked for one representative from each organisation to attend so that they can discuss the issues raised at the various Network meetings.

Centre fence

Bridgend Community Centre caretaker, Avril Waldron was praised for her efforts as she and her family have been scraping old paint off the front railings and painting them.

Volunteer of the Year

Before Covid, we used to run the Volunteer of the Year. Latterly, it was expanded to incorporate a Citizen of the Year. Jim Pierce won the award in May 2019, the last time it was presented due to Covid. We had planned to restart it last year but due to loss of James' son, we delayed the restart for another year. It is therefore our intention to restart the Volunteer of the Year award after Christmas, where we will seek nominations for local heroes and then run a poll to see who the community thinks should be awarded Volunteer of the Year 2025.

Spout of the Garnock

Questions were asked about the Spout of the Garnock, in the hills above Kilbirnie. There has been works done in the hills in recent years for small scale hydroelectric power generation and it was asked if these works had diverted waterways sufficiently that the Spout had dried out. It was suggested the drying out may be seasonal, but as this has been one of the wettest summers in recent memory and the Spout has still dried out, then this causes concern for when we have a nicer summer.
