☐ Margaret Archibald Fund – Andy had circulated a note to CC about the fund, aimed at the over 65 community and local organisations are aware of the fund. Majority of groups have applied for the fund. The CC will continue to support the promotion of this fund for individuals going forward. Formal process for individuals to apply on council website.

Governance in relation to the fund. Trust deed gives GV Cllrs legal application to make decision on whether to approve the application.

□ Roads / Traffic Issues –

Speeding motorists – near misses and high volume of reports of erratic/speeding driving. Encourage public to report it to the police. New Street rat run.

Residential streets will be moving to 20mph. Main routes through will remain a 30mph.

Cllr Stalker has written to NAC re revoking of one-way system at New Street/ Garnock Street. Various viewpoints being expressed to Cllrs and it will be brought in for 18 months at Garnock Street and reviewed thereafter. Many years ago, it was agreed a survey would be done, but given current financial status no survey will been done.

□ Royal Mail Deliveries – Increasing numbers of email and social media complaints. New system in place with overtime cancelled so staff can only do so much in a day, impacting on a lot of areas. Resident has complained to Royal Mail without any satisfactory outcome.

Statutory organisations still rely on official correspondence going by mail. Hospital appointments, official documentation etc.

RM has to deliver within laid down timescales. Local information suggests parcels are taking precedence over letters.
