

# **Vice Chairperson Role**

- ➤ Work with the Board to assess organisational priorities and ensure alignment with the mission and goals.

#### Partnerships and Advocacy:

- ➤ Build and maintain strong relationships with key stakeholders, including donors, partner organisations, and government agencies.
- Advocate for the rights and well-being of children, representing the charity in relevant forums and events.

#### Financial Oversight:

- Collaborate with the finance committee to oversee the charity's financial health and sustainability.
- Assist in fundraising efforts, leveraging personal networks and resources.

#### Risk Management:

- Work with the Board to identify potential risks and develop strategies to mitigate them.
- Ensure compliance with legal and regulatory requirements.

## Succession Planning:

- Participate in the identification and development of potential future leaders within the organisation.
- ➤ Contribute to the ongoing development of the Board's effectiveness and governance structure.
