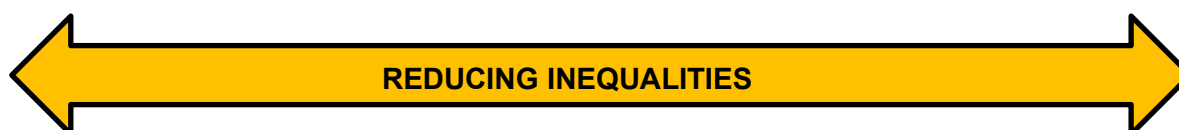

The Chair welcomed those present to the Three Towns Locality Partnership meeting, introductions were made and apologies for absence were noted. <u>Declarations of Interest</u> • Cllr Sweeney declared an interest in the CLASP application • J Gray declared an interest in Whitlees Community Centre	Noted Noted

2.	Action Note from meeting in June 2025 The action note from the meeting held on 4 June 2025 was submitted for approval as a correct record with the following updates provided: • Item 3- Community Investment Fund- No Update was available in July but an update will be made at this meeting. • Item 10- Welcoming Michelle Sutherland to speak on CHES and discuss with the Partnership at this meeting. Matters Arising • Saltcoats Vics were awarded CIF on the basis that match funding was secured. The Locality team can confirm that £8,000 of the required £20,000 has been procured. • Ardrossan Bowling Club were also required to secure match funding. So far, they have secured £6,400 of the £10,000 match funding required. They have a Community Benefit Fund application at this meeting to secure the rest if possible. • Hayocks have now completed their business plan and have applied for UKSPF and Community Landfill Fund. An update on this can be provided at the next meeting. • These updates will be circulated by A Morrell. Noted.	A Morrell
3.	Collaboration for Health Equity (CHES) The Locality Partnership received a presentation on the CHES Programme by M Sutherland: • An overview of CHES was provided to the Partnership. The work is jointly between several community planning partners including Council, Public Health and NHS. • Looking at reducing inequality and closing health equity gap. • One of three 'Marmot Places' • Two questions- What has the most impact in closing health inequality gap and what actions can we take? • North Ayrshire selected due to having lowest female healthy life expectancy in Scotland, with healthy life expectancy for men also now also the worst in Scotland. A large part of the population is economically inactive, high levels of child poverty and high levels of drug deaths. • M Sutherland provided an overview of available related statistics and evidence. • Have carried out analysis of the challenges in North Ayrshire. A report will be circulated on this alongside the slides from the meeting. • Looking at areas of poorest health outcomes in North Ayrshire- Three Towns, Irvine and Garnock Valley localities.	

	• Provided overview of 8 Marmot principles mapped to areas of highest health inequalities. Next stage is developing tests of change across these areas and start to deliver interventions. Discussion • Questions posed: How can we best engage the LPP and other networks in Three Towns, what opportunities are there to progress engagement, and how can we best feedback on engagement? • The Partnership expressed surprise at the exceptionally low healthy life expectancy of women in North Ayrshire. • Highlighted the work taking place across North Ayrshire around reducing social isolation. The Partnership feel this is a key issue and highlighted reaching socially isolated people as an important aspect. • HSCP could work closer, more jointly with other departments across the council especially around digital access. Classes are available across North Ayrshire for support and access on this. • Highlighted generational low economic activity and the effects on North Ayrshire communities. • Appreciate the targeted nature of the CHES programme. • Highlighted the lack of skilled employment in North Ayrshire as another issue of focus. A legacy in North Ayrshire of losing these industries that are then not replaced. • Highlighted work by Whitlees during Covid to build links and encourage community out into the centre from the house. Catching the children early is key also, for example increasing breakfast club and clubs that start early enough, school breakfast club does not start till 8am. The young people then feel a sense of ownership over the centre and can gain skills and experience through helping and volunteering. Local community organisations are vital in this process. • Efficient communication would help with lower resources, for example with health and care waiting times. Building links between CLD and Community Link Workers are key here. Increased partnership working. • From a Police perspective, mental health cases are increasingly visible to Police in Three Towns as they cannot access the support they need and call 999. This then diverts police away from being able to focus on criminal behaviour. • Highlighted review of locality networks that sit around the Locality Partnership- local partners and council services sit on the networks and this is where the key partnership working and link could be taking place. • M Sutherland is currently pulling together an FAQ document. • Next steps will be to pull together ideas for change and test these with the Partnership and continue a dialogue over the next 16-18 months.

Brief details of organisation	North Ayrshire Table Tennis Club have been established since 2001 and aims to give people of all ages, within the three towns and across North Ayrshire the opportunity to come along to our 24 table, Table Tennis centre at ST. MATTHEWS Saltcoats. All abilities and backgrounds can participate together from as young as 6 to 90 years of age. The club has grown from strength to strength with a response to community need for smaller venues popping up all over North Ayrshire including our Island communities. Playing regularly delivers major social, physical and mental well-being benefits – addressing some of the major health challenges in society today • Its simplicity makes it particularly effective at helping the inactive become more active • It can be played in schools, sports centres as well as village halls, community centres and day-care centres reaching into communities of all sizes • We have a pathway at the club for all abilities from grass roots to international level • We had a vision 24 years ago to introduce table tennis to the community of North Ayrshire hence the name. We have covered most areas, and now Saltcoats is one of the main venues in the UK for table tennis visitors and major events • The club has invested £28,000 over the past few years in new tables and equipment and we have a total of 42 table tennis tables and 120 safety surrounds in venues within our remit. This is to meet the demand for table tennis within the local area

	- The club currently hold the title of Scottish Sports club of the year, winning it for the 2nd time, previously in 2013, and are the only club to have won this prestigious award twice. - The club pride themselves on sustainability and with excellent facilities coaches, partners and a strong committee we are in our 24th year with our membership continuing to grow.

Brief Overview of Proposal	Our proposal is to create a full-time Development Officer/coach and equip our part time coaches to run sessions. We will work towards obtaining UKCC coaching awards for these coaches and the funding would go towards increasing hours for coaching and qualifications for new coaches who would work alongside the Development Officer post. Our coaches are age 16+ and the opportunities provided, will help young people to identify strengths and build on their skills. As a club we have seen young people move on to positive pathways and secure employment as a result. Project budget Proposal: Our 2-year plan is to have a coach paid for 35 hours a week over 44 weeks of the year at £15 per hour min totalling £23k Year 1: CIF Fund £3,921 + club contributions of £8,000 Year 2: The club has applied to ARRAN CVS via the Mental health and wellbeing Fund for 2-year funding of £10k per year. We have been supported through this fund over the past 4 years. 2 x ad hoc Table Tennis apprentice coaches to support our head coach. Hours approx 6 hours per week. We will cover the cost of their salaries through local small sponsors and events. Club membership is growing each year and income is rising year on year. We are also in talks with a few companies who have supported us over the years and going into our 25th year we are organising fund raising events to celebrate our 25th year.

	Community wealth building continues to be a major objective of the club through the years and for the future. The club have invested into the three towns since it was founded and continues to help promote the local economy and tourism by staging major events in Saltcoats. In addition to these objectives: • We actively focus on building active and strong communities by using table tennis as a means. • Providing children and young people opportunities to take part in a fun, healthy and active experience. • We are tackling social isolation and improving wellbeing by being inclusive of all ages, skill levels and abilities. • We are utilising social media to promote the reach of the club across North Ayrshire. • Assist training skills to encourage paid employment. • We would like to leave a legacy to the community by owning or naming the table tennis centre as a centre of excellence and dedicate this to someone. • We could not have achieved all we have over the past 24 years without the continued partnerships we have enjoyed, such as Arran CVS, NAC, KA LEISURE and Active schools. • The club has been successful in obtaining funding for capital equipment and due to this we have and are increasing our membership on a monthly basis and now into wintertime our club will be increasing venue hire to run more sessions.

Housing and Communities, Finance and Legal Services have been consulted and their comments are as follows: Finance: Quotes and requested documentation have been provided. There would remain £1,433 available for disbursement from the Saltcoats Common Good Fund should this application be successful. Legal: It is legal's understanding from this application that the lights installation in previous years was carried out by NAC building services free of charge, however this charge is now the community's responsibility. NAC building services would still be responsible for installation of the lights and associated equipment, however the applicant is responsible for paying the Council as per the quote provided in the submitted application paperwork. The Act states that in terms of s.15(4) of the Local Government (Scotland) Act 1994 when determining whether an application is to receive assistance from Common Good fund the Council should have regard to the interests of the inhabitants as a whole of the area to which the Common Good relates. Whilst I think that the purpose of the funding itself (installation of lights/equipment) could potentially meet the criteria of the act as Christmas lights are an essential part of the Christmas carnival and the carnival itself is attended and enjoyed by the community of Saltcoats, I would normally expect the application to explain in more detail why this fits the criteria of the act. Housing and Communities: Having considered this application and Finance and Legal's comments we believe this application meets the criteria of benefiting a significant group of inhabitants to Saltcoats Town.

Description of the Project

Background:

The female toilets and changing area at the Ardrossan Indoor Bowling Club have not been upgraded since the building was first constructed. The facilities are described as unsightly and unpleasant, with two non-operational toilets, rusty and scratched toilet roll holders, and evidence of previous, poorly concealed vandalism and graffiti. Users have also noted an unpleasant odour, missing and cracked tiles, and flaking paint. The Formica worktops on the sinks are splitting, and the carpets are worn, stained, and show significant water damage from a previous roof leak. It is vital to the community to ensure the maintenance of the building is kept to an operational standard as this is a warm hub for many elderly who rely on this for friendship, exercise, heat and socialising where they can have a hot drink and avoid isolation.

Project for Funding:

The club is seeking funding for a comprehensive toilet renovation project. This will include the removal of existing WC's and cisterns, the supply and fitting of four new WC's, and associated pipework alterations in the ladies' toilet. The project also covers the removal of the existing worktop and WHB's, to be replaced with a new worktop, four new WHB taps, and gratings. Plastering and painting of the renovated areas are also included in the scope of the works. This will enhance the facilities for use not only for the Members, but other Community Groups who currently use the building and anyone attending private and community functions that will be held in the future. The proposed project start date has been amended to 2nd February 2026, with a completion date of 13th February 2026. The users of the venue will have access to the accessible toilet while the work is being carried out.

The club is also used by other community groups and for events, and the renovated facilities will benefit all these users. The club also plans to engage members in fundraising efforts to contribute to the project costs.

Description of the Project

Background: The organisation's current broadcasting equipment is over ten years old and is becoming increasingly unreliable. The software they use runs on Windows 10, which will no longer be supported by Microsoft from October 2025, rendering the system obsolete. This poses a significant and imminent risk to the station's ability to continue its broadcasting services for the communities of Ardrossan, Saltcoats, and Stevenston broadcasting to roughly 30,000 members of the public annually. Some of which are expats of the Three Towns now living in the USA and Canada who listen to the stream via the internet.

Project for Funding: The project is to purchase essential new digital broadcasting equipment. The funding requested will be used to purchase a new Myriad Broadcasting Software system and a new Digital Radio Mixing Desk. This capital investment will replace the obsolete systems, modernise the studio, and ensure the long-term continuation and development of the 3TFM community radio service. The new updated system will enable 3TFM to do a live broadcast on Christmas Day from their own homes, reducing social isolation. The group have applied for £8,000 from Clothworks Foundation to replace the broadcasting equipment. If the application to Clothworks is unsuccessful at this stage, with the CBF award the Community Radio would still be able to operate with the new mixing desks and software update. NAC external funders are also supporting the group.

Ardrossan Community Association/Whitlees Community Centre : Community Asset Transfer

The association have received excellent support and advice from CJM Lumina, who worked with them to complete the business plan, financial projections and a set of next step recommendations along with an options appraisal, which wasn't included in the original brief for the consultant. The review of finances and forward projections highlighted the risk to the association of taking on the building at the present time and with current ways of working, as it would drain reserves and put enormous strain on the staff and volunteers. Based on this, the association have decided to pause the CAT process for now and take the time to work with North Ayrshire Council to put in place the recommendations from the business plan, which focus on increasing financial resilience and adjusting processes and procedures to strengthen the association's case for taking on the asset in the future. The recommendations have been pulled into a separate action plan and we are about to begin a costing review exercise focused on the events side of the business to ensure that every event is at minimum breaking even while minimising waste.

The association hope to work closely with Connected Communities and Community Facilities over the next 2-3 years to gradually take on more responsibility for staff, bills and other costs to build up their financial resilience before they revisit full ownership through CAT in the future to safeguard the centre for the community.

PDA Youth Work Ardrossan Academy

The young people are close to completing unit one of their 3-unit higher qualification. Some young people are shy, so it is a working progress to support the young people to develop their confidence as we approach the Youth work, workplace next year. Some of work covered so far has involved the UNCRC, youth engagement, practice and policy and risks/boundaries. With this extra option as part of the curriculum, we can use this as a foundation for young people to access Youth Work practices within the local community.

PDA Youth Work Auchendarvie Academy

The PDA has been running over the past three months making steady progress in Auchendarvie Academy with S5-S6 pupils

The group have completed Unit 1 (Understanding and Exploring youth work) which focused on 3 separate outcomes.

- 1 Outline the settings and context for delivery of youth work in Scotland
- 2 Explain the roles and responsibilities of an effective youth worker
- 3 Outline the factors which may impact on youth work practice

Three Towns Community Shed

The group were recently supported throughout their community open days during the October holidays and are being supported with updating policies and setting up their new laptops which they received through the community benefit wishlist.



Stevenston Community Council

With a change in chair, the group have been supported to learn how to generate an agenda template and are currently being supported to submitted their CIF annual report. The subgroup of the council are working away in the background to process the applications received to access the windfarm monies.

Ardrossan Youth Association (AYA)

Work has begun on the centre from the money allocated from the National Lottery to refresh the external walls of the Youth centre. The centre has undergone a fresh lick of paint on the outside as well as a new sign. This work was carried out by the CLD workers who support the association and volunteers from the D.I.S.C. Award group who also use the centre as part of their award.

The youth association have managed to make massive savings to outgoing bills. This was done through identifying out of contract utility suppliers and making new contracts or changing suppliers. The association changed other things like insurance providers and stopping contracts with businesses that are no longer used. It works out around £8900 of savings per year which will be used more constructively with positive outcomes. They have also received around £4000 back from different suppliers for over payments



Increasing Civic Pride & Community Engagement

Participatory Budgeting -

- 324 applications were received in total across the three funds, of which 264 were eligible to proceed to the public vote, which opened on Monday 20th October.
- 32 community reviewers, the Modern Apprentices and 4 Youth Forums reviewed the applications this year before the public vote opened, with many people participating at this stage for the first time. The older Modern Apprentices co-delivered the training on community review to the new intake and helped lead the review for Irvine and Kilwinning localities.
- At the time of this update (11th November), 10,424 votes have been cast across the funds with the majority being cast by young people (so far). School engagement remains low overall, but an increase in participation was seen following promotion during Youth Work Week, particularly at Joint Cabinet and the Youth Conference.
- The voting deadline has been extended from Monday 10th November to Sunday 16th September to allow additional time for votes to come in
- North Ayrshire's approach to PB has been highlighted as a good practice example in the recent Audit Scotland Best Value report, with attention drawn to the percentage of funding spent through participatory approaches and the value of our process, particularly for young people

Community Hub of Hope

The group are now successfully operating as a SCIO. This came in good time where double celebrations were held with the official opening of their new premise. The group were supported on the day with this celebration. In the background they have also been supported with the creation of group policies which align with the groups ethos and from this a child protection policy, confidentiality policy, Equality, Diversity & Inclusion Policy, Code of Conduct policy, social media policy and a safe-guarding policy were created.

Friends of North Ayrshire

This group has now come to a natural end. Having supported the group for 5 years, it is now time for them to go out there and try something new. Support will always be available over the phone or with a catch up.

Hayocks Tenants and Residents Association (HTARA)

The group have been supported to make amendments to their constitution, providing them with SCIO status, develop new policies and to complete a business plan in preparation for the group to submit their full CAT application. HTARA were successful with their CIF bid of £100k and required to find match funding towards the build and extension to the playpark, they were supported to apply for funding from the UKSPF fund, securing £25k and a successful funding application for the Scottish Landfill Community Fund gaining a further £45k which in total is £170k for the Play Park.



West Coast Furniture Bank

The Three Towns team continue to support the furniture bank to do what they do best - to help individuals and families out of poverty and provide household items to make a house a home. By upcycling items that would normally go to landfill, their organisation will either re distribute or sell on these items to continue the work of the charity. The Charity are currently in a very large building in Ardrossan and are looking for organisations to rent some of the space the new large premises have to offer. They continue to seek funding to ensure that they can continue to carry out the great work and partnership working with other charities.

New Scots Update:

- Mental health awareness embedded in ESOL curriculum using storyboards and roleplay
- In October, the Equality and Inclusion Manager from Ayrshire and Arran NHS attended the Big Community ESOL class. The team spoke to learners to gather their views on any healthcare they have received and the challenges that ethnic minorities face when accessing healthcare
- New Scots have been supported to take up volunteer opportunities supporting them with interviews, language required and ongoing support while volunteering
- ESOL Learner Forum has been established with 14 learners participating to shape service provision and remove barriers
- We ran a Summer School for young New Scots and unaccompanied minors in Saltcoats and Irvine, the summer school provided a safe and supporting space to keep learning, practising English and socialising

Core Skills Update:

- Core Skills drop-ins in Irvine, Kilwinning and Stevenson support literacy, numeracy, and digital skills; 3 learners gained permanent employment
- Core skills volunteer recruitment drive launched with 7 volunteers completing induction and shadowing with the core skills team

3 Towns Growers - Update

THE ALCHEMIST PATH - a forage trail.

This project will establish a wild path through the wooded area on the west side of the allotment. Using recovered tree twigs, branches, logs and other fibrous organic material, to build a 'dead hedge'. The project will become a place to forage wild foods. It will introduce individuals and communities to the idea of sustainable food provision through foraging, create a site of biodiversity protection and enhancement. Plot holders will be asked to help by provide cuttings from native fruit trees and bushes they have. The purchase of propagated bushes will also be undertaken, along with seeds for vegetables.

We will look to establish a group of volunteers to start developing the Alchemist Path both from the allotment membership and importantly the communities of the Three Towns. The development of the hedge and path will be from January 2026 to March 2026. The funding will provide the infrastructure for the path to become a reality.

It will be an outdoor workshop and training space, a wild place in the heart of the community. Expand the Three Towns Growers community outreach and ownership approach and ethos.

3 Towns Growers - Community Hub Build

The new building construction has been underway since July 2025, and progress has been steady, with a finish date in February 2026. Many of the 'Growers' membership has commented that this is an asset that will help the allotment become more publicly known, benefit the membership and the communities of the Three Towns. Conversations with people who pass the build sight daily, are very positive about the new community hub.

The 3TG Board are working on a let policy and booking system, as well as starting to look at potential users and what workshops and educational programmes can be facilitated from the 'Community Hub'. These will be tied into a new business plan for the allotment and the community hub.

Argyle Community Association

The Association has been working hard over the last 3 months transitioning from their old booking system to the new Hallmaster booking system.

The association have taken part in training days to learn the new system and how to navigate through all options. They have also uploaded all long-term customers (centre users) onto the system which will benefit them and the centre users when they go live in January.

This new system will come with a website that will promote all groups at the centre as well as a Calendar which takes the public to the online booking form. The association has also opted to keep hard copies of the booking form for those not online. These will have to be inputted by association members.

Argyle Digital Drop in

The group which runs on a Wednesday afternoon and continues to grow. Average participation per session is sitting at 15 people. This is an outlet for anyone, but predominantly older people who are socially isolated and unable to carry-out everyday tasks in our digital world without assistance

The NAFF larder network were represented at a market place event at the recent Housing Partnership Event and also at the Financial Inclusion Conference. Both events were held at Fullarton Connexions in Irvine. It was a great opportunity to share the work of the network with colleagues in Housing services and wider partner organisations.

Increasing Civic Pride & Community Engagement

Hayocks Community Association – have been supported in their journey to take on the hall lets from the facilities team at Hayocks Community Hall. Training is now taking place with the Hallmaster system to manage the hall and further develop activities as an association and hall.

Hayocks TARA – the group has been introduced to a new volunteer from another group from the Discovery Award Group. He has agreed to work in the community garden that the group manage. Flowers have been planted, benches sanded, and painting is beginning. The group are working on a plan with the volunteer to transform the space and are also working in partnership with the Three Towns Growers to achieve this.



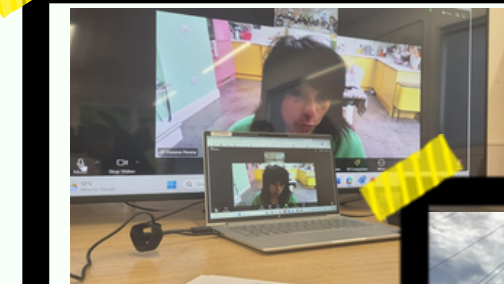

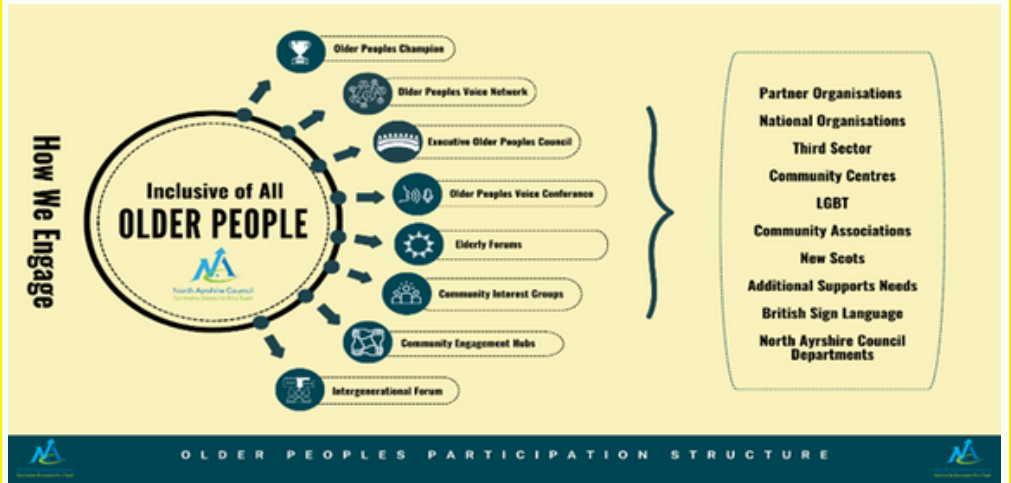

In the period of September to November we have provided advice to a number of new and established businesses and continue to work with those who are implementing next steps and developing projects.

We have supported 6 new businesses to start-up and supported businesses in a variety of sectors with 1 grant and 2 instances of specialist consultancy support, as well as offering a number of free Business Gateway workshops and webinars covering a range of business topics. In addition, we've supported 8 businesses in the 3 Towns to develop Fair Work practices and 8 businesses with energy/sustainability related support.

Improving Community Wellbeing

Improving Community Wellbeing

Gamers group – Youth group for ASN young people aged 12-15. Young people enjoy meeting at a space where they can play games like uno, PlayStation, Xbox and Dungeons and Dragons. The group has around 14 members who regularly turn up every week. They have developed friendships and have started exploring how to use the 3d printer and Cricut machine.

Ardeer Parent group- The group have been supported weekly up until now and the parents have developed in confidence and leadership skills. They are now at a place where they have decided to run the group themselves.

Hayocks Community Association – facilitation and meetings have taken place with the child poverty team about the fairer futures test for change programme which has led to potential investment of new staff and will aim to engage with community members that need support, who are not currently engaging with the Community Association and local services.

Hayocks Youth Café – the group continues to run in partnership with CLD, Hayocks Community Association, Hayocks TARA and KA Leisure. The participation numbers continue to be very strong with 35-40 young people taking part weekly in gaming, football, board games, dancing and a free meal from the community café volunteers. In October, the group the Youth Café Hosted a Spooky Halloween movie night with free pizza, hot dogs and sweets.

Halloween Events
Successful halloween events were held across the Three Towns at all our locality run youth groups, including our Community Centres and the annual 3 Towns Growers Halloween spooktacular event which seen over 250 people attending.

Campus Officer Updates (Auchenharvie, St Matthews, Ardrossan)–

Safer communities

St Matthews Academy

Following discussions with HT at St John's Primary School around issues relating to bullying and antisocial behaviour, inputs were delivered to P6 & P7 pupils around being a responsible citizen, internet safety and anti-social behaviour.

Following antisocial behaviour within the community and inappropriate use of social media by pupils at St Mark's Primary School, inputs delivered around anti-social behaviour and internet safety.

Ardrossan Academy

On the request of feeder schools, Stanley and Dykesmains, resulting from their concerns of internet safety and bullying, internet safety and cyberbullying inputs have been delivered, to all P6 and P7s at Stanley and P7s at Dykesmains. The same inputs have also been delivered to all S1 pupils in PSE classes at the academy on the request of their pastoral teachers. Cyberbullying appears to be one of the biggest issues at the academy just now.

Fire Service and Police inputs delivered to all S1-S3 Ardrossan Academy Pupils at assemblies

Auchenharvie Academy

Liaised with Fire Service, and supported the Fire Service to give inputs to the pupils of Auchenharvie Academy regarding Fire Safety in relation to Operation Moonbeam.

Inputs delivered to S1 to S3 regarding Fire Safety, and showing respect to emergency services during Operation Moonbeam.

Inputs delivered to various classes regarding Road Safety, and how to cross the Road safely in conjunction with pastoral care staff. Attend Saltcoats Road Stevenston outside Auchenharvie Academy every day, in order to supervise pupils crossing the road safely, and to encourage drivers to adhere to the speed limit during thus encouraging Road Safety.

Talks at local Primary Schools regarding Internet Safety and Bullying.

Community wellbeing

St Matthews Academy

'You, Me, Together' – Domestic Abuse controlling and coercive behaviour inputs delivered to S5 pupils within school as part of 16 Days of Action campaign.

Plans in place for a walk from the school to Woman's Aid with pupils in support of 16 Days of Action campaign. This involves visiting North Ayrshire Woman's Aid where pupils will receive input from staff and ongoing initiative for donation of clothing and toiletries for pupils to provide to Woman's Aid for their service users.

NKBL – inputs continued to be delivered around knife crime and to be rolled out to new S1 pupils next

Police Scotland Work Experience Programme – pupils from ass secondary schools took part in this year's work experience programme where they gained an understanding of the different roles and departments within Police Scotland, visiting Tulliallan and seeing what the day in the life of a police probationer is like, inputs from CID, Mountain Rescue, Mounted Unit, visiting the Control Room, Kilmaronock Sheriff Court. Feedback from the pupils was extremely positive and has reaffirmed their desire to join Police Scotland in the future.

Breakfast Club – volunteered to assist with running the breakfast club within each school on a Wednesday morning, ensuring pupils have access to breakfast prior to the start of the school day which will again assist in building positive relationships with young persons.

S2 Boys Football Team –managing/coaching S2 boys football team and organising their league and cup matches, allowing the campus officer to develop strong positive relationships with a number of young people within the group.

Ardrossan Academy

ACES (Ayrshire Communities Education and Sport), street striker challenge, (designed

to raise awareness and help tackle knife crime among young people) delivered to all S1 & S2 pupils in November at Ardrossan Academy. This was a big success and enjoyed immensely by all pupils who attended.

S2 1-S3 boys Football Team – the campus officer has been managing boys football teams since the beginning of term. This has enabled the officer to build good relationships and rapport with, promoting a different side to the Police. The pupils are now more likely to engage with the campus officer on a daily basis

Auchenharvie Academy

Currently carrying out the "Pitching in Programme" with a group of twelve S2 pupils. During this Programme talks are delivered to pupils regarding knife crime, drugs and various other social issues. A trip to Ibrox stadium has been arranged in December for the pupils which is used to build bridges between the police and the pupils. Plans are also in place to do this programme with S3 and S1 pupils after Christmas.

Preventions and Interventions Officer

Joint work alongside NAC Trading Standards has been carried out in order to support the local community, 4 events have been attended in relation to provide advice and guidance on how to prevent being victim of "scams" as well as inputs on the dangers of vapes to community groups. There has also been work carried out in order ensure premises are adhering to legislation on vape sales with approx. 20 licensed premises visited.
